Executive Summary

This report provides 30-year Uniform Crime Reporting data for Alaska and Anchorage. The report also provides 12-year arrest data for Anchorage; law enforcement data for Alaska and Anchorage; and court filing data for Alaska and Anchorage.

Selected Findings of this Report

Violent Crime

- **Violent crime rates in Alaska**

- There was an increasing trend for overall violent crime rates in Alaska from 1986-2015.
- During the 30-year period (1986-2015), the highest rate of violent crime in Alaska occurred in 1995 (753.2 crimes per 100,000 people), and the lowest violent crime rate occurred in 1987 (430.3 crimes per 100,000 people). The top three highest violent crime rates occurred in the mid-1990s. In 2015, the 4th highest violent crime rate occurred in Alaska at 692.3 violent crimes per 100,000 people.
- There was a decreasing trend for homicide rates in Alaska between 1986 and 2015. The highest homicide rate occurred in 1987 (9.4 homicides per 100,000 people) and the lowest homicide rate was in 2009 (3.0 homicides per 100,000 people). The homicide rate increased from 4.1 to 8.0 homicides per 100,000 between 2013 and 2015.
- On average, aggravated assault accounted for 71.7% of the violent crime rate in Alaska between 1986 and 2015.

- **Violent crime rates in Anchorage**

- There was an increasing trend for overall violent crime rates in Anchorage between 1986 and 2015. The highest rate of violent crime in Anchorage occurred in 2015 (1,029.0 violent crimes per 100,000 people). The lowest rate of violent crimes was in 1987 (453.5 per 100,000). There was a spike in violent crime in the mid-1990's, where violent crime rates rose as high as 993.2 violent crimes per 100,000 people.
- There was a decreasing trend in homicide crime rates in Anchorage during this time, with the highest rate of homicides occurring in 1995 (11.5 homicides per 100,000 people). The lowest homicide rate was in 2008 (3.5 per 100,000). There was a recent spike in the homicide rate between 2014 and 2015; the homicide rate rose from 4.0 to 8.7 homicides per 100,000.
- There was an increasing trend in aggravated assault between 1986 and 2015. The highest rate of aggravated assault occurred in 2015 (690.3 per 100,000) and the lowest rate of aggravated assault occurred in 1987 (252.7 per 100,000).
- On average, aggravated assault accounted for 64.6% of the violent crime rate in Anchorage between 1986 and 2015.

Property Crime

- **Property crime rates in Alaska**

- There was a decreasing trend for property crime (burglary, larceny-theft, motor and vehicle theft) rates in Alaska between 1986 and 2015. The highest rates of property crime occurred in the mid-1980's to 1990's, with the highest instance of property crime in 1986 (5,326.3 per 100,000). The lowest rate of property crime occurred in 2011 (2,623.0 per 100,000).
- On average, property crime accounted for 86.1% of the overall Part I crime rate in Alaska between 1986 and 2015.
- On average, larceny-theft accounted for 72.6% of the property crime rate in Alaska between 1986 and 2015.

- **Property crime rates in Anchorage**

- There was a decreasing trend for property crime (burglary, larceny-theft, and motor vehicle theft) rates for Anchorage between 1986 and 2015. The highest rate of property crime was in 1986 (6,567.3 per 100,000 people). The lowest rate of property crime occurred in 2011 (3,195.1 per 100,000). There was a 24% increase in the property crime rate between 2011 and 2015; the rate rose from 3,195.1 per 100,000 to 3,950.6 per 100,000.
- On average, property crime accounted for 86.1% of the overall Part I crime rate in Anchorage between 1986 and 2015.
- On average, larceny-theft accounted for 74.9% of the property crime rate in Anchorage between 1986 and 2015.

Arrests for Anchorage

- **Overall adult arrest rates for Anchorage**

- There was a decreasing trend in the overall adult arrest rate for Anchorage between 2004 and 2015.

- **Part I (Violent and Property offenses) adult arrest rates for Anchorage**

- There was a slight upward trend over the 12-year period for Part I arrest rates.
- There was an increasing trend in the adult arrest rate for violent offenses between 2004 and 2015 in Anchorage.
- There was a slight upward trend in the adult homicide arrest rate for Anchorage between 2004 and 2015. There was a slight increase in the homicide arrest rate between 2014 and 2015; the homicide arrest rate rose from 4.4 to 8.5 arrests per 100,000.
- There was an increasing trend in the adult arrest rate for rape, robbery, and aggravated assault between 2004 and 2015 in Anchorage.
- There was a decreasing trend in the arrest rate for motor vehicle theft between 2004 and 2015. There was a slight increase in the arrest rate between 2014 and 2015; the rate rose from 44.5 to 67.7 arrests per 100,000.

- **Part II offenses adult arrest rates for Anchorage**

- There was a declining trend in the adult arrest rate for Part II offenses for Anchorage between 2004 and 2015; the lowest arrest rate for Part II offenses occurred in 2015 (4,837.6 per 100,000).

- **DUI arrest rates for Anchorage**
 - There was a declining trend the adult arrest rate for DUI offenses in Anchorage between 2004 and 2015. The highest rate of DUI arrests occurred in 2008 (1,088.1 arrests per 100,000) and the lowest rate of DUI arrests occurred in 2015 (461.7 arrests per 100,000).
- **Drug arrests for Anchorage**
 - The highest drug arrest rates for adults in Anchorage occurred in 2010 and the lowest rates occurred in 2015.
 - Drug sale/manufacturing arrests in Anchorage peaked at 238 arrests in 2010 and fell to 60 arrests in 2015.
 - Drug possession arrests in Anchorage peaked at 530 arrests in 2010.
 - The highest volume of arrests for drug sale/manufacturing in 2015 was for narcotics (31 arrests). The highest volume of arrests for drug possession in 2015 was for other/non-narcotics (141 arrests).
 - Marijuana sale/manufacturing arrests peaked at 57 arrests in 2010 and fell to 7 arrests in 2015. Marijuana possession arrests peaked in 2010 at 353 arrests and fell to 42 arrests in 2015.

Police Officers

- **Number of police officers in Alaska**
 - The number of police officers between 2004 and 2015 peaked at 1,331 officers in 2013 (1.76 officers per 1,000 persons) and decreased to 1,269 officers (1.72 officers per 1,000 persons) in 2015.
- **Number of police officers in Anchorage**
 - The number of police officers between 2004 and 2015 peaked at 390 officers in 2011 (1.32 officers per 1,000 persons) and decreased to 362 officers (1.21 officers per 1,000 persons) in 2015.

Court Filings

- **Court filings in Alaska**
 - There was an increasing trend for overall felony filing rates in Alaska between FY04 and FY15. The percentage change in overall felony filing rates in Alaska between FY04 and FY15 was 13.5%.
 - There was an increasing trend for property felony filing rates in Alaska between FY04 and FY15.
 - There was a decreasing trend for person felony filing rates, drug felony filing rates, and motor vehicle felony filing rates in Alaska between FY04 and FY15.
 - There was a decreasing trend for overall misdemeanor filing rates in Alaska between FY04 and FY15; the percentage change in filing rates between FY04 and FY15 was -30.6%.
- **Court filings in Anchorage**
 - There was an increasing trend for overall felony filing rates in Anchorage between FY04 and FY15; the percentage change in filings rates between FY04 and FY15 was 35.6%.

- There was an increasing trend for property felony filing rates and drug felony filing rates in Anchorage between FY04 and FY15.
- There was a decreasing trend for person felony filing rates and motor vehicle felony filing rates in Anchorage between FY04 and FY15.
- There was a decreasing trend for overall misdemeanor filing rates in Anchorage between FY04 and FY15; the percentage change in filing rates between FY04 and FY15 was -28.7%.

Part 1: Introduction

This report provides historical criminal justice data related to crime in Alaska, including incidents reported to law enforcement, number of arrests, number of law enforcement officers, and court filings. Number of incidents reported to law enforcement and crime rates for Anchorage and Alaska are provided for a 30-year period to determine high and low rates of crime during that time and also to show the trend in crime rates. The number of arrests, law enforcement officers and court filings are provided for a 12-year period to show a similar snapshot of variation and trends in the data, but for a shorter period of time. The 12-year period was chosen as there was an increase in felony filings during this period.

A. Uniform Crime Reporting (UCR) Program

The Committee on Uniform Crime Records was developed in 1927 by the International Association of Chiefs of Police (IACP) to meet the need for uniform nation-wide crime statistics. The Committee determined the number of offenses known to law enforcement would be the appropriate measure for crime rates. The Committee also chose seven crimes based on their seriousness, frequency, pervasiveness, and likelihood to be reported to law enforcement. The seven crimes were: felonious homicide, rape, robbery, aggravated assault, burglary – breaking or entering, larceny- theft, and auto theft. The Committee also formulated standardized offense definitions by which law enforcement agencies could collect and submit data. In 1929, a manual, *Uniform Crime Reporting*, was published to define Part I and Part II crimes and explain procedures for reporting statistics. Later that year, the first monthly Uniform Crime Report was published which contained one table with the number of offenses known to police. Law enforcement agencies from 400 cities in 43 states and the territories of Puerto Rico, Alaska, and Hawaii submitted statistics to the IACP. The Federal Bureau of Investigation (FBI) assumed responsibility for the program in 1930. In 1960, the publication included reporting from all 50 states. In 1982 arson was added as a Part I offense (Federal Bureau of Investigation, 2004).

The Alaska Criminal Justice Planning Agency began publishing the *Crime in Alaska* reports in the mid-1970s. The Alaska Department of Public Safety (DPS) began administering the UCR program in 1982 and continues to publish the yearly report. Archives of the reports (1976-1999) are available online through the Alaska Justice Statistical Analysis Center at <http://www.uaa.alaska.edu/ajsac/ucr>. Reports from 2000-present are available online through the Alaska DPS at <http://dps.alaska.gov/Statewide/UCR.aspx>. Under Alaska Statute 12.62.130, law enforcement agencies are required to submit crime data to DPS. Agencies who report to DPS constitute approximately 99% of the state population (Alaska Department of Public Safety, 2015).

Alaska DPS collects data on Part I and Part II offenses outlined by the FBI UCR program. Part I offenses consist of violent crimes and property crimes. Violent crimes include homicide (murder and non-negligent manslaughter, negligent homicide is not included), rape, robbery, and aggravated assault. Property crimes include burglary, larceny-theft, motor vehicle theft, and arson. The UCR program collects data on offenses known to law enforcement and arrests for Part I offenses. The UCR program only collects arrest data for Part II offenses. Part II offenses include other assaults (simple); forgery and counterfeiting; fraud; embezzlement; stolen property:

buying, receiving, possessing; vandalism; weapons: carrying, possessing, etc.; prostitution and commercialized vice; sex offenses (sexual abuse of a minor and incest is included); drug abuse violations; gambling; offenses against the family and children; driving under the influence; liquor laws; drunkenness; disorderly conduct; vagrancy; all other offenses; suspicion; curfew and loitering laws (persons under age 18); and runaways (persons under age 18). In 2013, the UCR program began reporting data on human trafficking offenses. No arrests were reported in the 2013-2015 *Crime in Alaska* reports for human trafficking, therefore human trafficking arrest data is not included in this report. Part 2: 30-year Reported Crime and Crime Rates

The following tables provide 30 years of the number of reported Part I crimes and crime rates for Anchorage and Alaska overall. Reported crimes includes the number of crimes reported to law enforcement regardless of whether they resulted in an arrest or not. The number of crimes reported is the actual offenses reported; this number removes unfounded reports. The number of reported crimes shows the overall volume of crimes reported. Crime rates take into account the population of the location. Crime rates were calculated using population estimates from the Alaska Department of Labor and Workforce development and therefore may be slightly different than the *Crime in Alaska* publication. Population estimates for Alaska and Anchorage Municipality were obtained from <http://live.laborstats.alaska.gov/pop/>. Crime rates were calculated per 100,000 people.

Part I crimes are based on the UCR definition of the offenses, which includes violent crime (murder and non-negligent manslaughter, rape, robbery, and aggravated assault) and property crime (burglary, larceny-theft, motor vehicle theft, and arson). The Alaska UCR program began reporting data on arson offenses in 2012, therefore arson is not included in the 30-year reported crime and crime rates. The UCR program revised the definition of rape in 2013 to allow for both female and male victims. In this report, the number of reported rapes for the years 2013 to 2015 have been adjusted to maintain a consistent definition (legacy definition) of rape across the 30-year period (See https://ucr.fbi.gov/crime-in-the-u.s/2013/crime-in-the-u.s.-2013/rape-addendum/rape_addendum_final for more information). The formula used is (revised rape number/1.417 = legacy rape estimate). This adjustment also impacts the number of violent crimes and Part I crimes.

A. Alaska Part I Crime

1. Number of Reported Part I Crimes for Alaska

Table 1 and Figure 1 show the number of Part I crimes reported to law enforcement between 1986 and 2015 for Alaska overall. Table 1 shows the highest volume of Part I offenses was in 1994 at 32,971 reported offenses and the lowest incidence occurred in 2011 with 23,353 reported offenses. Figure 1 also shows a large proportion (80% in 2015) of the Part I crimes are due to property crimes.

- The number of reported violent crimes was highest in 2015 (5,104) and lowest in 1987 (2,329).
 - The number of reported murders was highest in 2015 (59) and lowest in 2009 (21).
 - The number of reported rapes was highest in 2013 (649 *adjusted legacy definition estimate*) and lowest in 1989 (277).
 - The number of reported robberies was highest in 1995 (918) and lowest in 1989 (352).
 - The highest number of reported aggravated assaults occurred in 2015 at 3,654 and the lowest number occurred in 1987 (1,569).
- The number of reported property crimes was highest in 1991 (28,704) and lowest in 2011 (18,961).
 - The highest number of reported burglaries was in 1986 (6,075) and the lowest was in 2011 (2,841).
 - Reported larceny-thefts were highest in 1994 (20,676) and lowest in 2011 (14,742).
 - The highest incidence of motor vehicle theft was in 1994 at 3,166 and the lowest was in 2011 (1,378).

2. Part I Crime Rates for Alaska

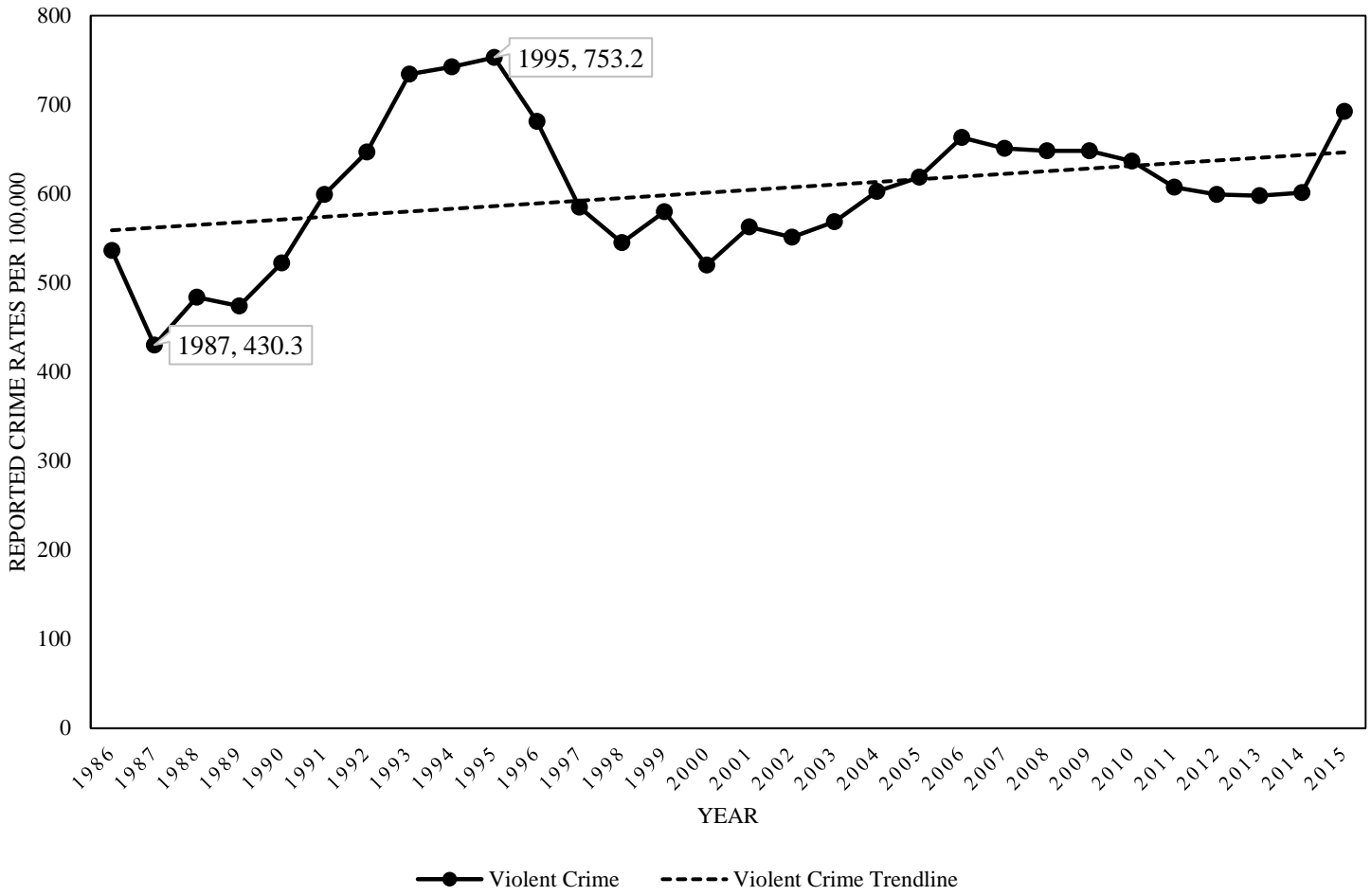
Figure 2: Part I Crime Rates, Alaska, 1986-2015

Table 2 shows the crime rates for Part I crimes reported to law enforcement between 1986 and 2015 for Alaska overall. Figure 2 shows the highest rate of Part I crime occurred in 1986 (5,862.7 per 100,000) and the lowest rate occurred in 2011 (3,230.5 per 100,000). Over a thirty-year period, there was a decreasing trend in overall Part I crime rates. On average, property crime accounted for 86.1% of the overall Part I crime rate in Alaska between 1986 and 2015.

a. Violent Crime Rates for Alaska

Figure 3 shows an increasing trend in violent crime in Alaska over a 30-year period. In 2015, the 4th highest violent crime rate occurred at 692.3 violent crimes per 100,000 people. Higher rates of violent crime occurred in the mid-1990's, with the highest rates of violent crime occurring from 1993 to 1995. The highest violent crime rate occurred in 1995 (753.2 crimes per 100,000) and the lowest occurred in 1987 (430.3 per 100,000).

- Figure 4 shows a decreasing trend for homicide in Alaska between 1986 and 2015. The highest homicide rate occurred in 1987 (9.4 per 100,000) and the lowest occurred in 2009 (3.0 per 100,000). There has been an increase in the homicide rate over the last four years; the rate increased from 4.1 to 8.0 homicides per 100,000.
- Figure 5 shows a slight upward trend for rape crime rates between 1986 and 2015. The highest rape crime rate was in 1992 (96.5 per 100,000) and the lowest was in 1989 (51.4 per 100,000).
- Figure 6 shows a slight downward trend of robbery crime rates in Alaska over the 30-year period. The highest robbery crime rate occurred in 1995 (152.6 per 100,000) and the lowest occurred in 1989 (65.3 per 100,000).

- Figure 7 shows an increasing trend of aggravated assault crimes rates in Alaska between 1986 and 2015. The highest rate of aggravated assault occurred in 1994 (524.8 per 100,000) and the lowest was in 1987 (289.9 per 100,000).
- As shown in Figure 8, the violent crime rate was most influenced by aggravated assault. On average, the aggravated assault accounted for 71.7% of the violent crime rate in Alaska between 1986 and 2015.

b. Property Crime Rates for Alaska

Figure 9 shows a decreasing trend of property crime rates in Alaska between 1986 and 2015. The highest rates of property crime occurred in the mid-1980's to 1990's, with the highest instance of property crime in 1986 (5,326.3 per 100,000) and the lowest rate of property crime in 2011 (2,623.0 per 100,000).

- Burglary, larceny-theft, and motor vehicle theft crime rates all have decreasing trends in Alaska between 1986 and 2015 (Figures 10-12). The highest rate of burglary occurred in 1986 (1,103.1 per 100,000) and the lowest rate occurred in 2013 (393.0 per 100,000). The highest rate of larceny-thefts was also in 1986 (3,672.6 per 100,000) and the lowest rate was in 2011 (2,039.3). The highest rate of motor vehicle theft occurred in 1986 (550.6 per 100,000) and the lowest rate was in 2011 (190.6 per 100,000).
- On average, larceny-theft accounted for 72.6% of the property crime rate in Alaska between 1986 and 2015.

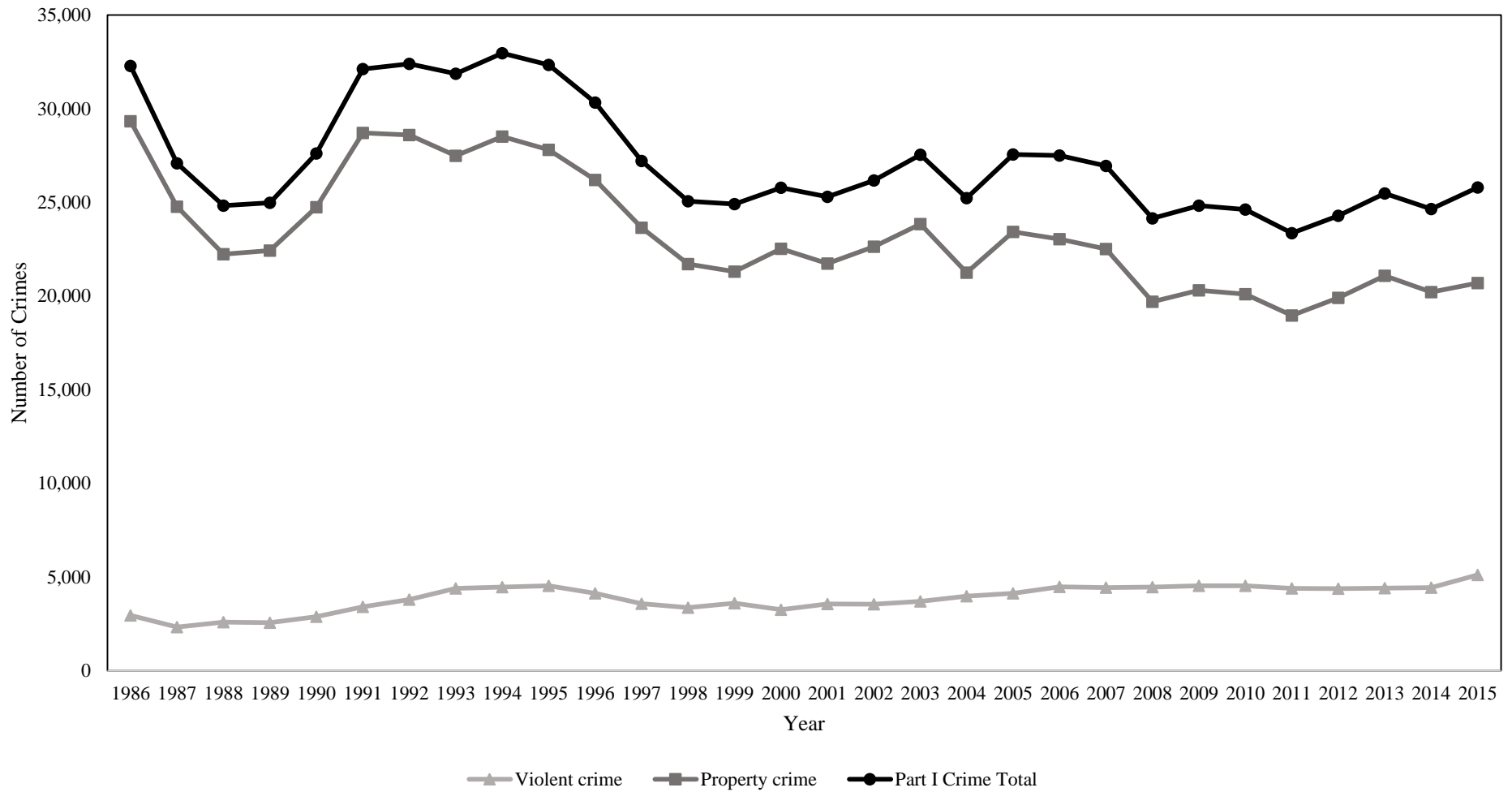

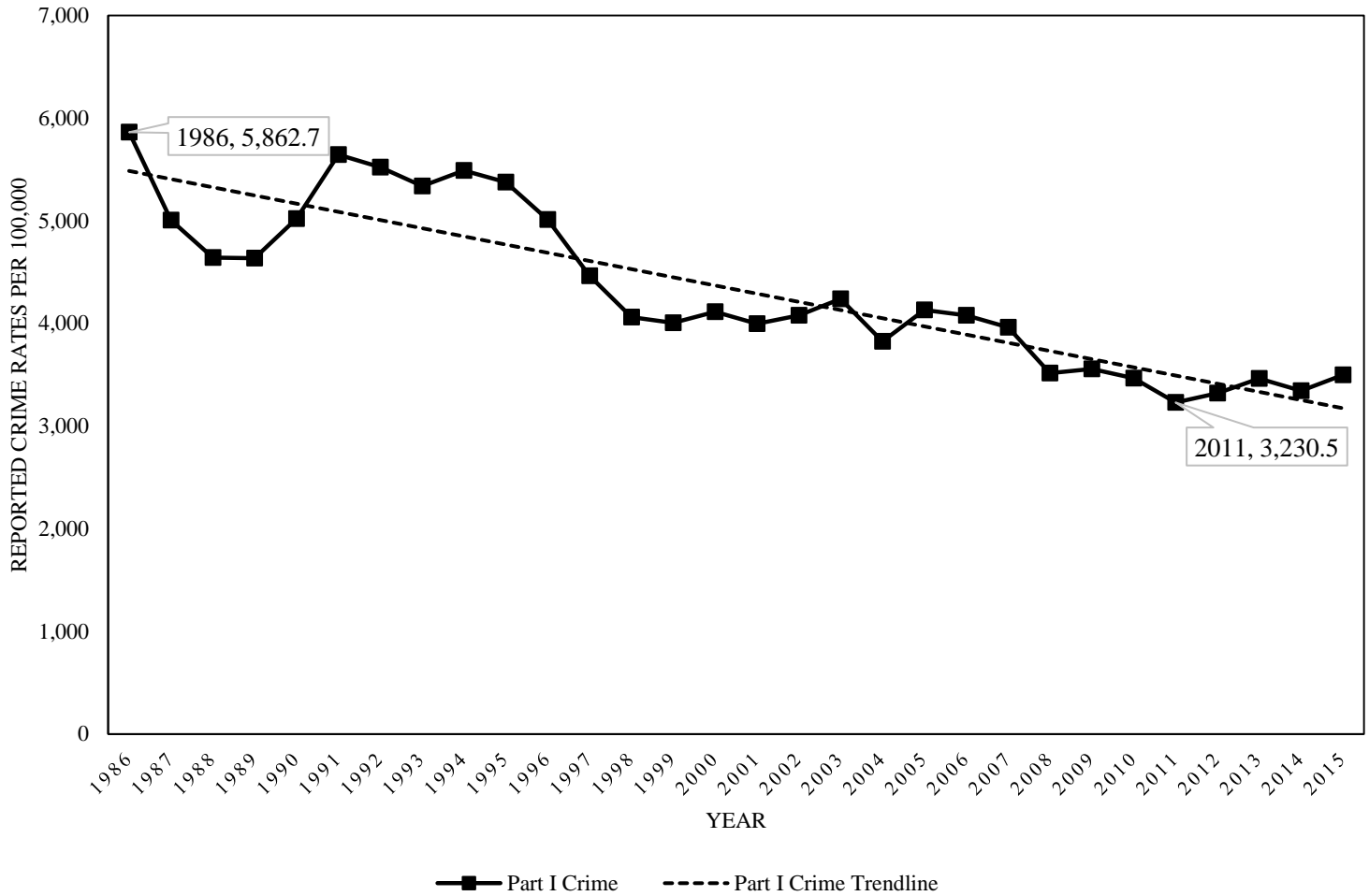

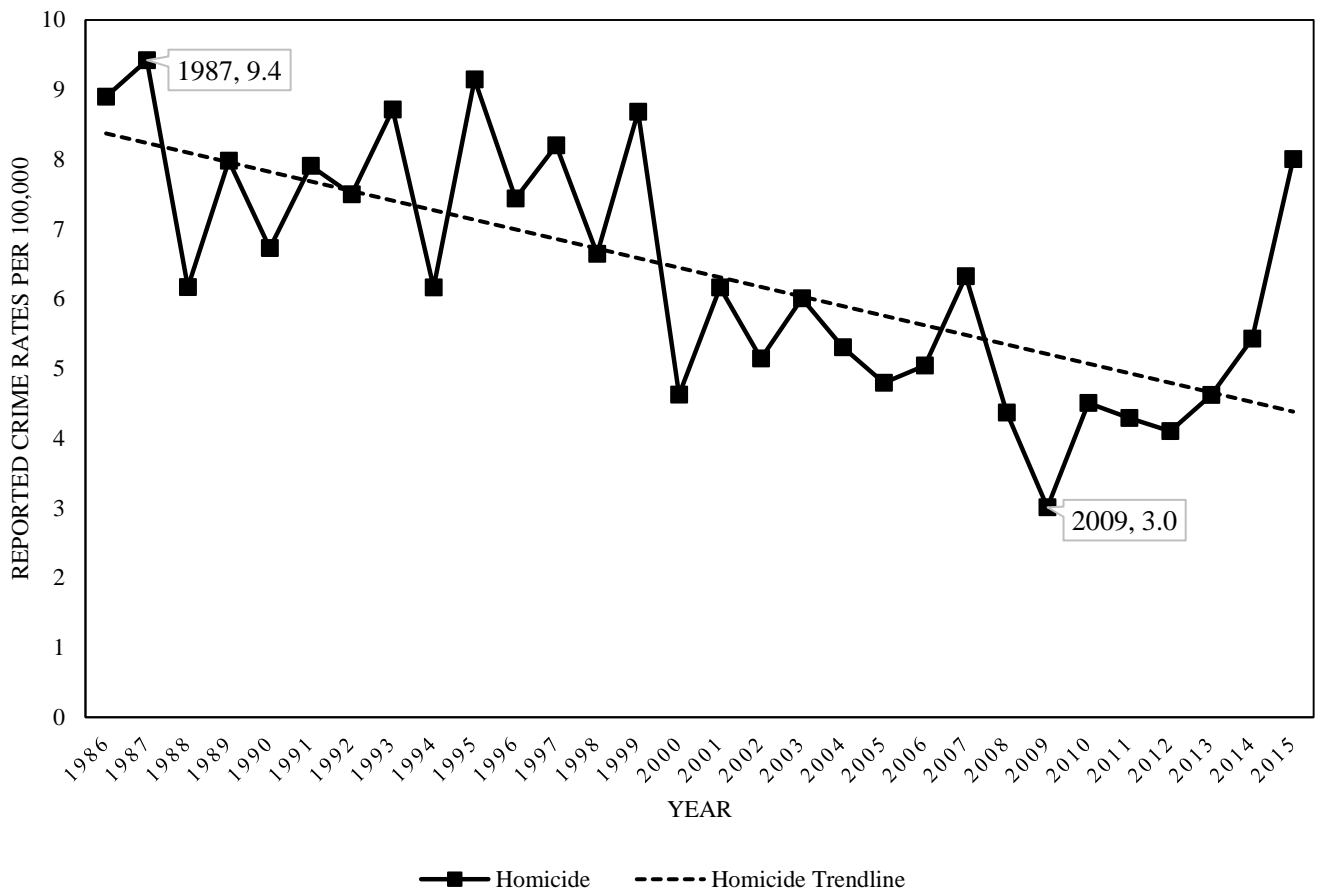

(Homicide, Rape, Robbery, & Aggravated Assault)



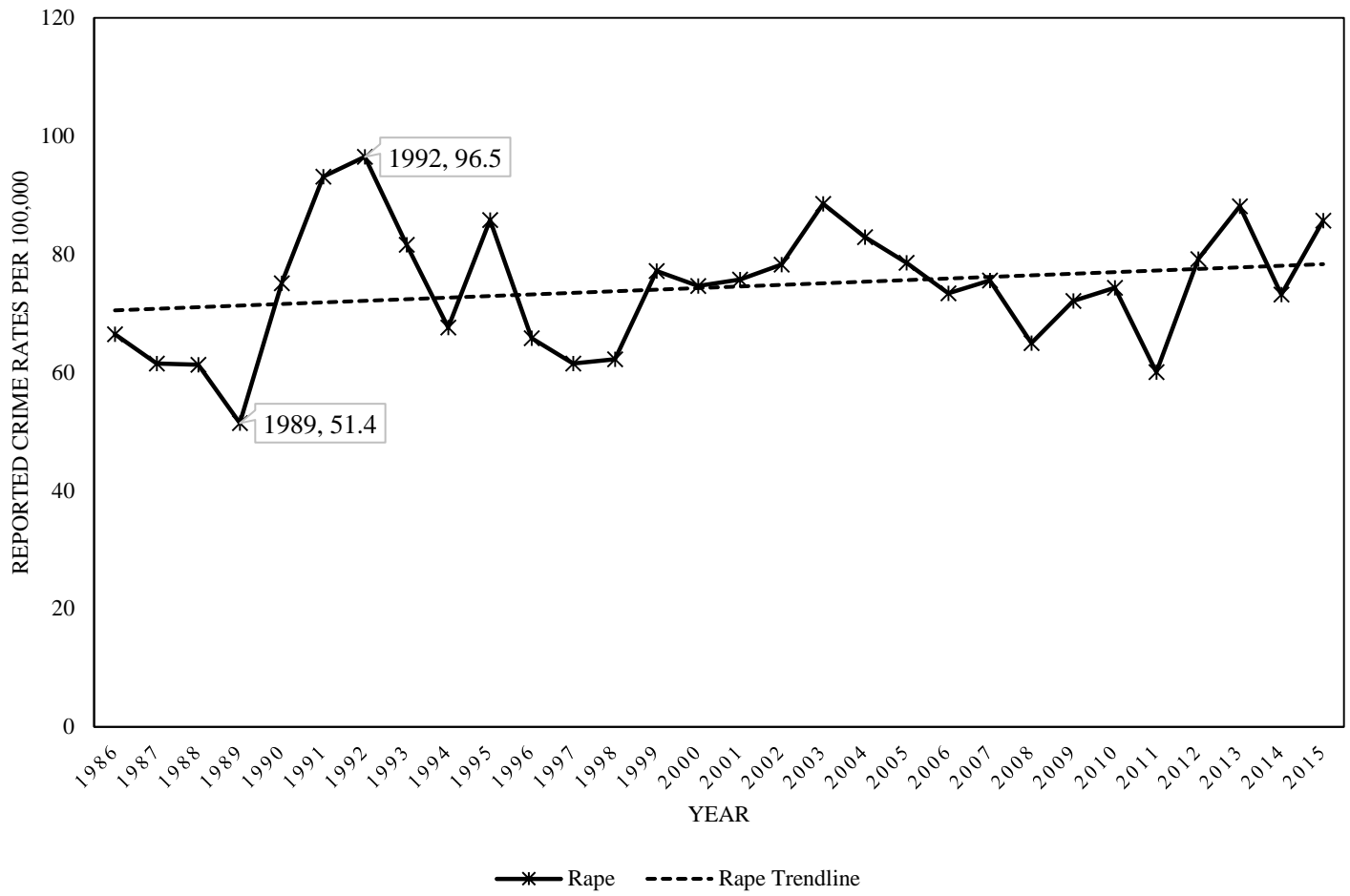

(Murder and Non-negligent Manslaughter)



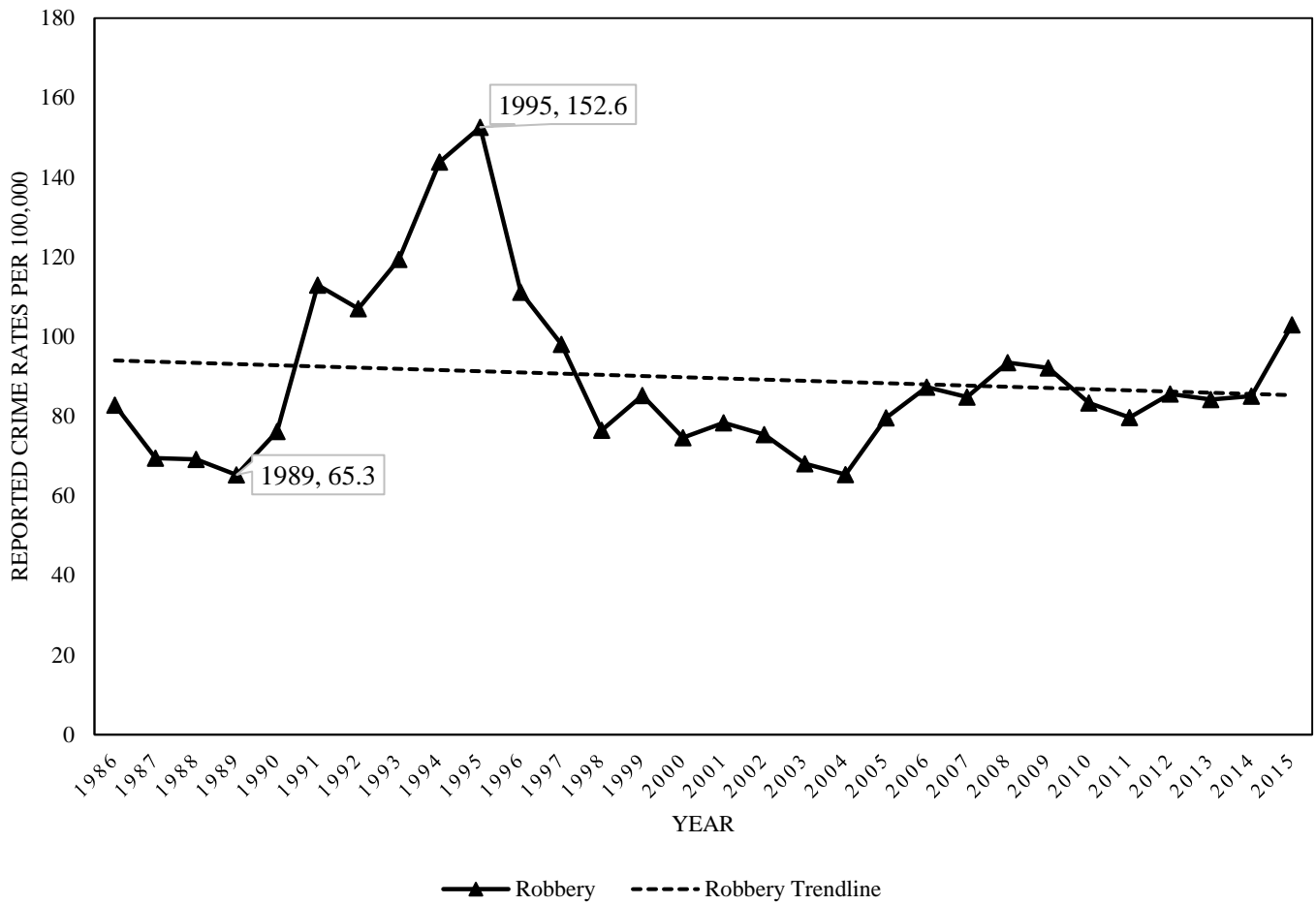

Figure 5: Rape Crime Rates, Alaska, 1986-2015



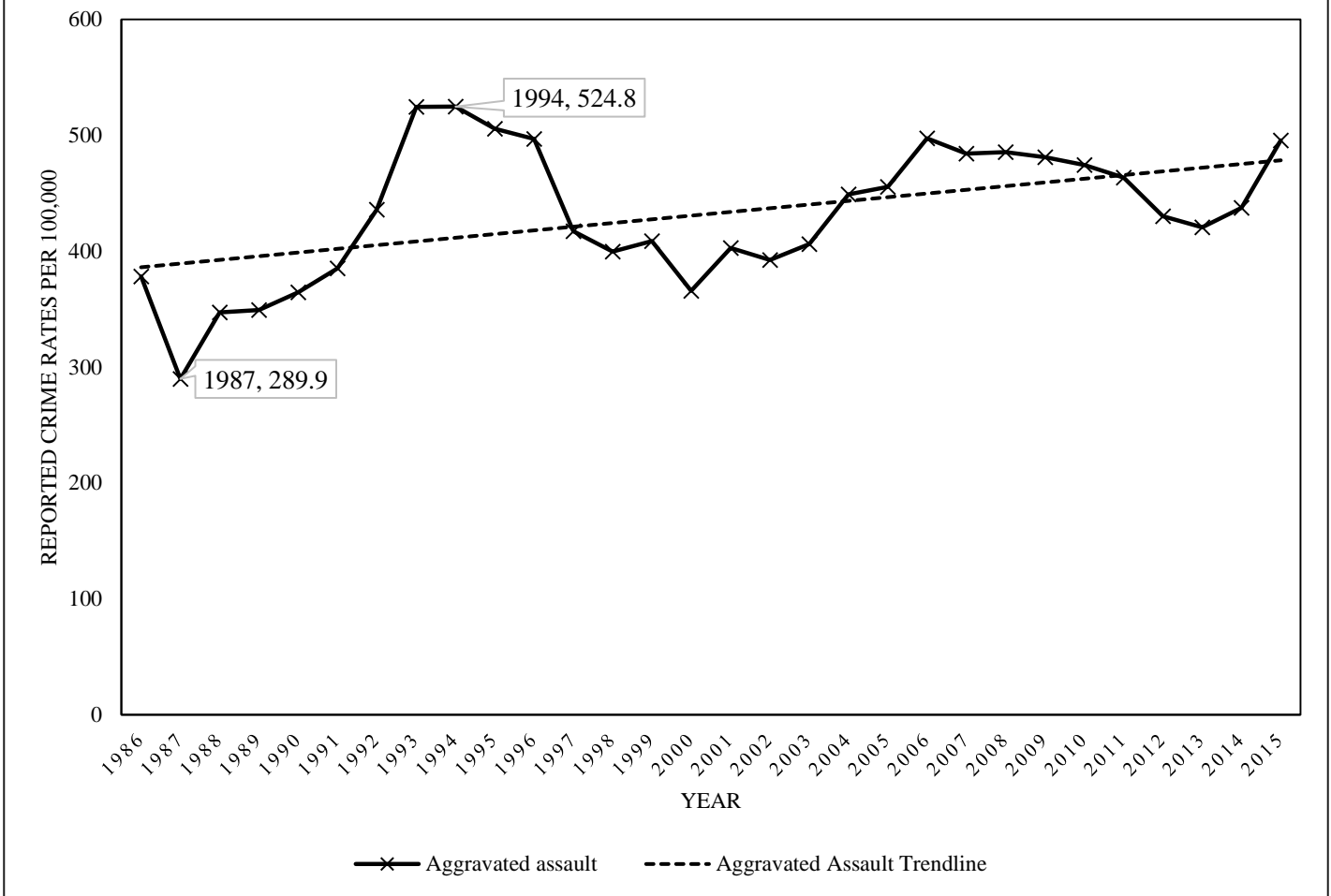

Figure 6: Robbery Crime Rates, Alaska, 1986-2015



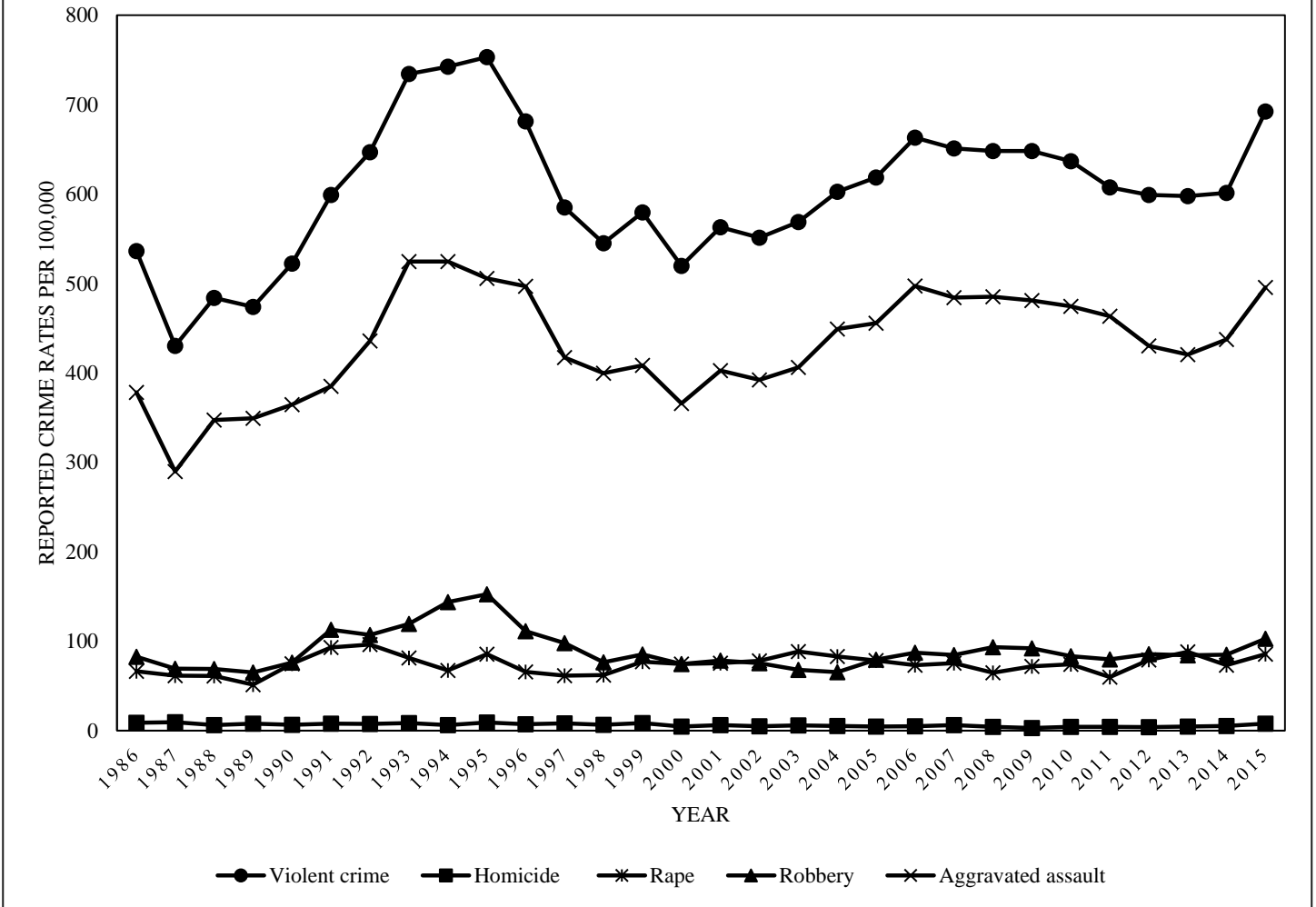

Figure 7: Aggravated Assault Crime Rates, Alaska, 1986-2015



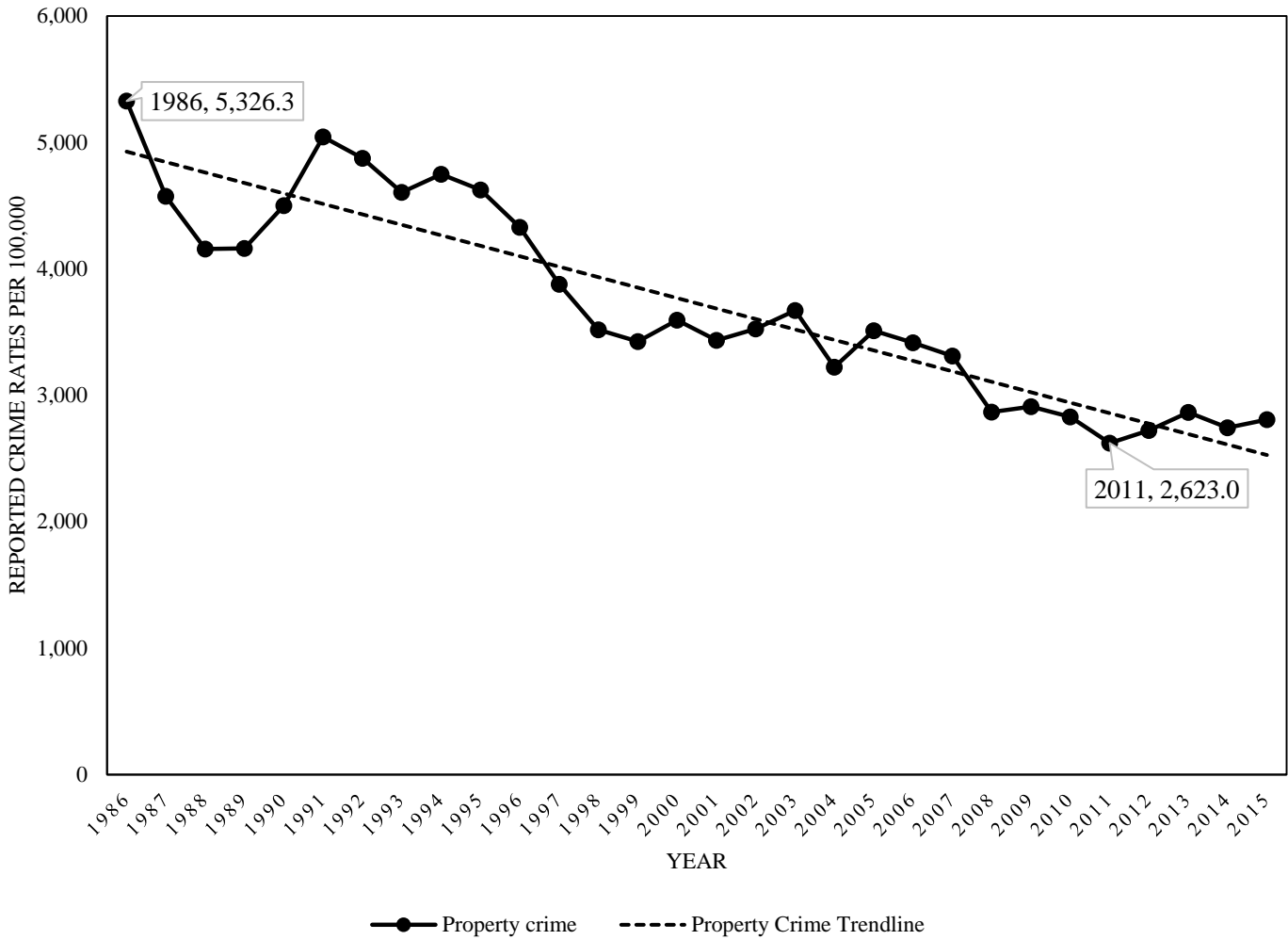

Figure 8: Violent Crime Rates, Alaska, 1986-2015



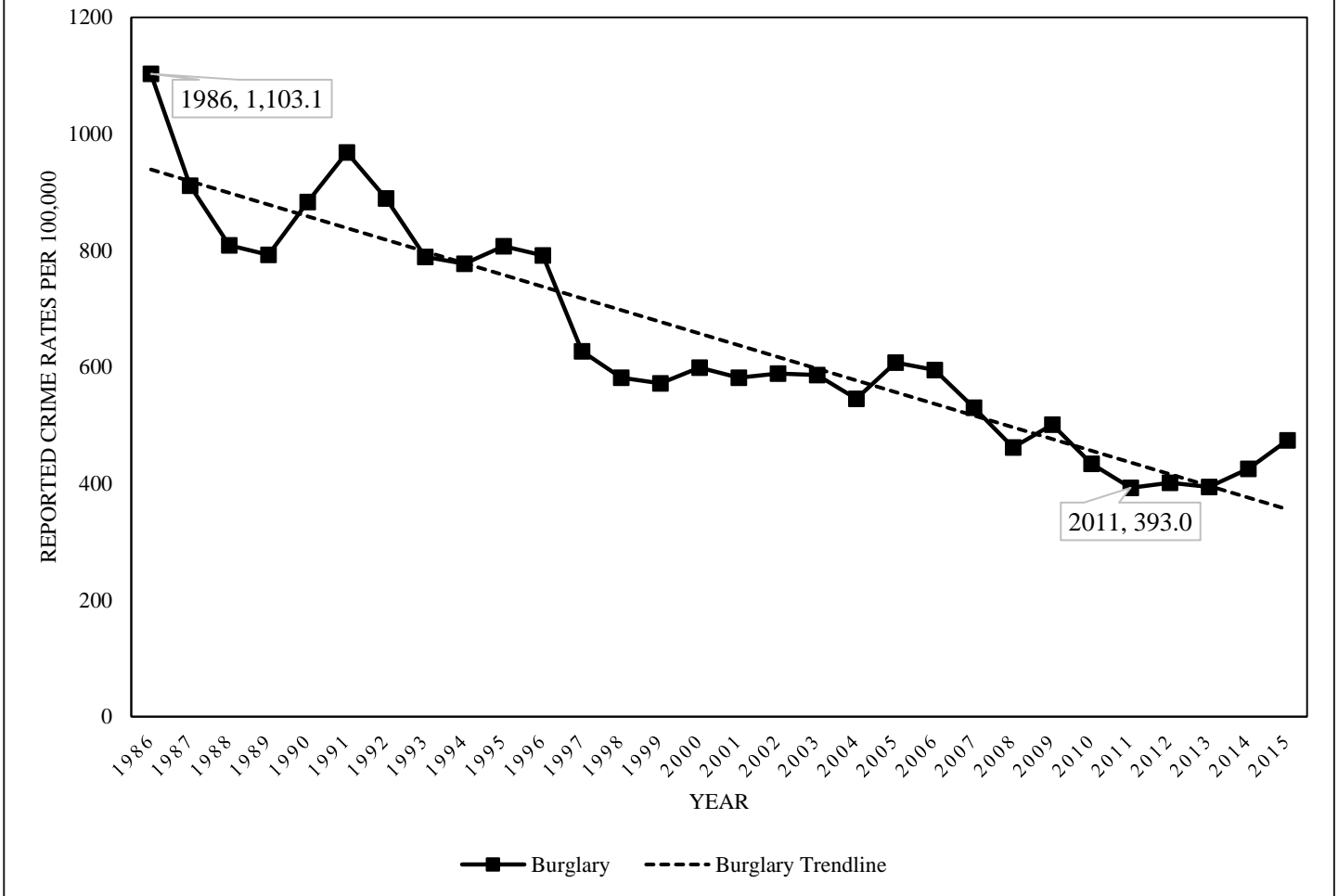

(Burglary, Larceny-Theft, & Motor Vehicle Theft)



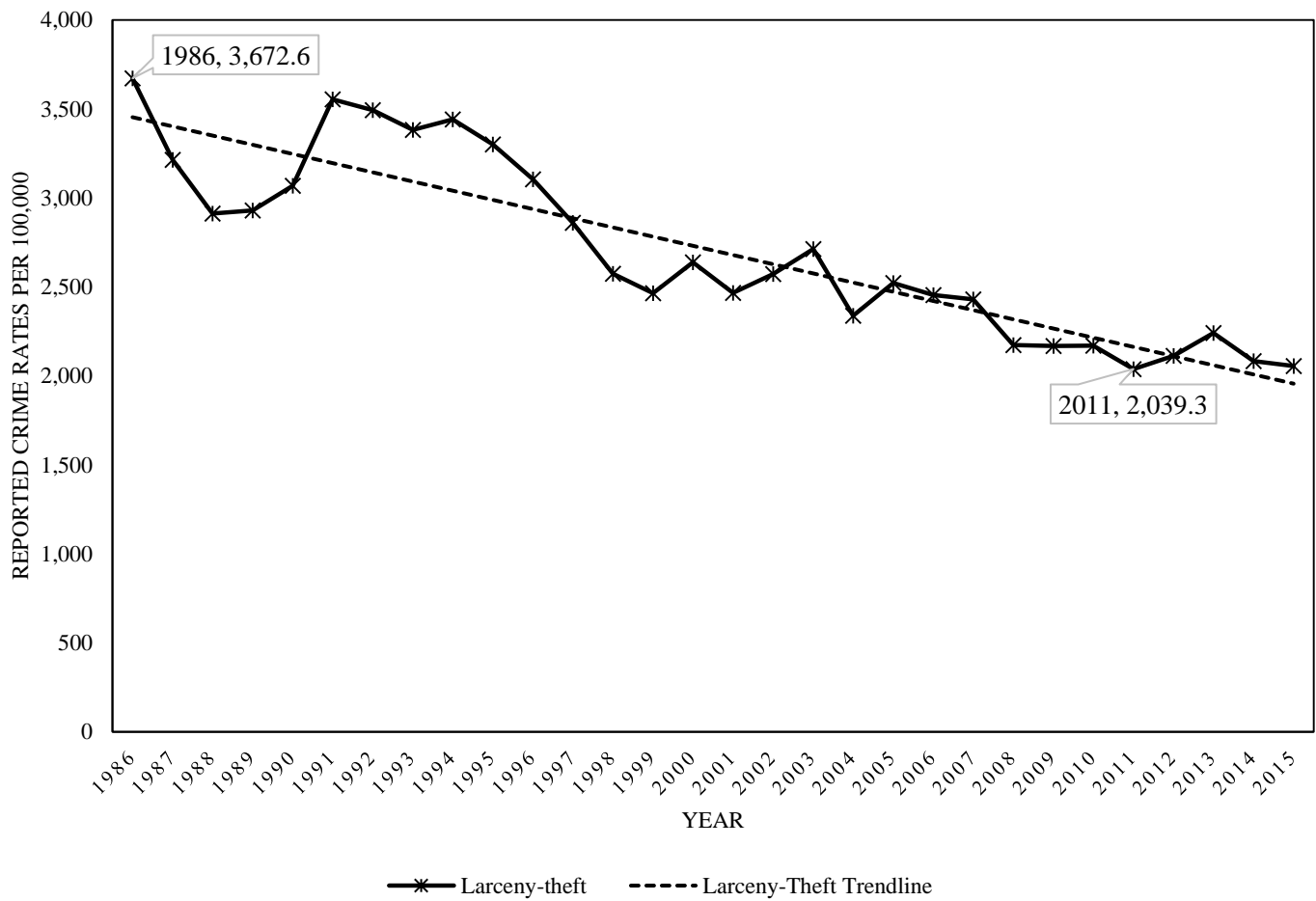

Figure 10: Burglary Crime Rates, Alaska, 1986-2015



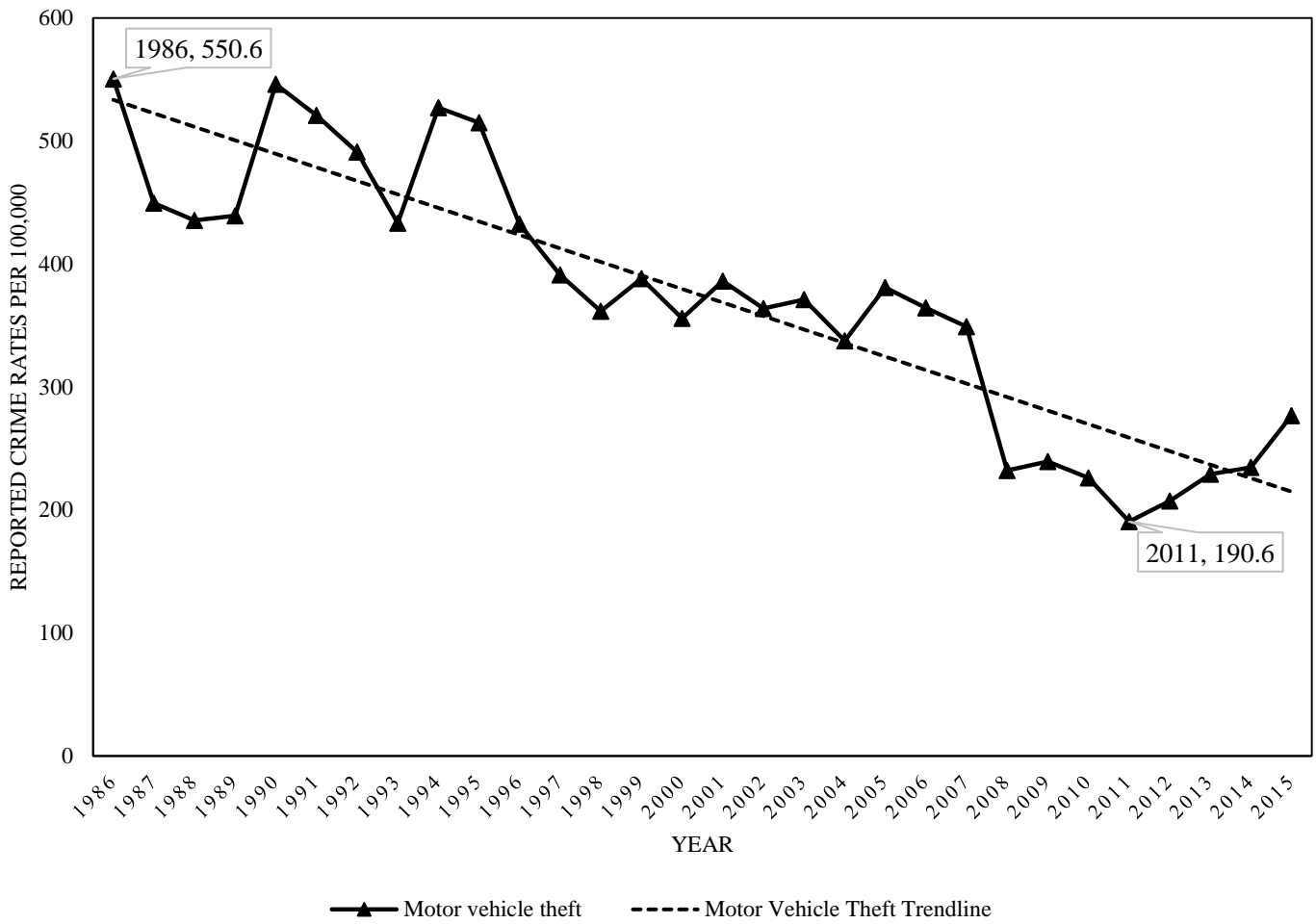

B. Anchorage Part I Crime

1. Number of Reported Part I Crimes for Anchorage

Table 3 and Figure 13 show the number of Part I crimes reported to law enforcement between 1986 and 2015 for Anchorage. The number of crimes reported for Anchorage include only crimes reported to the Anchorage Police Department. Table 3 shows the highest number of reported Part I offenses occurred in 1994 at 18,662 reported offenses and the lowest number occurred in 2004 at 11,736 reported offenses. Figure 13 also shows a large proportion (79.3% in 2015) of the Part I crimes are due to property crimes.

- The volume of reported violent crimes was highest in 2015 (3,074) and lowest in 1987 (1,025).
 - The number of reported murders was highest in 1995 (29) and lowest in 1990, 2001, and 2008 (each year had ten reported murders).
 - The number of reported rapes was highest in 2015 (365 *adjusted legacy definition estimate*) and lowest in 1989 (139).
 - The number of reported robberies was highest in 1995 (777) and the lowest in 1989 (272).
 - The highest number of aggravated assaults occurred in 2015 (2,062) and the lowest occurred in 1987 (571).
- The number of reported property crimes was highest in 1994 (16,184) and lowest in 2008 (9,211).
 - The highest number of reported burglaries was in 1986 (2,824) and the lowest was in 2011 (1,080).
 - Reported larceny-thefts were highest in 1994 (11,717) and lowest in 2004 (7,133).
 - The highest incidence of motor vehicle theft was in 1994 (2,191) and the lowest was in 2011 (625).

2. Part I Crime Rates for Anchorage

Table 4 shows the crime rates for Part I crimes reported to law enforcement between 1986 and 2015 for Anchorage. Figure 14 shows the highest level of Part I crime occurred in 1994 (7,361.6 per 100,000) and the lowest level occurred in 2011 (4,002.1 per 100,000). Over the thirty-year period, there was a decreasing trend in Part I crimes. On average, property crime accounted for 86.1% of the overall Part I crime rate in Anchorage between 1986 and 2015.

a. Violent Crime Rates for Anchorage

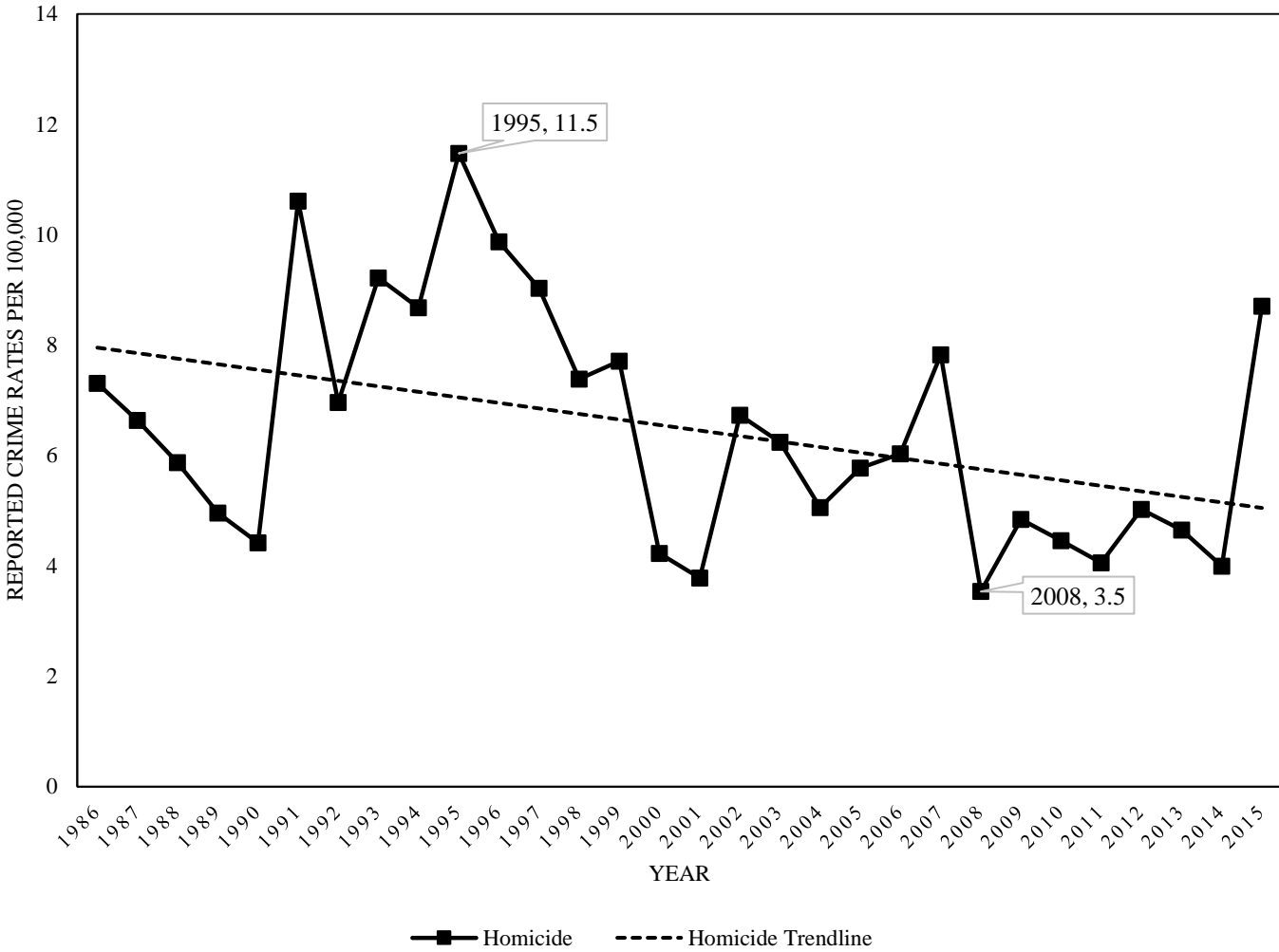
Figure 15: Violent Crime Rates, Anchorage, 1986-2015

Figure 15 shows an increasing trend in violent crime rates in Anchorage between 1986 and 2015. The highest rate of violent crime occurred in 2015 (1,029.0 violent crimes per 100,000 people) and the lowest rate occurred in 1987 (453.5 per 100,000). There was a spike in violent crime in the mid-1990's, where violent crime rates rose as high as 993.2 violent crimes per 100,000 people.

- Figure 16 shows a decreasing trend in homicides for Anchorage, with the highest rate of homicides occurring in 1995 (11.5 homicides per 100,000 people). The lowest rate of homicides occurred in 2008 (3.5 per 100,000). There was a recent spike in the homicide rate between 2014 and 2015; the rate increased from 4.0 to 8.7 homicides per 100,000 people.
- Figure 17 shows an increasing trend for rape crime rates between 1986 and 2015. The highest rate of rape was in 2015 (122.1 per 100,000) and the lowest rate was in 1999 (62.1 per 100,000).

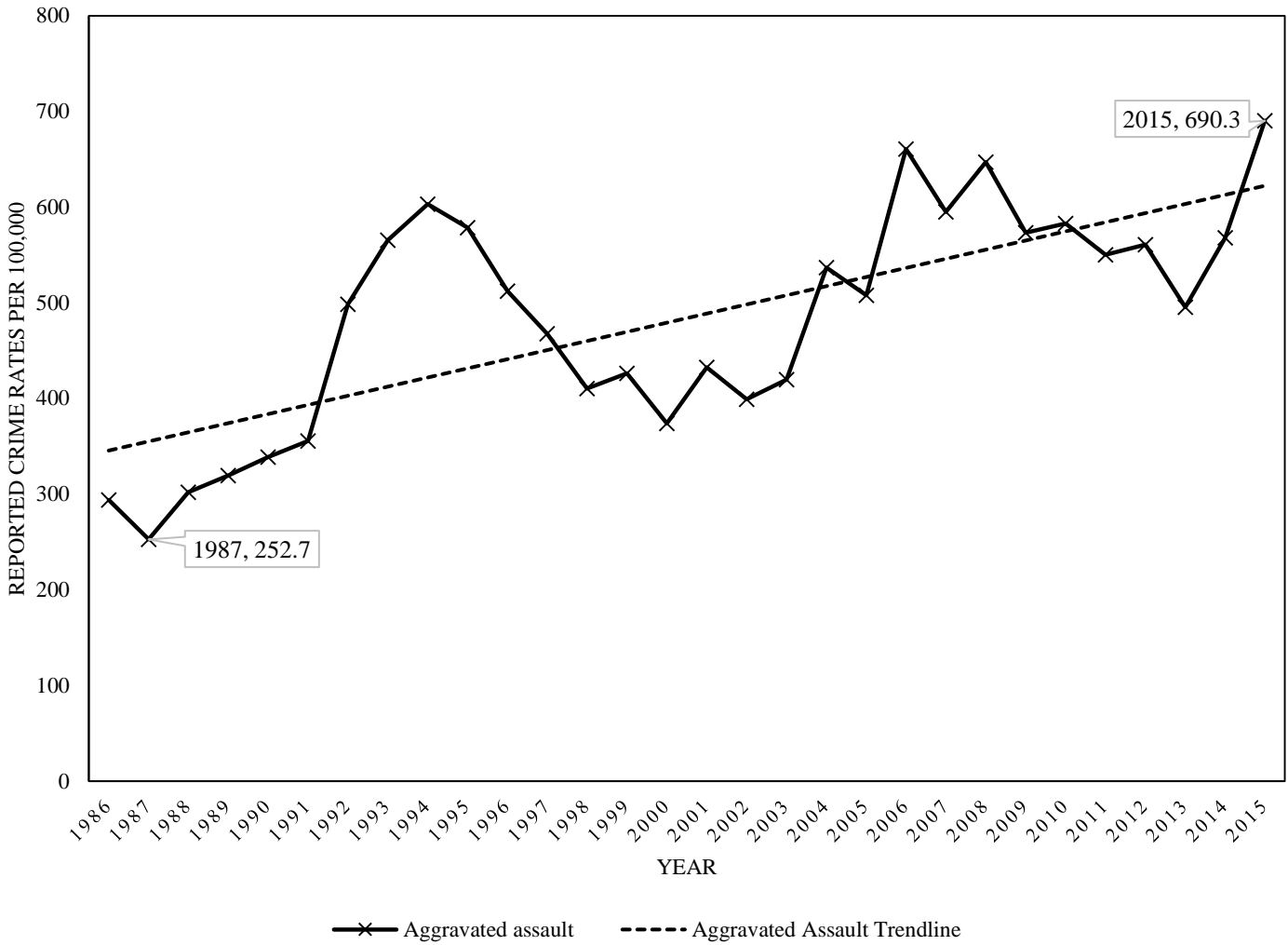
Figure 18: Robbery Crime Rates, Anchorage, 1986-2015

- Figure 18 shows a slight decreasing trend for robbery crime rates. The highest rate of robberies occurred in 1995 (307.4 per 100,000) and the lowest rate occurred in 2004 (115.2 per 100,000).
- There was an increasing trend in aggravated assault between 1986 and 2015. The highest rate of aggravated assault occurred in 2015 (690.3 per 100,000) and the lowest rate occurred in 1987 (252.7 per 100,000). On average, aggravated assault accounted for 64.6% of the violent crime rate in Anchorage between 1986 and 2015.

b. Property Crime Rates for Anchorage

Figures 21-24 show a decreasing trend for the overall property crime rate, burglary crime rate, larceny-theft crime rate, and motor vehicle theft crime rate for Anchorage between 1986 and 2015. The highest rate of property crime was in 1986 (6,567.3 property crimes per 100,000 people) and the lowest rate of property crime was in 2011 (3,195.1 property crimes per 100,000 people). There was a 24% increase in the property crime rate between 2011 and 2015; the rate rose from 3,195.1 per 100,000 to 3,950.6 per 100,000.

- Figure 22 shows the highest burglary rate occurred in 1986 (1,213.7 per 100,000) and the lowest occurred in 2011 (365.0 per 100,000). There was a recent increase in the burglary crime rate between 2011 and 2015; the rate increased from 365.0 to 564.1 burglaries per 100,000 people.
- Figure 23 shows the highest larceny-theft crime rate occurred in 1986 (4,758.0 per 100,000) and the lowest rate occurred in 2008 (2,564.4 per 100,000).
- On average, larceny-theft accounted for 74.9% of the property crime rate in Anchorage between 1986 and 2015.
- Figure 24 shows the highest rate of motor vehicle theft occurred in 1994 (864.3 per 100,000) and the lowest rate occurred in 2011 (211.2 per 100,000). There was a recent increase in the motor vehicle theft rate between 2011 and 2015; the rate rose from 211.2 to 386.3 per 100,000.

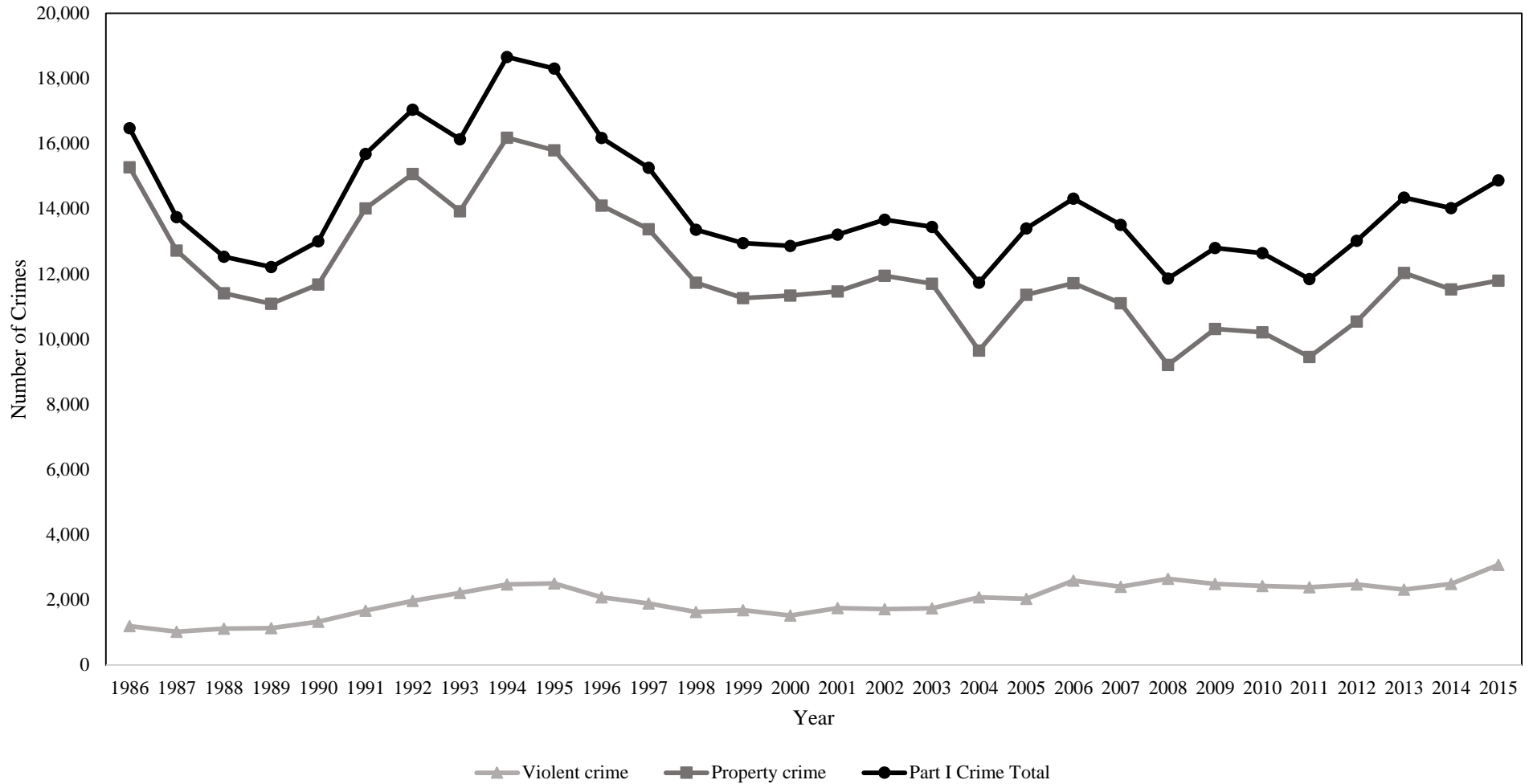

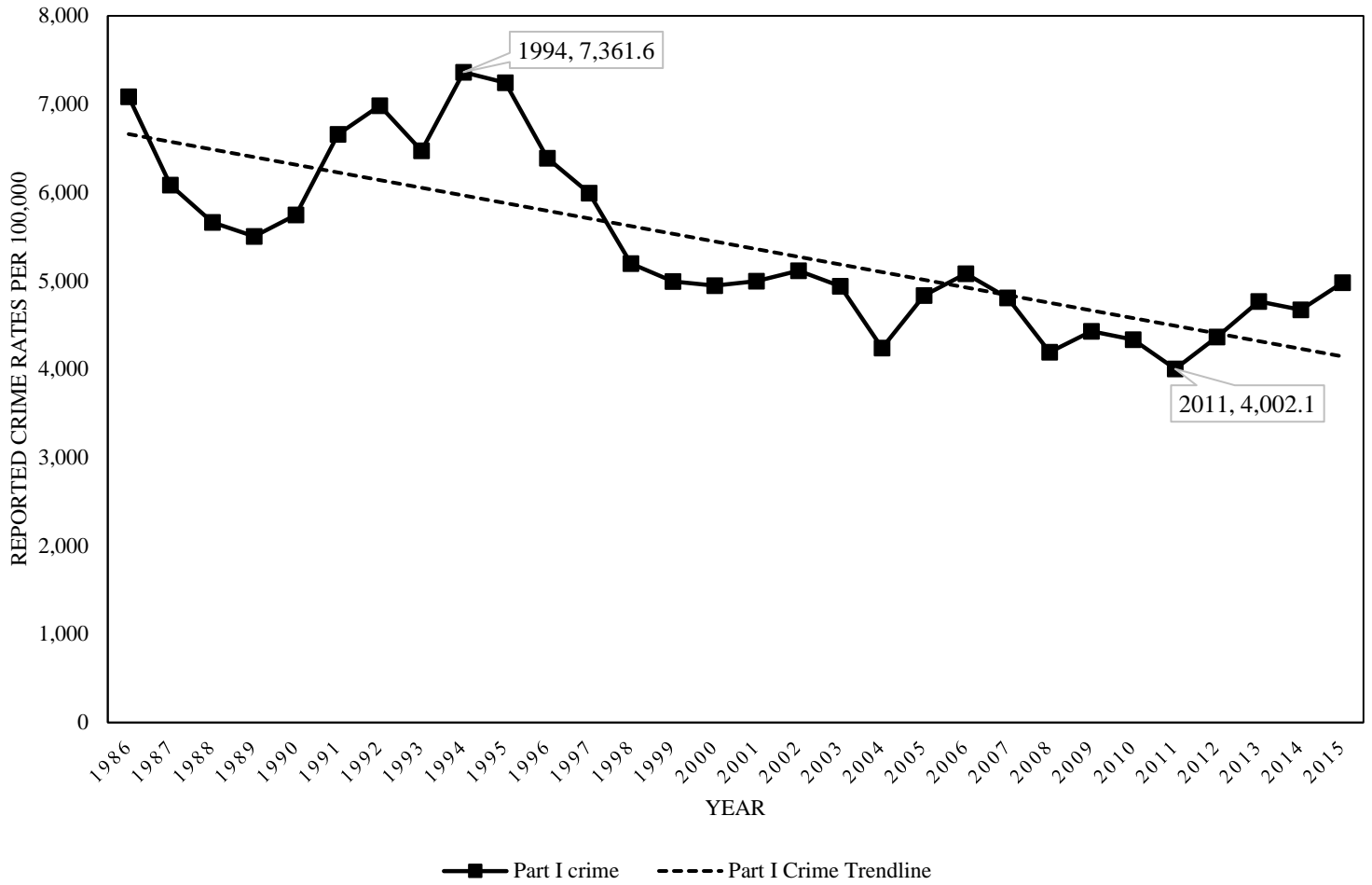

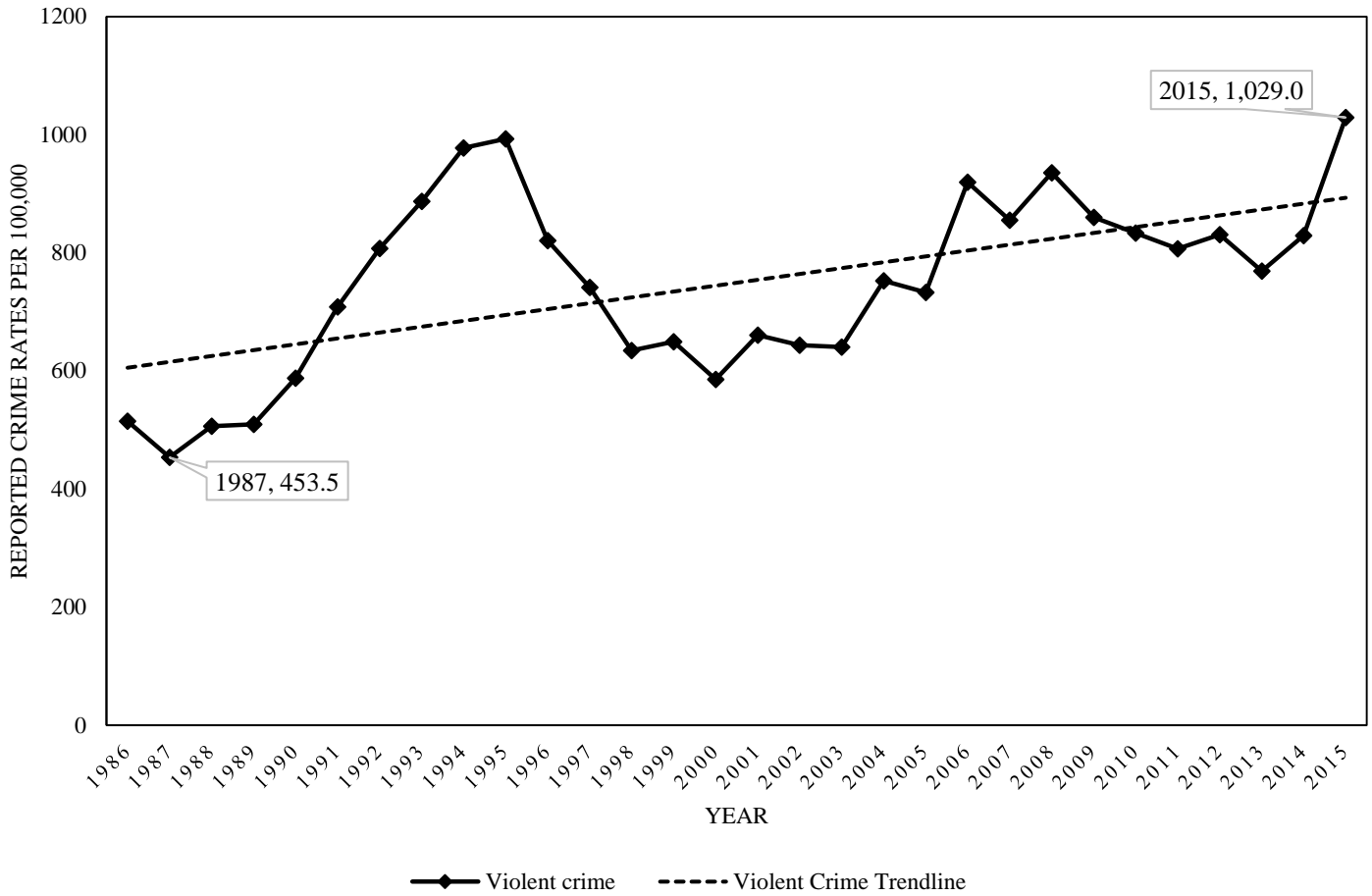

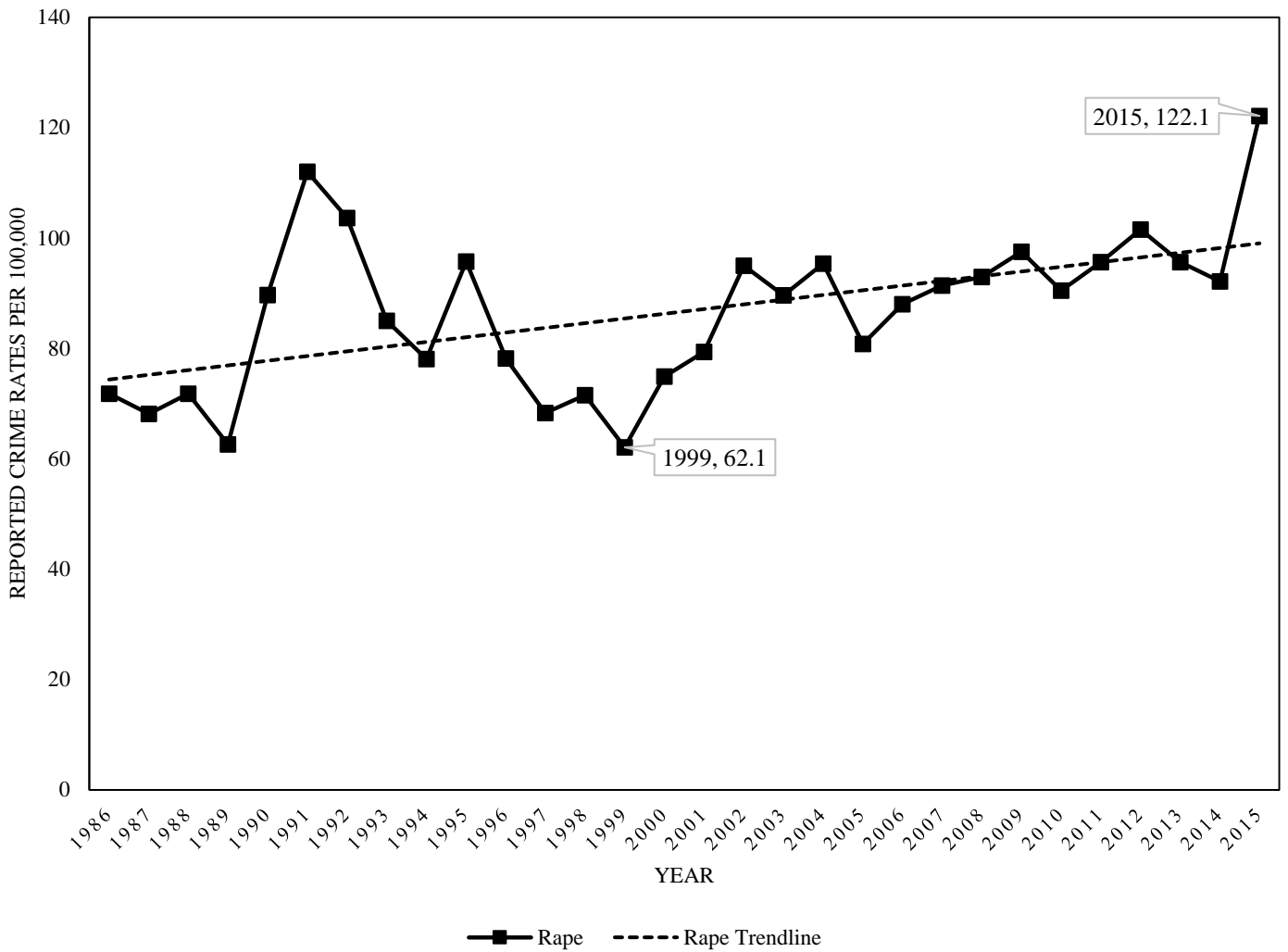

Figure 16: Homicide Crime Rates, Anchorage, 1986-2015



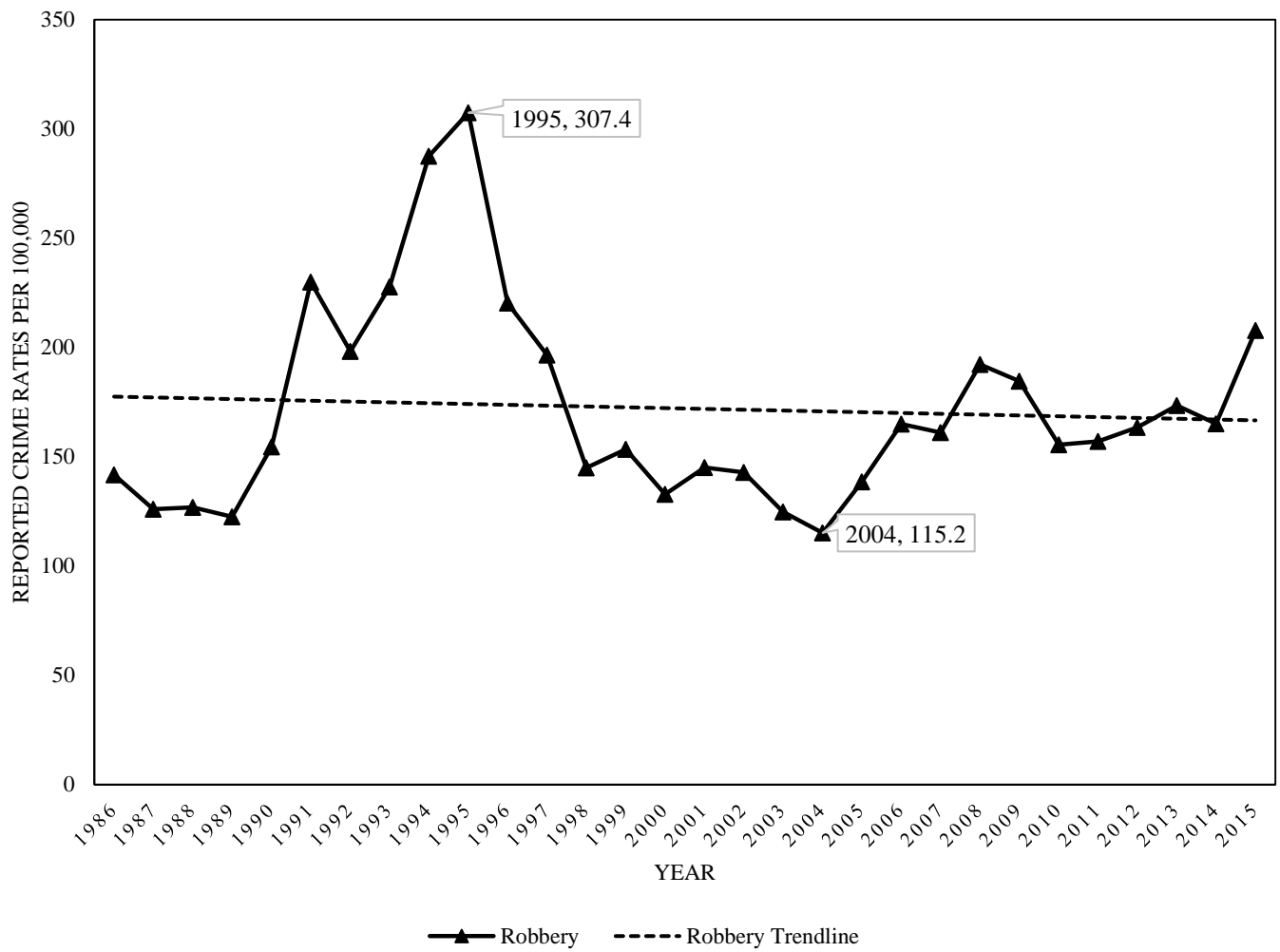

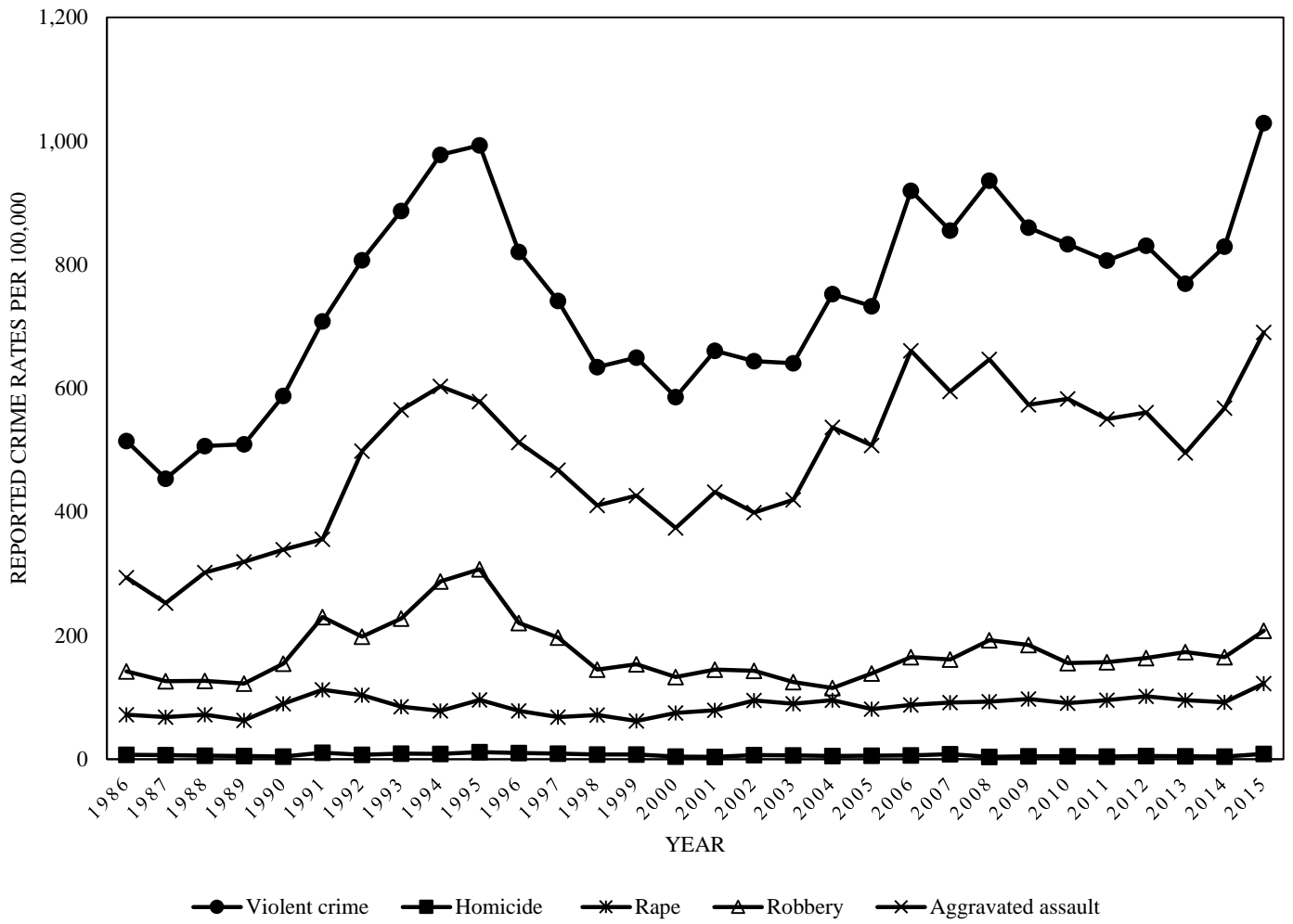
Figure 19: Aggravated Assault Crime Rates, Anchorage, 1986-2015

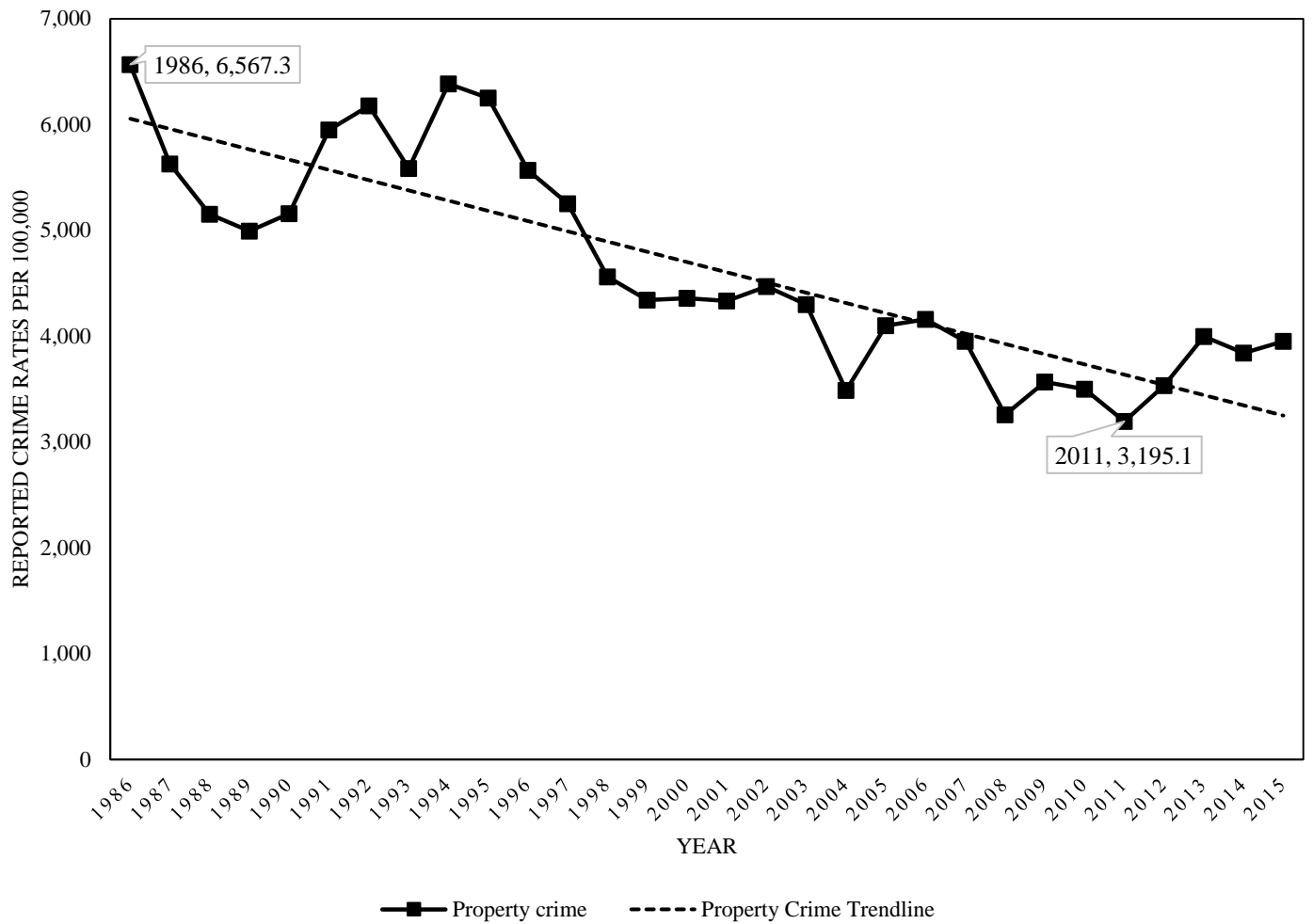
Figure 20: Violent Crime Rates, Anchorage, 1986-2015

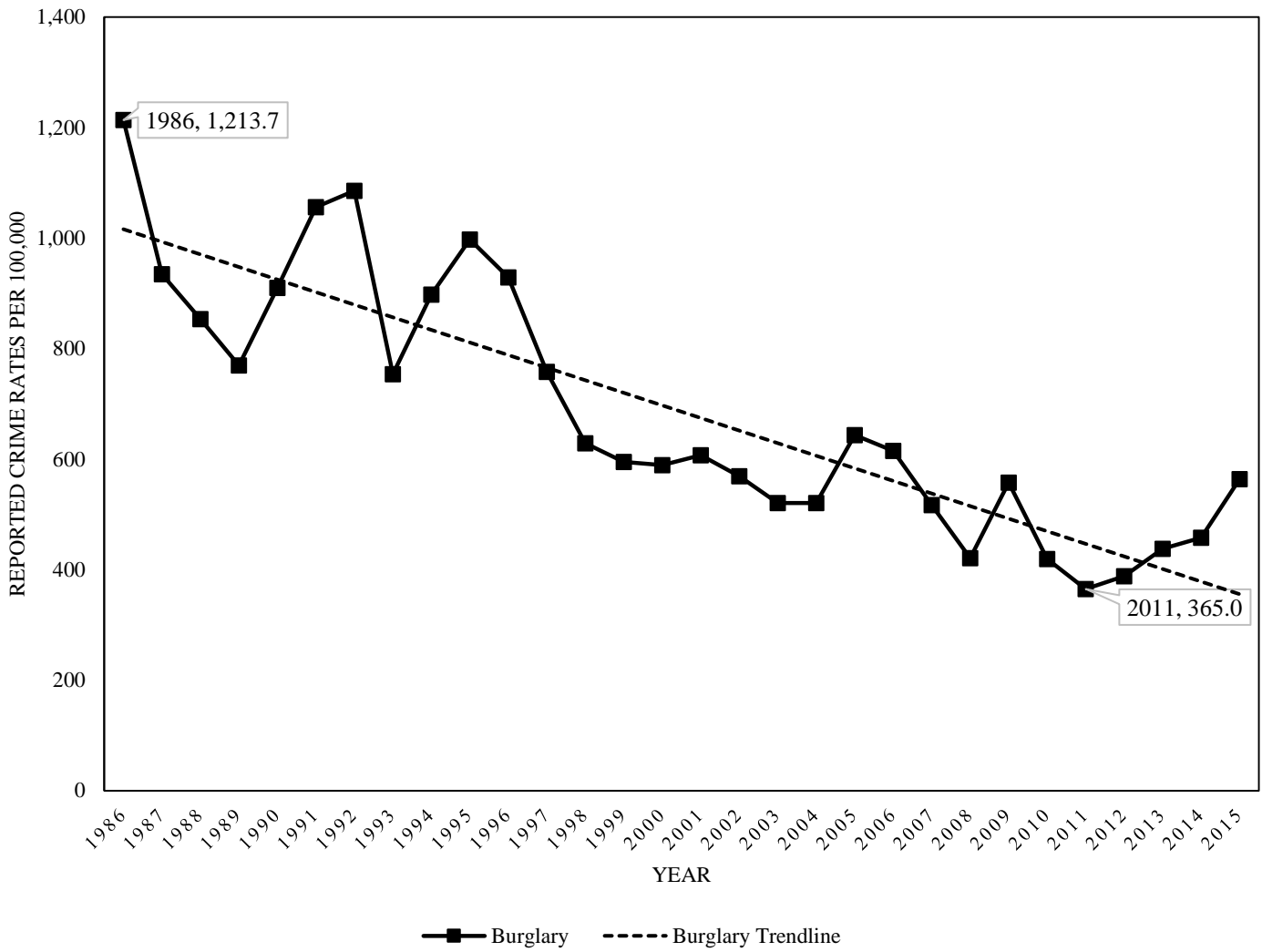

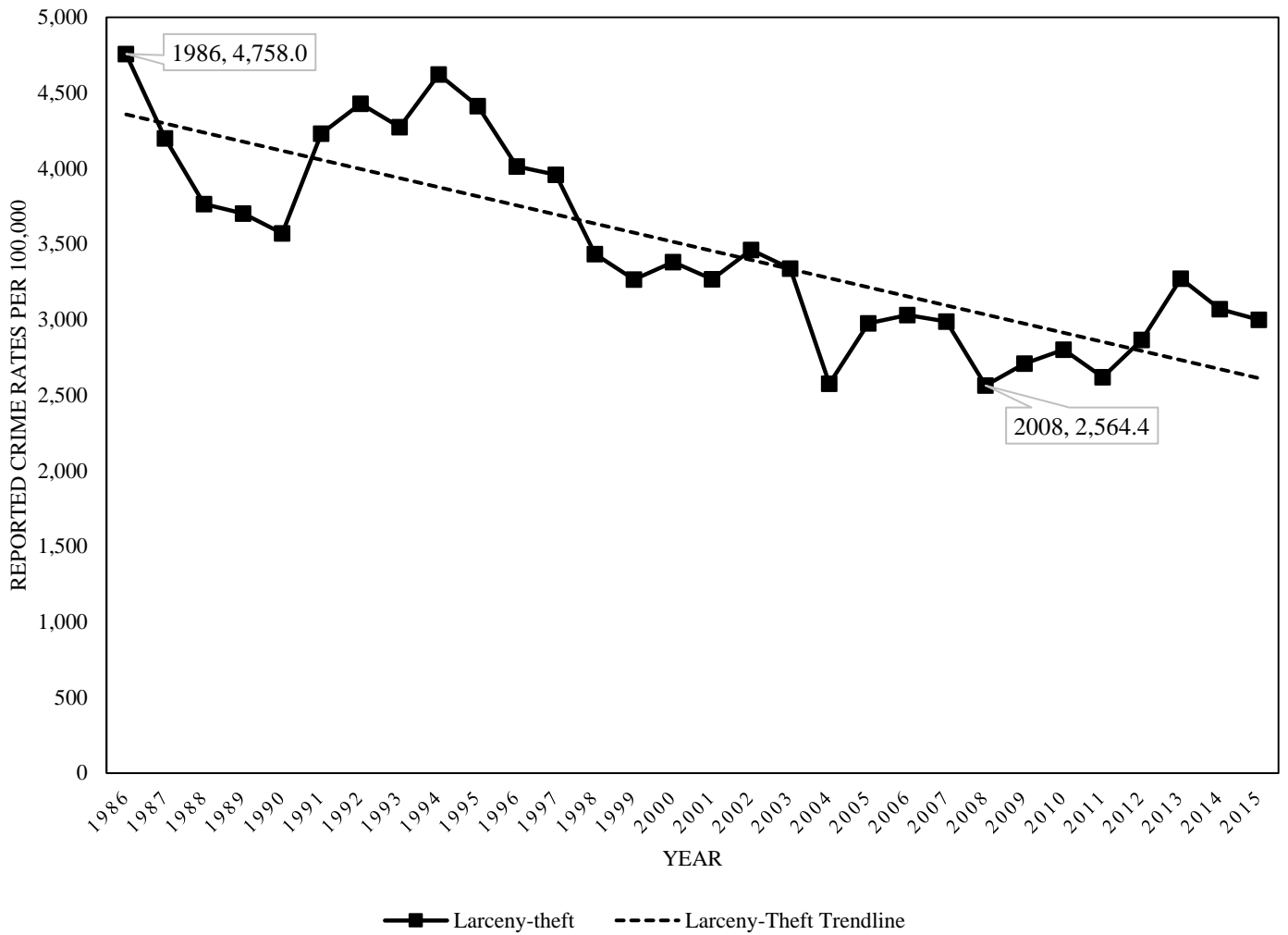
Figure 22: Burglary Crime Rates, Anchorage, 1986-2015

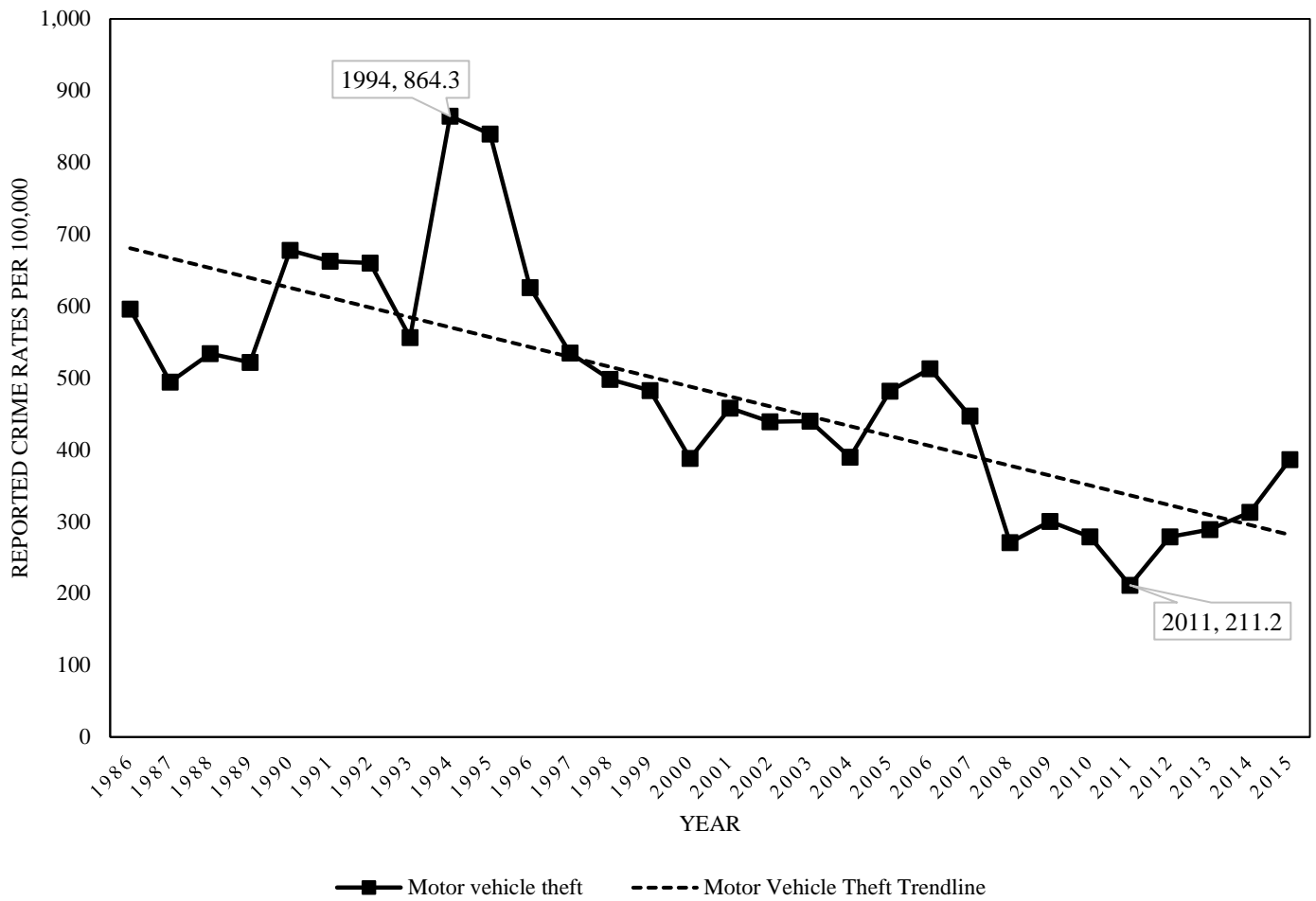

Part 3: Arrests for Anchorage

A. Number of Total Arrests and Total Arrest Rates for Anchorage

Tables 5-6 and Figures 25-27 show the total number of arrests and arrest rates for both adults and juveniles for Anchorage. Arrest data in this report includes only arrests made by the Anchorage Police Department for Part I and Part II crimes. The arrest data is only presented for Anchorage due to the missing arrest data for Alaska State Troopers from 2012-2014 in the *Crime in Alaska* reports. Total (adult and juvenile) arrest rates are calculated using total population estimates for Anchorage Municipality. Adult arrest rates are calculated using adult (18+) population estimates for Anchorage Municipality. Arrest rates were calculated per 100,000 people.

The overall Anchorage arrest rate (both adult and juvenile) and the adult only arrest rate both show decreasing trends. The highest volume of overall arrests occurred in 2009 (20,087 arrests) and the lowest occurred in 2015 (14,387 arrests). Figure 26 shows the arrest rate for both adults and juveniles; the highest arrest rate occurred in 2009 (6,945.0 per 100,000) and the lowest in 2015 (4,816.3 per 100,000). Figure 27 shows the arrest rate for adults only; the highest arrest rate occurred in 2009 (8,505.4 arrests per 100,000 people) and the lowest rate occurred in 2015 (5,995.7 arrests per 100,000 people).

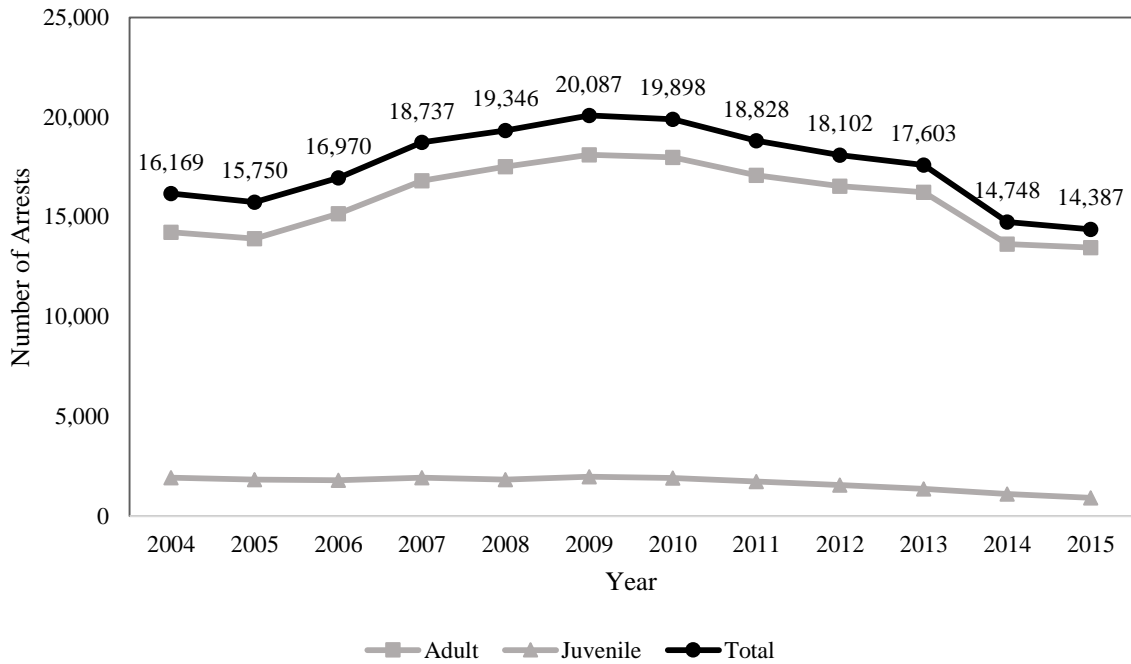

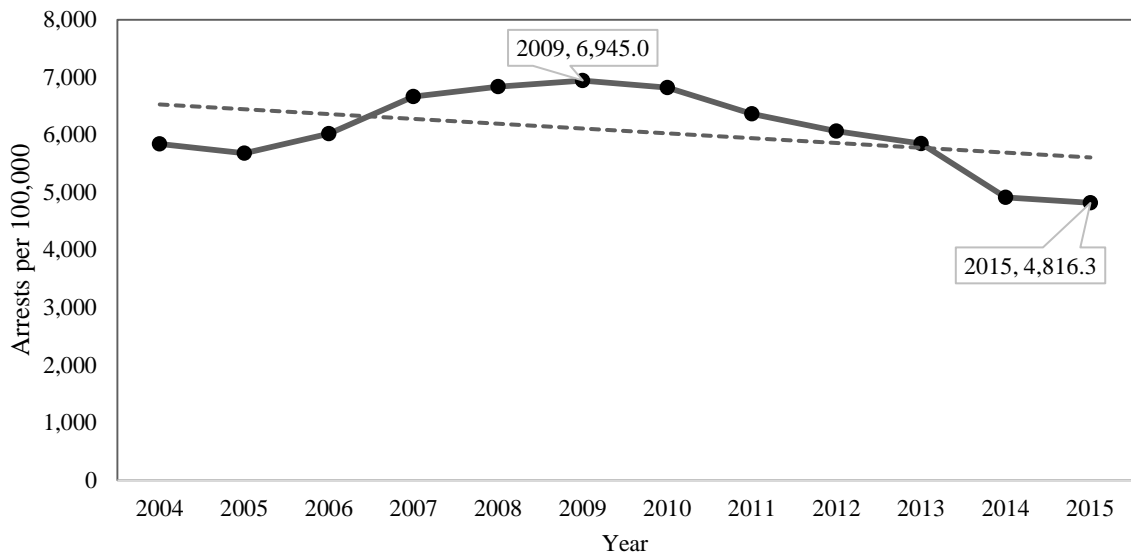

 Rates per 100,000 persons



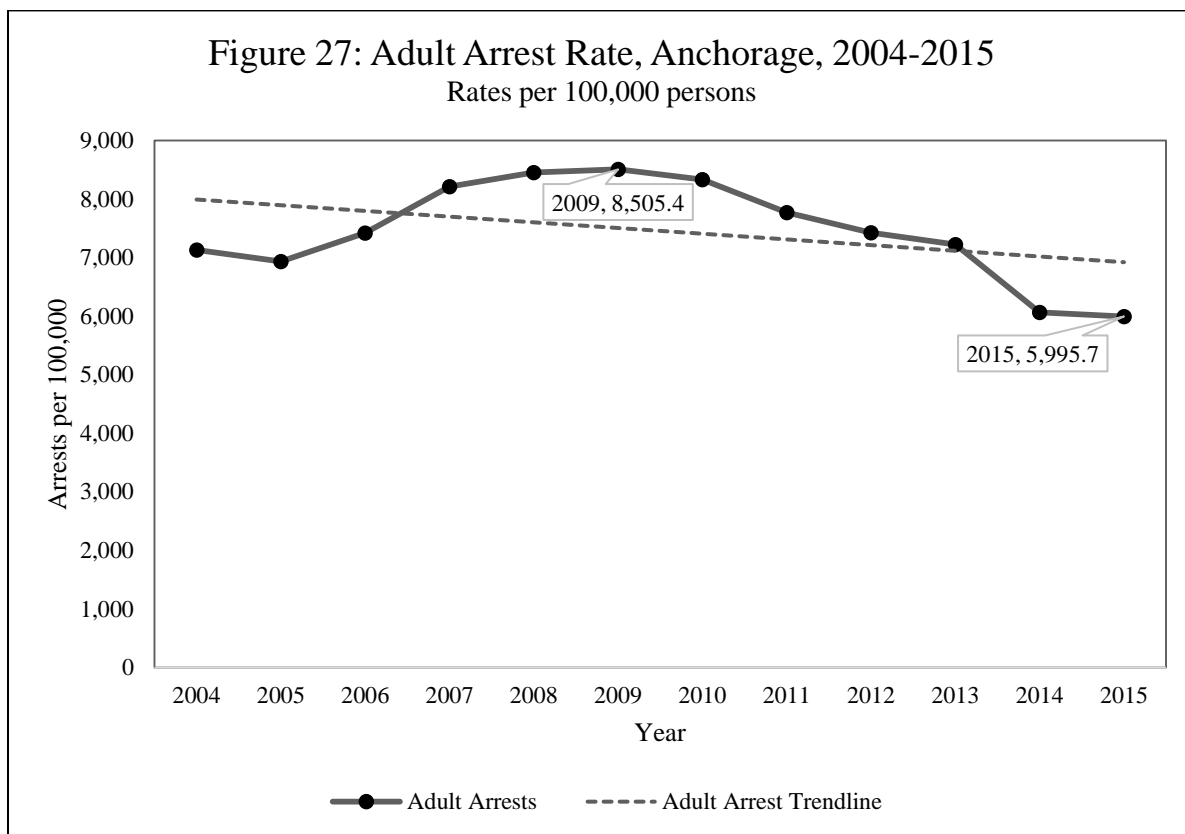

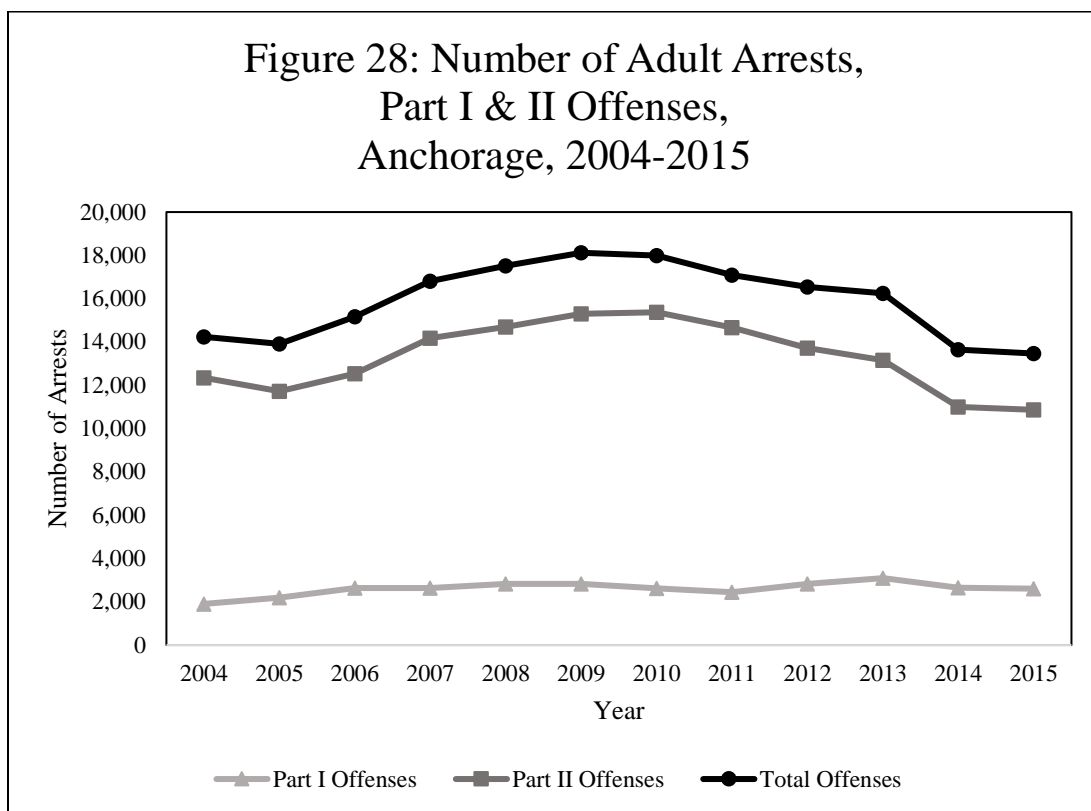

B. Number of Arrests for Part I and II Offenses for Anchorage

Part I offenses consist of violent crimes and property crimes. Violent crimes include homicide (murder and non-negligent manslaughter), rape, robbery, and aggravated assault. Property crimes include burglary, larceny-theft, motor vehicle theft, and arson. Part II offenses include other assaults (simple); forgery and counterfeiting; fraud; embezzlement; stolen property: buying, receiving, possessing; vandalism; weapons: carrying, possessing, etc.; prostitution and commercialized vice; sex offenses (except rape, prostitution, and commercialized vice); drug abuse violations; gambling; offenses against the family and children; driving under the influence; liquor laws; drunkenness; disorderly conduct; vagrancy; all other offenses; suspicion; curfew and loitering laws (persons under age 18); and runaways (persons under age 18).

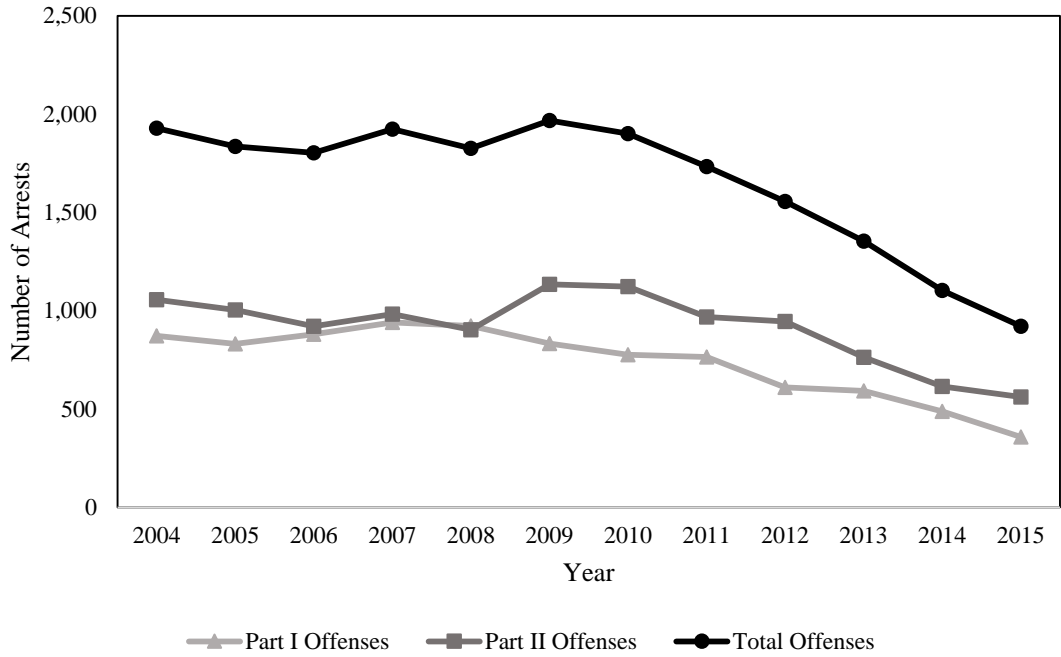
- Figure 28 shows the total volume of adult arrests for Anchorage and also the number of arrests broken down by Part I and Part II offenses. The highest number of adult arrests for Part I offenses occurred in 2013 (3,091 arrests) and the lowest number occurred in 2004 (1,901 arrests). The highest number of adult arrests for Part II offenses occurred in 2010 (15,371 arrests) and lowest number occurred in 2015 (10,865 arrests).
- Figure 29 shows the overall volume of juvenile arrests for Anchorage and also the number of arrests broken down by Part I and Part II offenses. The highest number of juvenile arrests for Part I offenses occurred during 2007 (941 arrests) and the lowest number occurred during 2015 (359). The highest number of arrests for juvenile Part II offenses occurred during 2009 (1,134 arrests) and the lowest number occurred during 2015 (562 arrests).

C. Part I Offenses Arrests for Anchorage

Table 7 shows the number of adult arrests for Part I offenses (violent and property offenses) for Anchorage between 2004 and 2015. The highest volume of Part I arrests occurred in 2013 (3,091 arrests) and the lowest in 2004 (1,901 arrests).

- The highest number of arrests for violent offenses occurred in 2008 (1,132 arrests) and the lowest occurred in 2004 (519 arrests).
 - The highest number of arrests for murders occurred in 2007 (20 arrests) and the lowest in 2012 (9 arrests).
 - The highest number of arrests for rapes occurred in 2012 (71 arrests) and the lowest in 2005 (15 arrests).
 - The highest number of arrests for robberies occurred in 2009 (206 arrests) and the lowest in 2005 (70 arrests).
 - The highest number of arrests for aggravated assaults occurred in 2008 (903 arrests) and the lowest in 2004 (413 arrests).
- The highest number of arrests for property offenses occurred in 2013 (2,122 arrests) and the lowest number of arrests were in 2004 (1,382 arrests).
 - The highest number of arrests for burglaries were in 2015 (145 arrests) and the lowest were in 2004 (91 arrests).
 - The highest number of arrests for larceny-thefts were in 2013 (1,891) and the lowest were in 2004 (1,172 arrests).
 - The highest number of arrests for motor vehicle thefts were in 2006 (158 arrests) and the lowest were in 2011 (86 arrests).
 - The highest number of arrests for arson was in 2008 (13 arrests) and the lowest in 2007 (1 arrest).

A. Part I Offenses Arrest Rates for Anchorage

Table 8 shows the adult arrest rates for Part I offenses for Anchorage between 2004 and 2015. Figure 30 shows the highest rate of Part I arrests occurred in 2013 (1,374.6 arrests per 100,000) and the lowest rate occurred in 2004 (951.9 arrests per 100,000). The trend was slightly increasing for Part I arrest rates between 2004 and 2015.

1. Violent Offenses Arrest Rates for Anchorage

Figure 31 shows an increasing trend in the adult arrest rate for violent offenses between 2004 and 2015 in Anchorage. The highest arrest rate for violent offenses occurred in 2008 (546.2 arrests per 100,000) and the lowest rate occurred in 2004 (259.9 arrests per 100,000).

- Figure 32 shows steady trend in the adult homicide arrest rate for Anchorage between 2004 and 2015. The highest rate arrest for homicides occurred in 2007 (9.8 per 100,000) and the lowest was in 2012 (4.0 per 100,000).
- Figure 33 shows an increasing trend in the adult arrest rate for rape between 2004 and 2015. The highest rate was in 2012 (31.9 per 100,000) and the lowest rate was in 2005 (7.5 per 100,000).

- Figure 34 shows an increasing trend in the arrest rate for robbery. The highest rate was in 2009 (96.7 per 100,000) and the lowest rate was in 2005 (34.9 per 100,000).
- Figure 35 shows an increasing trend in the aggravated assault arrest rate. The highest rate was in 2008 (435.7 per 100,000) and the lowest rate was in 2004 (206.8 per 100,000).

2. Property Offenses Arrest Rates for Anchorage

Figure 36 shows a slight decreasing trend in the adult arrest rate for property offenses between 2004 and 2015. The highest arrest rate for property offenses occurred in 2006 (961.7 arrests per 100,000). The lowest arrest rate for property crimes was in 2011 (666.5 arrests per 100,000).

- Figure 37 shows a slight increasing trend in the burglary arrest rate between 2004 and 2015. The highest burglary arrest rate occurred in 2015 (64.6 arrests per 100,000) and lowest occurred in 2004 (45.6 arrests per 100,000).
- Figure 38 shows a slight decreasing trend in the arrest rate for larceny-theft between 2004 and 2015. The highest arrest rate for larceny-theft occurred in 2013 (840.9 arrests per 100,000) and the lowest occurred in 2015 (554.3 per 100,000).
- Figure 39 shows a decreasing trend in the arrest rate for motor vehicle theft. The highest arrest rate occurred in 2006 (77.3 per 100,000) and the lowest occurred in 2011 (39.1 per 100,000).
- Figure 40 shows an increasing trend in the arrest rate for arson; the highest arrest rate occurred in 2008 (6.3 per 100,000) and the lowest in 2007 (0.5 per 100,000).

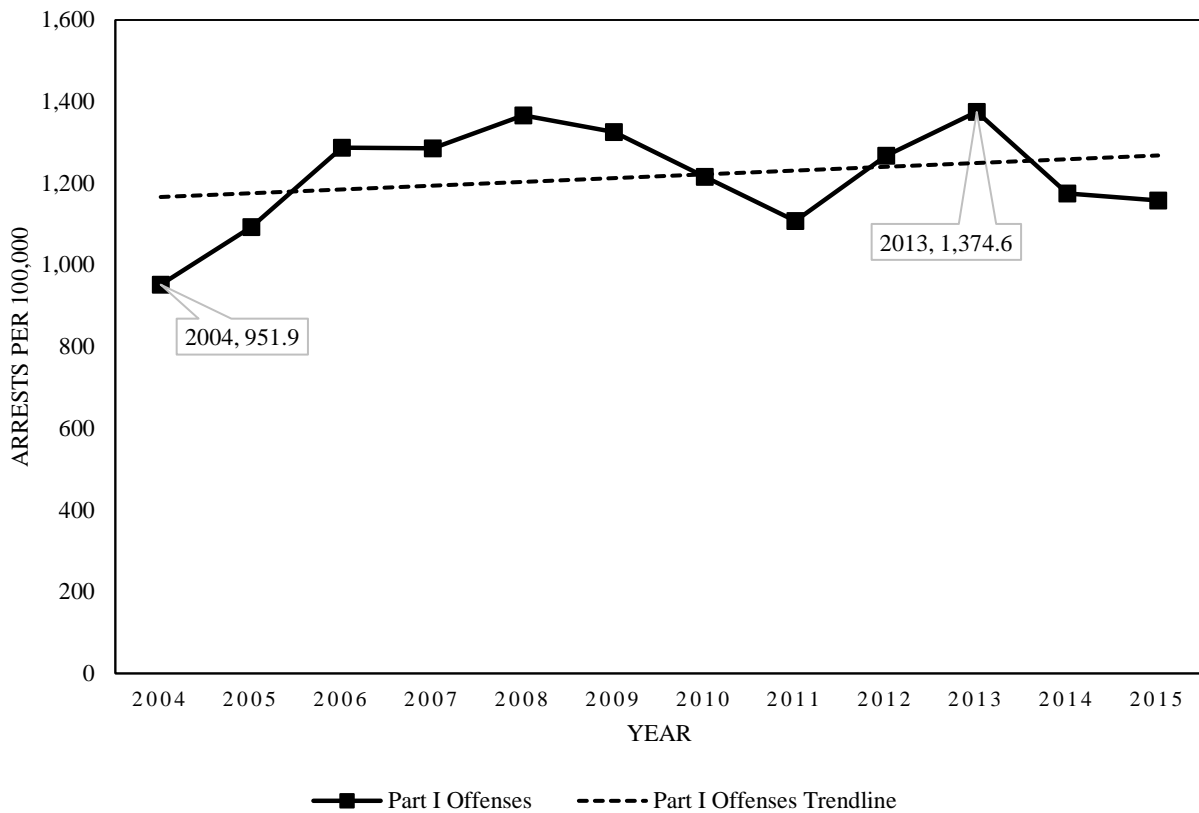

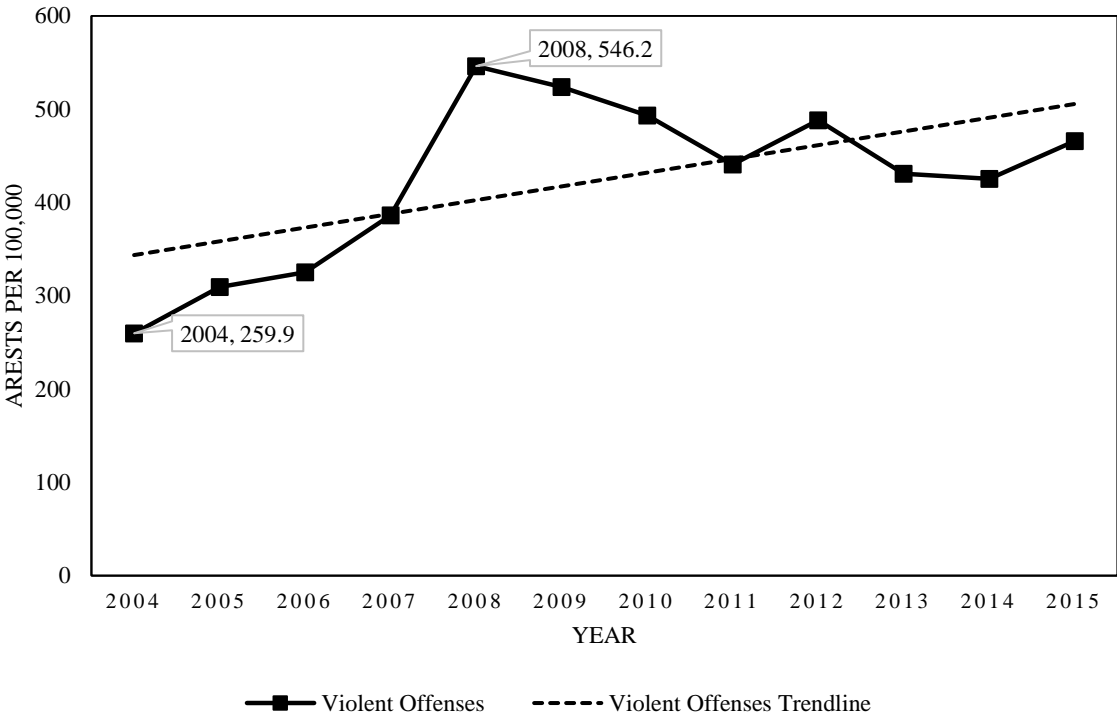

Figure 30: Adult Arrest Rate, Part I Offenses, Anchorage, 2004-2015



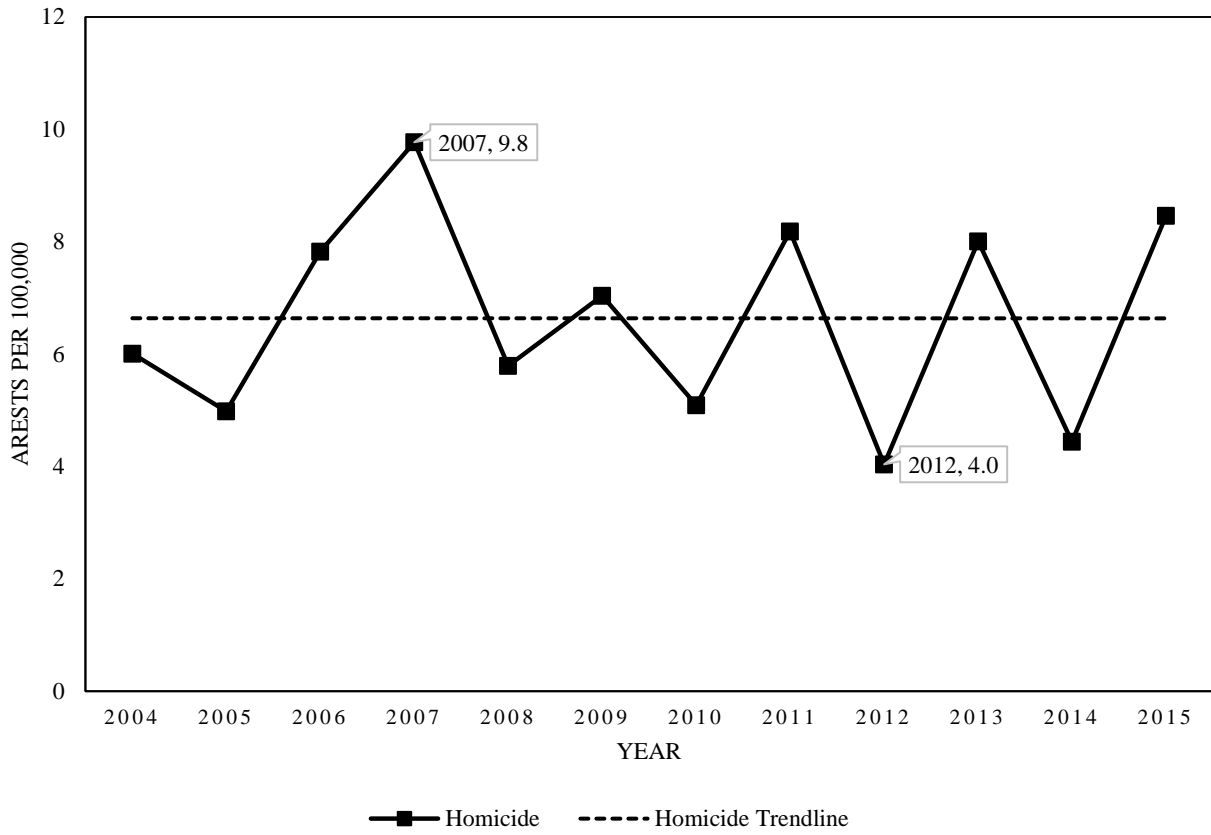

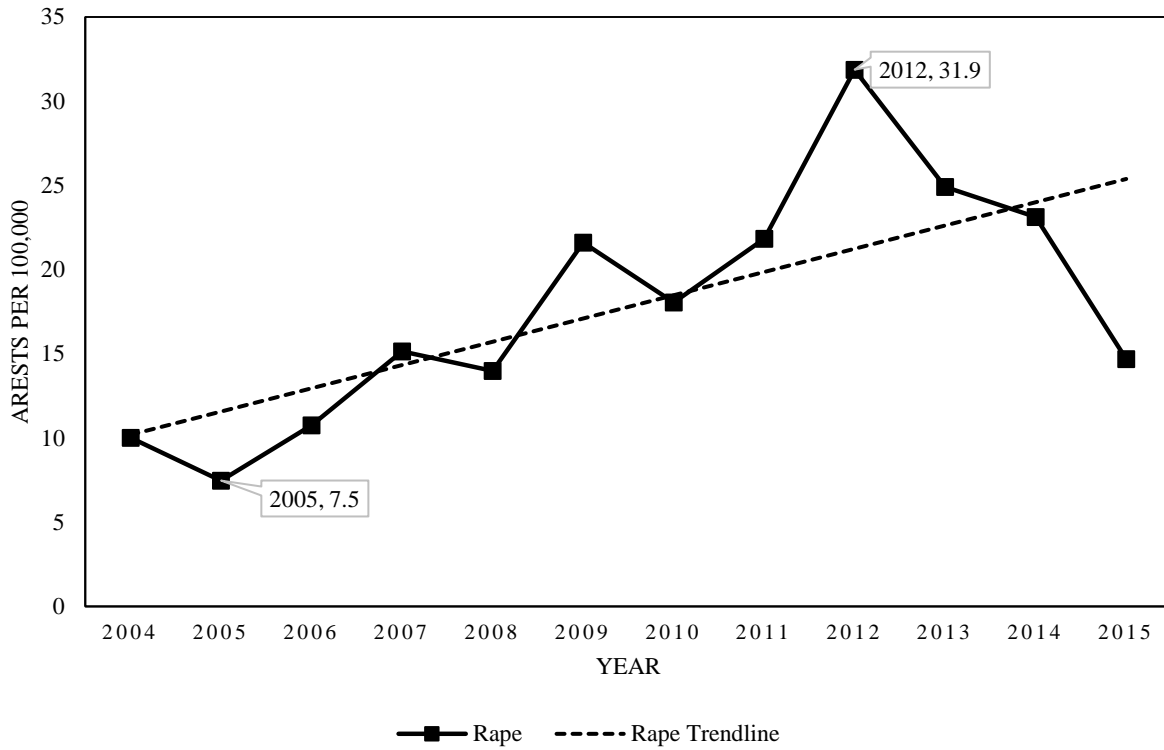

Figure 32: Adult Arrest Rate, Homicide, Anchorage, 2004-2015



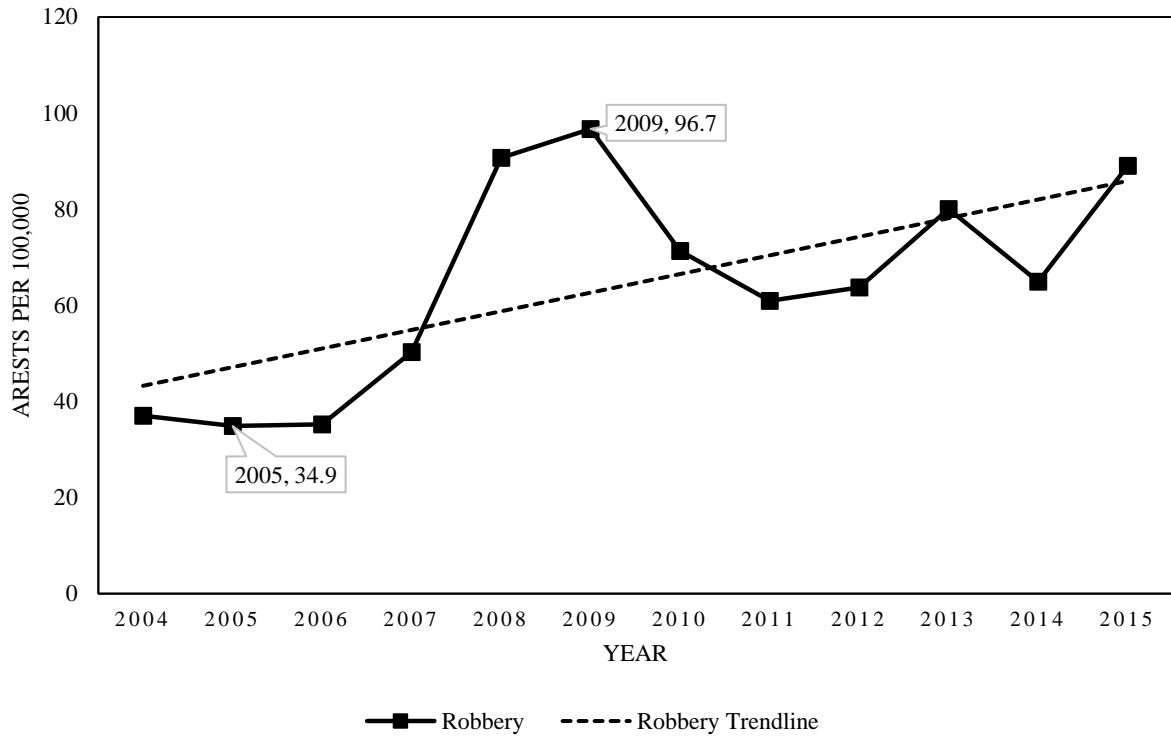

Figure 33: Adult Arrest Rate, Rape, Anchorage, 2004-2015



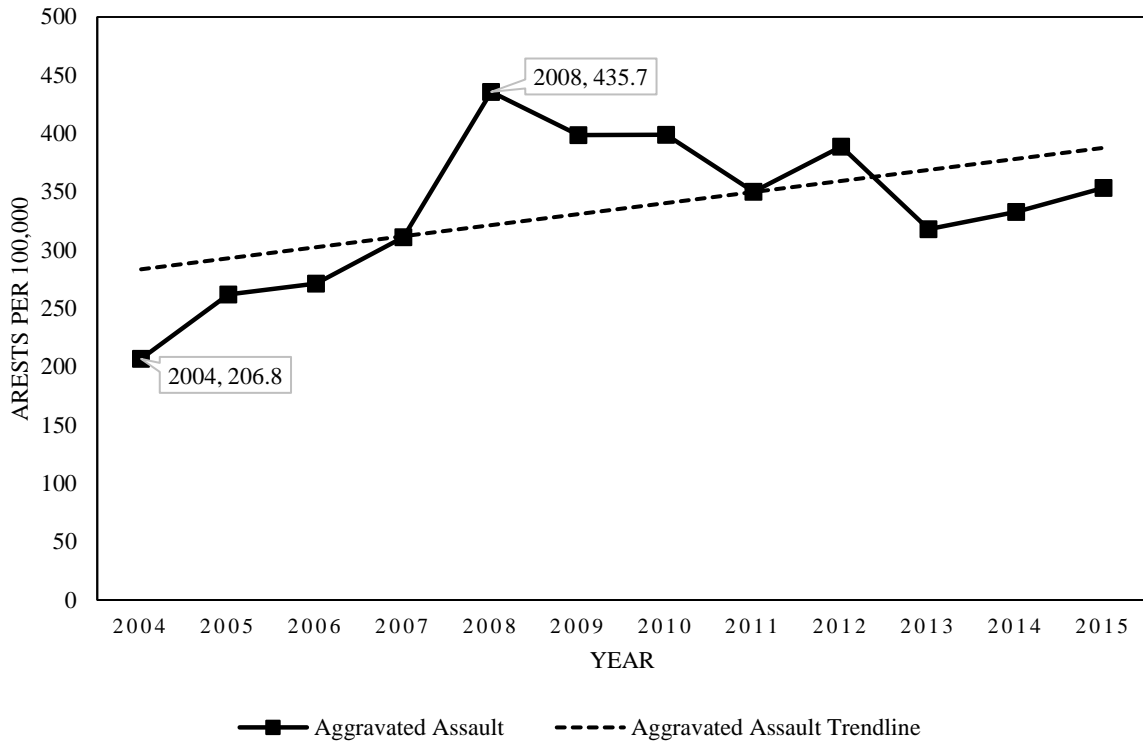

Figure 34: Adult Arrest Rate, Robbery, Anchorage, 2004-2015



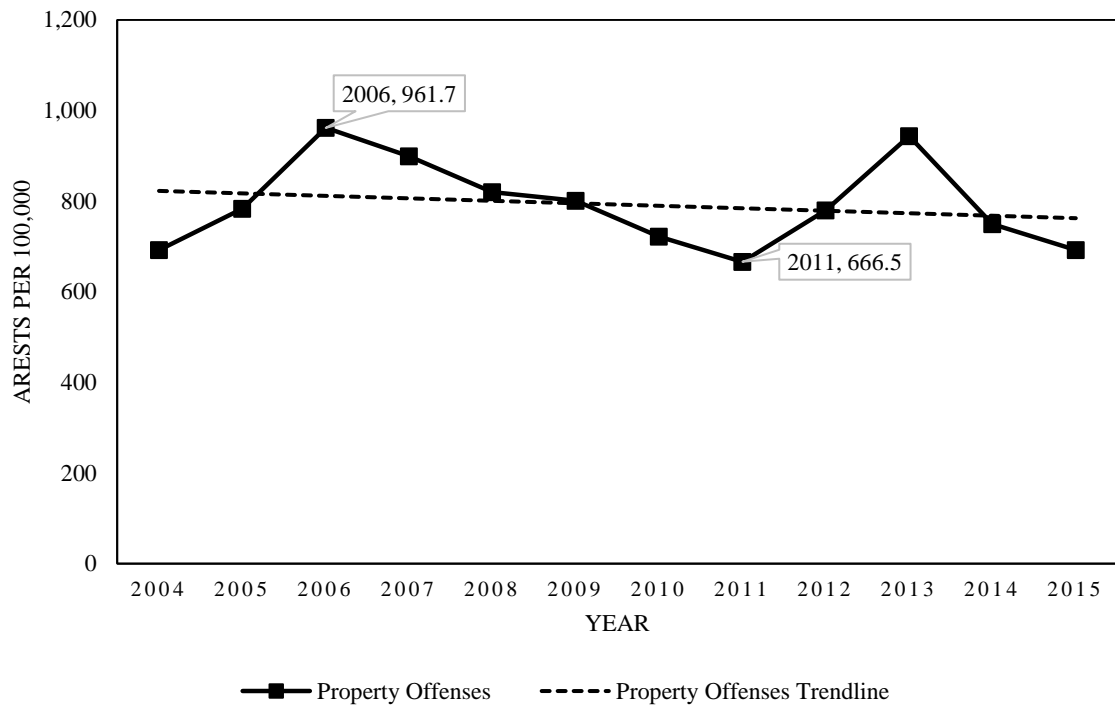

Figure 35: Adult Arrest Rate, Aggravated Assault, Anchorage, 2004-2015



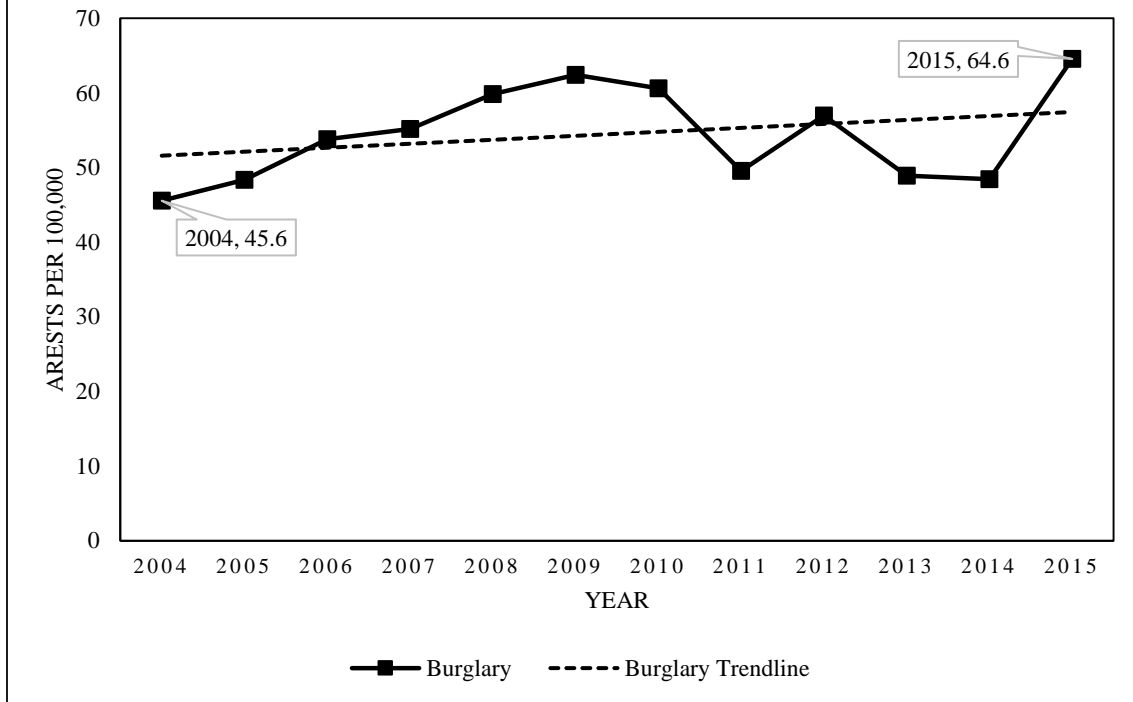

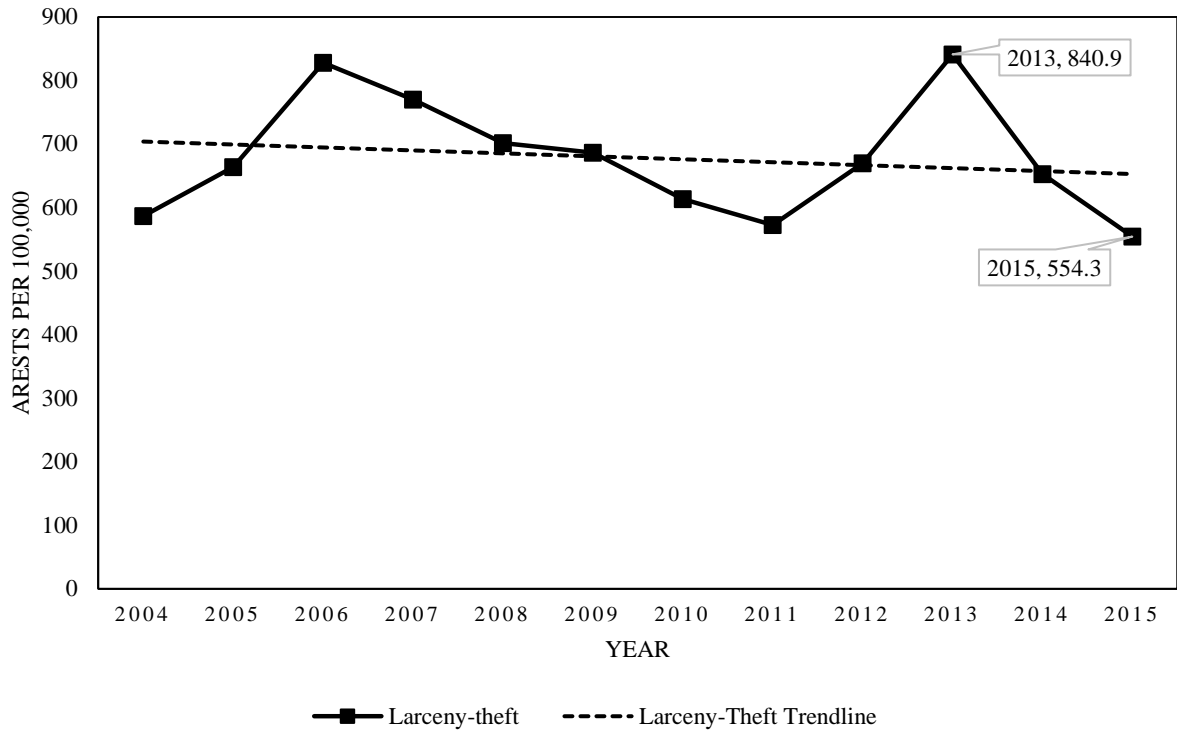

Figure 37: Adult Arrest Rate, Burglary, Anchorage, 2004-2015



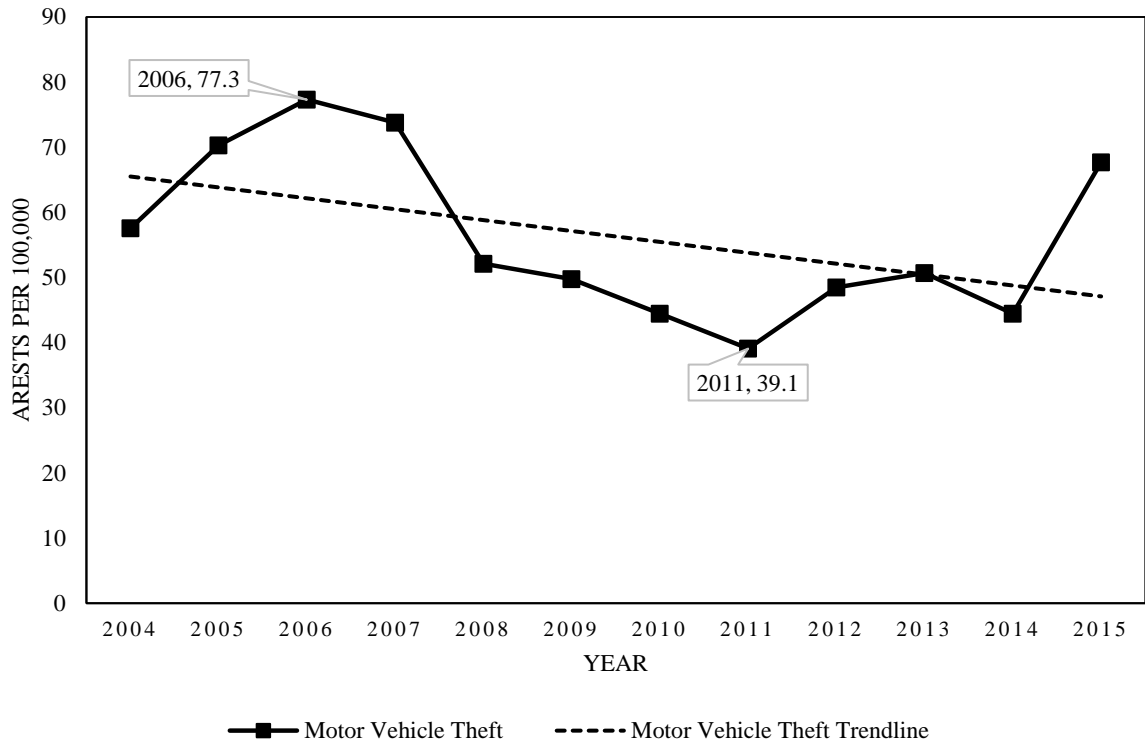

Figure 38: Adult Arrest Rate, Larceny-Theft, Anchorage, 2004-2015



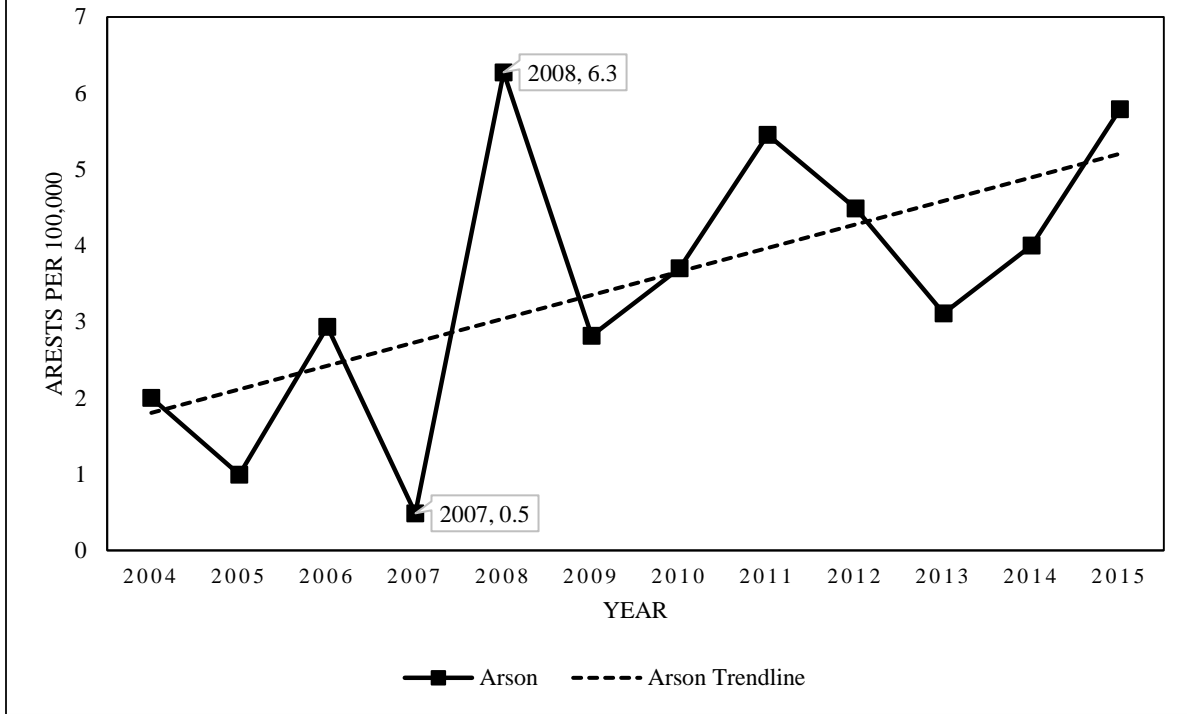

B. Reported Versus Arrested Part I Crimes for Anchorage

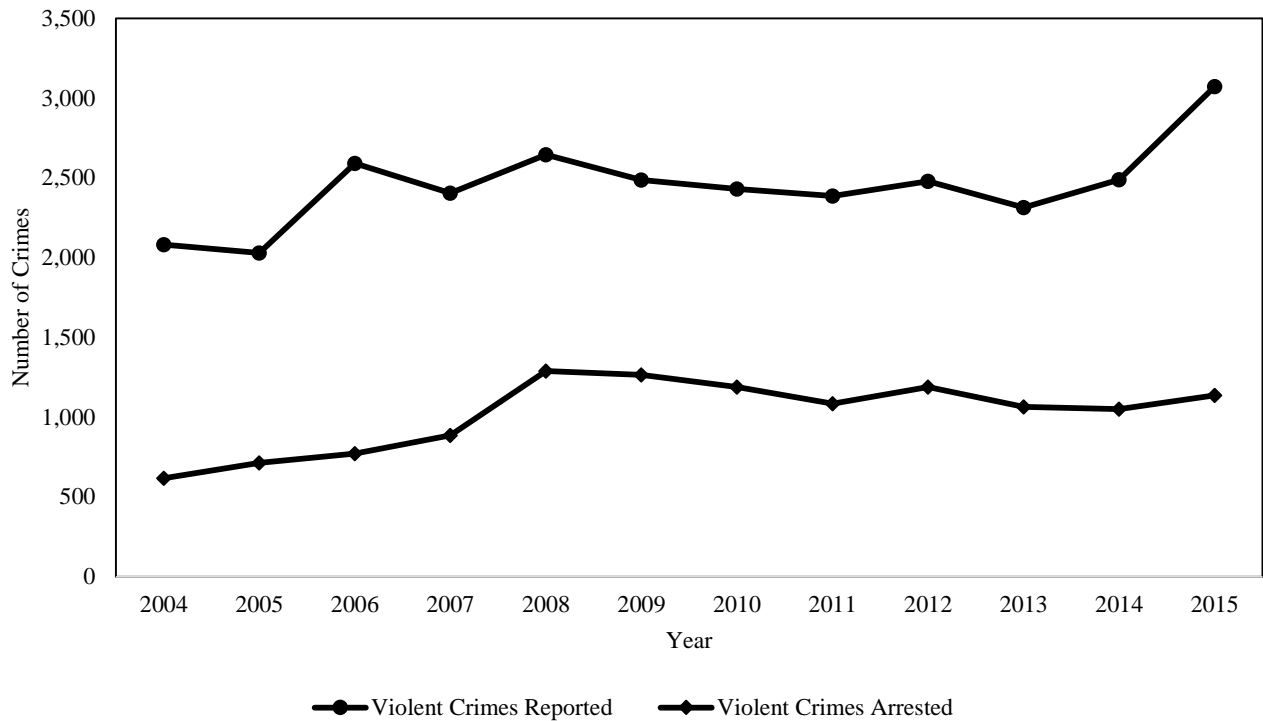
Figure 41: Part I Crimes (Violent & Property Crimes)

Table 9 and Figures 41-43 show the number of reported Part I crimes (violent and property crimes) compared to the number of arrests for Part I crimes for Anchorage between 2004 and 2015. These numbers include all reports and arrests of Part I crimes for both juveniles and adults for Anchorage Police Department. Arson was not consistently reported in the reported crimes for Anchorage, therefore arson was removed from the number of reported and arrested crimes. Table 9 also shows the percentage arrested compared to the number of crimes reported. The highest percentage of arrests for Part I crimes compared to the number of reported crimes occurred in 2008 (31.3%; 11,858 reported crimes and 3,716 arrested) and the lowest percentage occurred in 2015 (19.7%; 14,875 reported crimes and 2,927 arrested). For violent crimes, the highest percentage arrested compared to crimes reported was in 2009 (50.9%; 2,488 reported crimes and 1,266 arrested) and the lowest percentage arrested was in 2004 (29.6%; 2,083 reported crimes and 617 arrested). For property crimes, the highest percentage arrested compared to crimes reported was in 2008 (26.3%; 9,211 crimes reported and 2,427 arrested) and the lowest was in 2015 (15.2%; 11,801 crimes reported and 1,789 arrested).

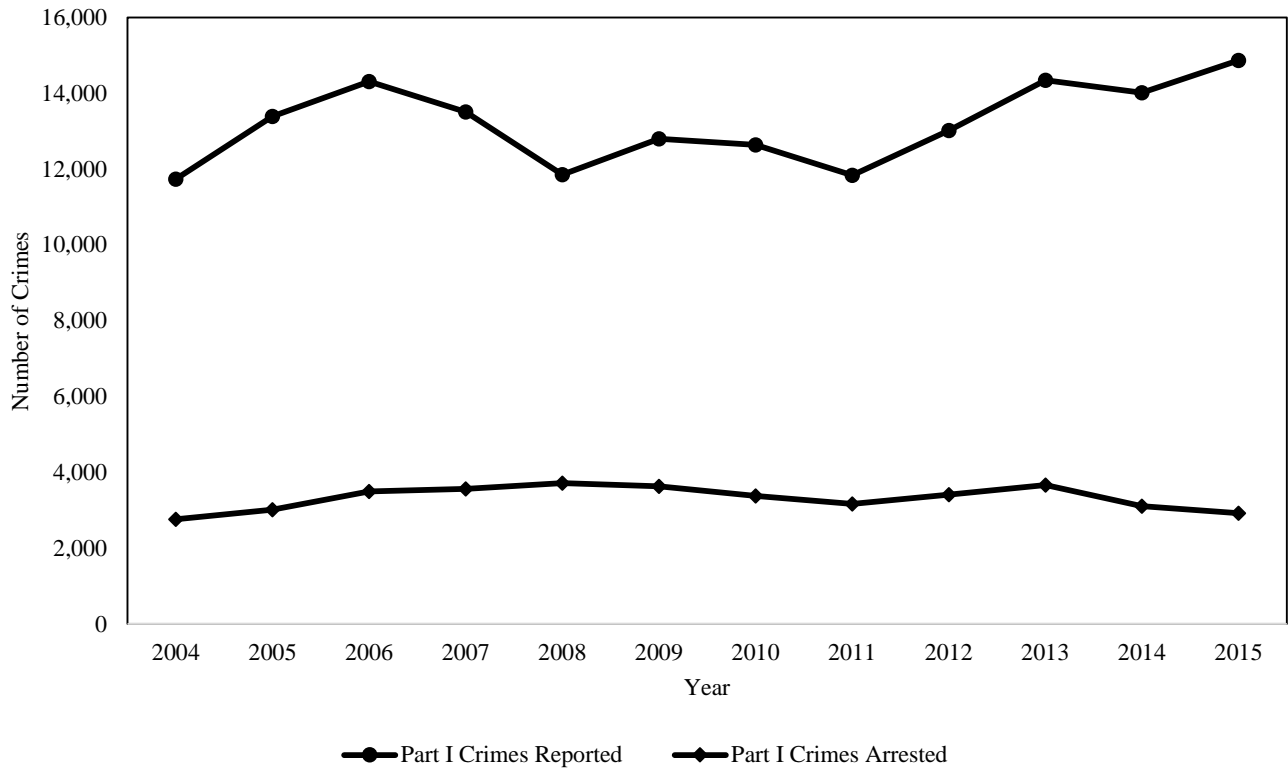

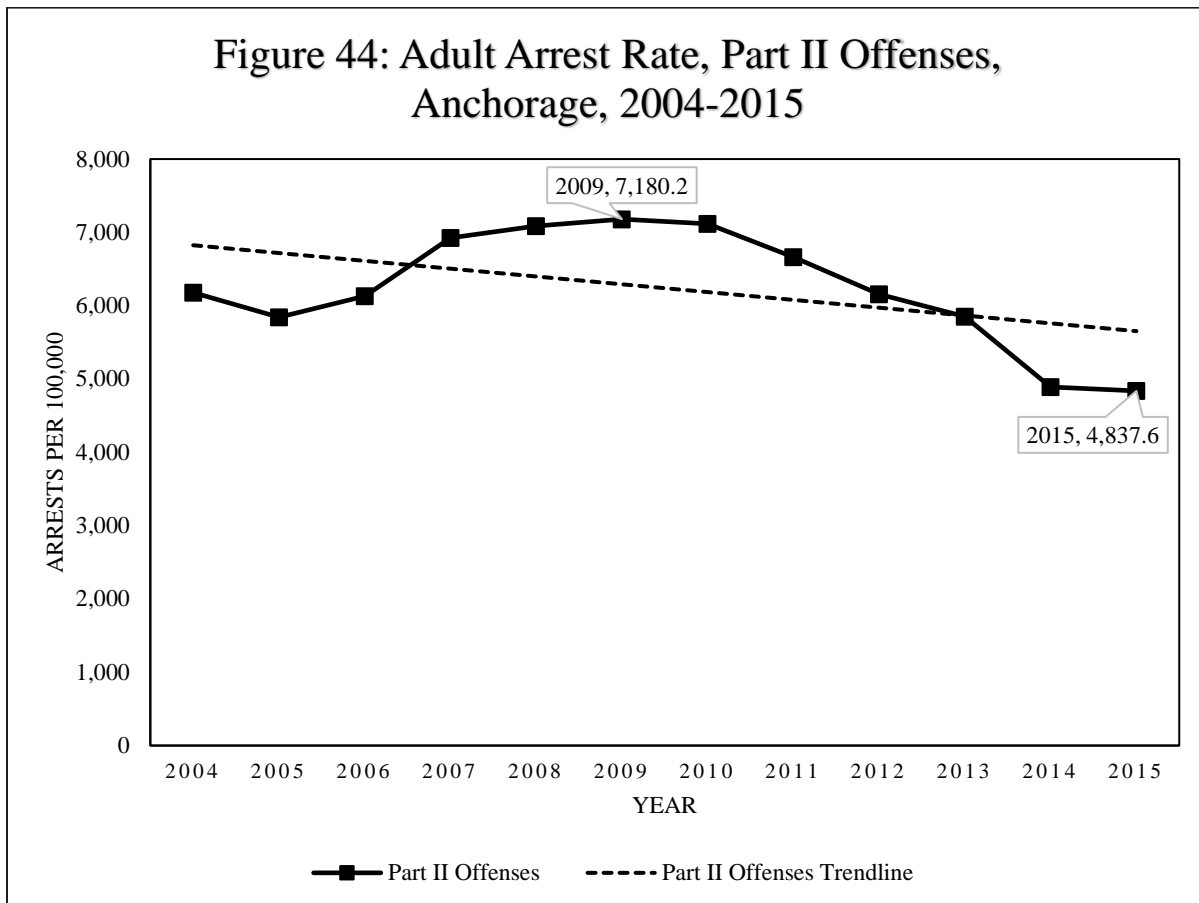
C. Part II Arrests for Anchorage

Figure 44 shows a decreasing trend in the adult arrest rate for Part II offenses for Anchorage between 2004 and 2015. The highest rate of Part II arrests during that time period was in 2009 (7,180.2 arrests per 100,000) and the lowest rate of arrests was in 2015 (4,837.6 arrests per 100,000).

Figures 45-56, 58-63, 67, and 69 show the number of adult arrests for each Part II offense for Anchorage between 2004 and 2015. The ten offenses with the highest volume of arrests in 2015 (excluding the 'All Other' offenses category) were as follows: other assaults (1,524 arrests; Figure 45), DUI (1,037 arrests, Figure 56), vandalism (419 arrests, Figure 50), drug possession (322 arrests, Figure 69), disorderly conduct (270 arrests, Figure 60), family/child (149 arrests, Figure 55), sex offenses (145 arrests, Figure 53), fraud (140 arrests, Figure 47), weapons (91 arrests, Figure 51), and drug sale/manufacturing (60 arrests, Figure 67). 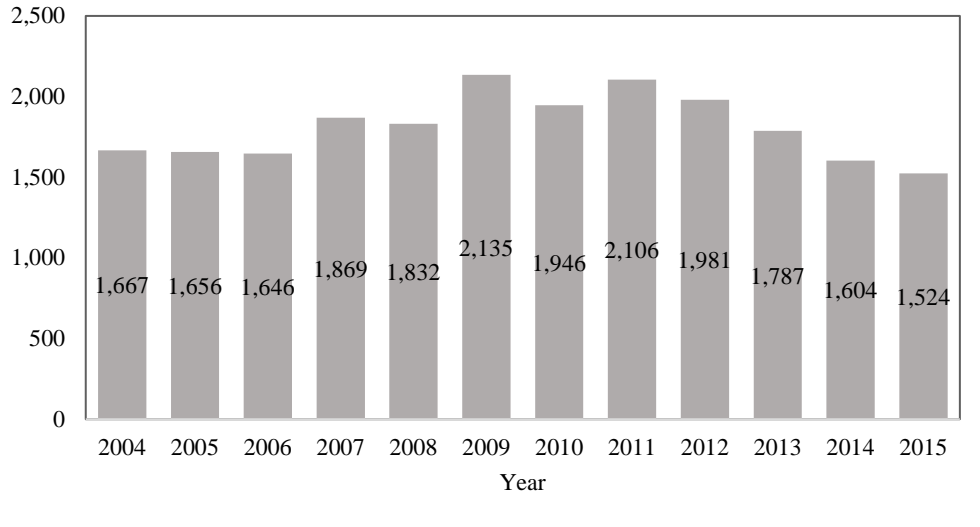

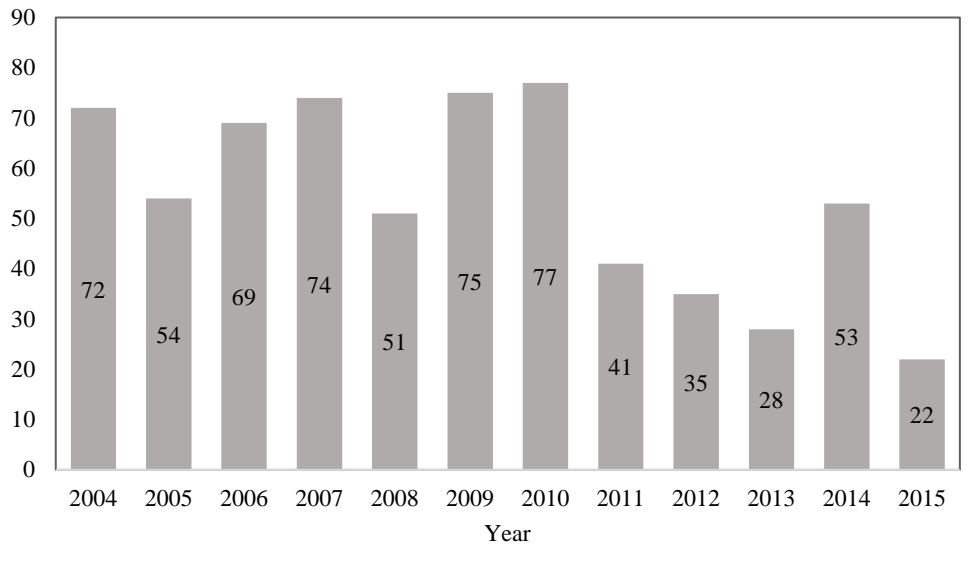

Anchorage, 2004-2015**



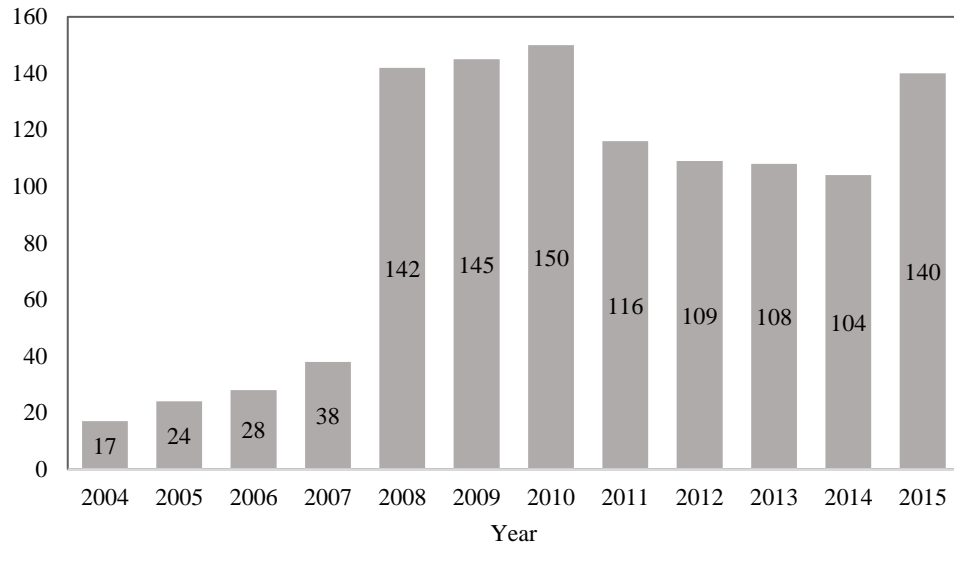

Anchorage, 2004-2015**



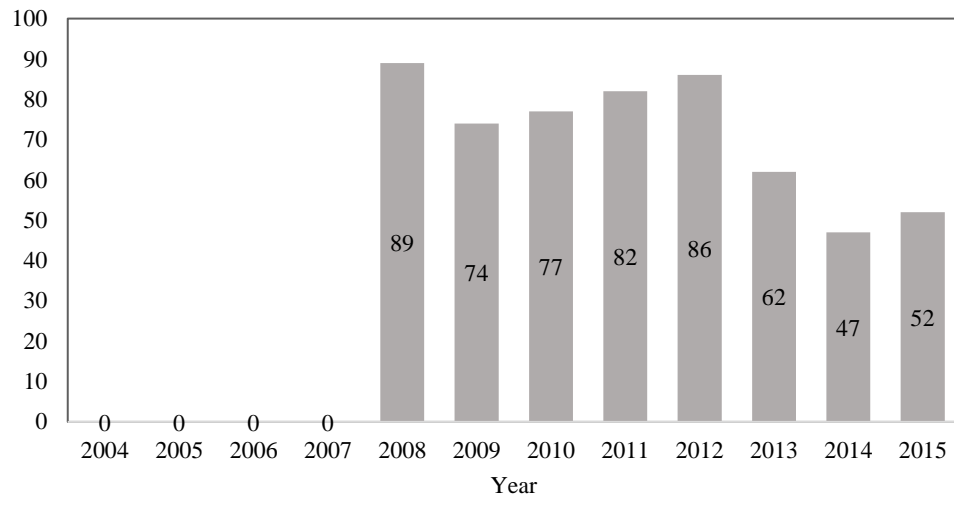

Figure 47: Number of Adult Arrests, Fraud, Anchorage, 2004-2015



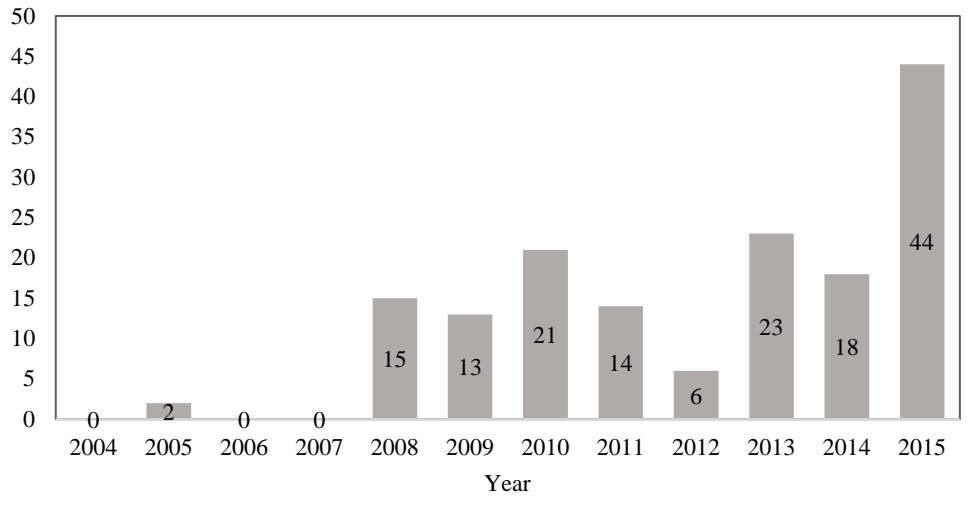

Figure 48: Number of Adult Arrests, Embezzlement, Anchorage, 2004-2015



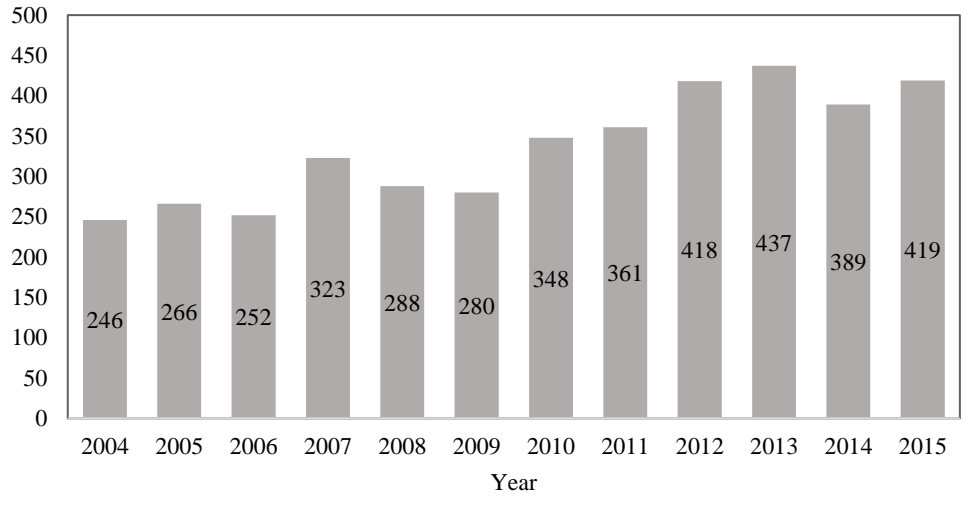

Anchorage, 2004-2015



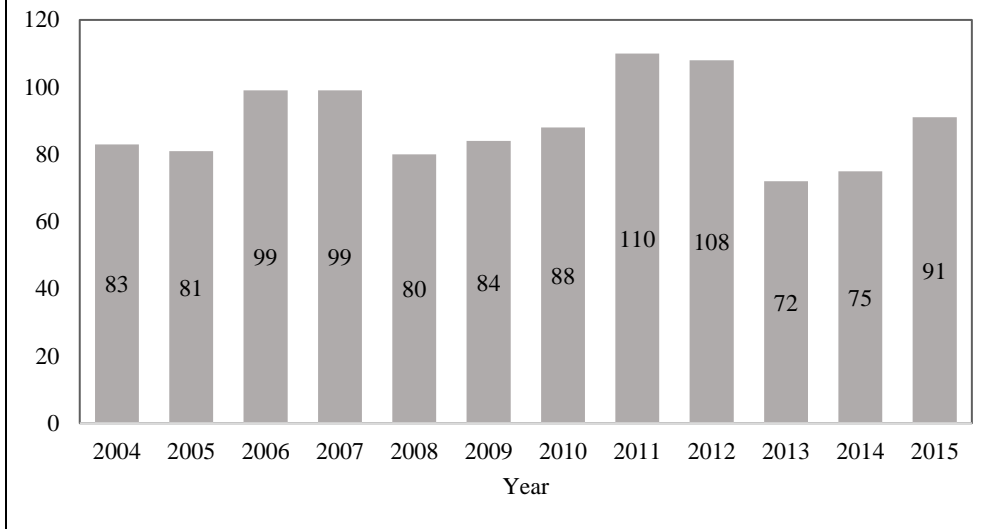

Anchorage, 2004-2015



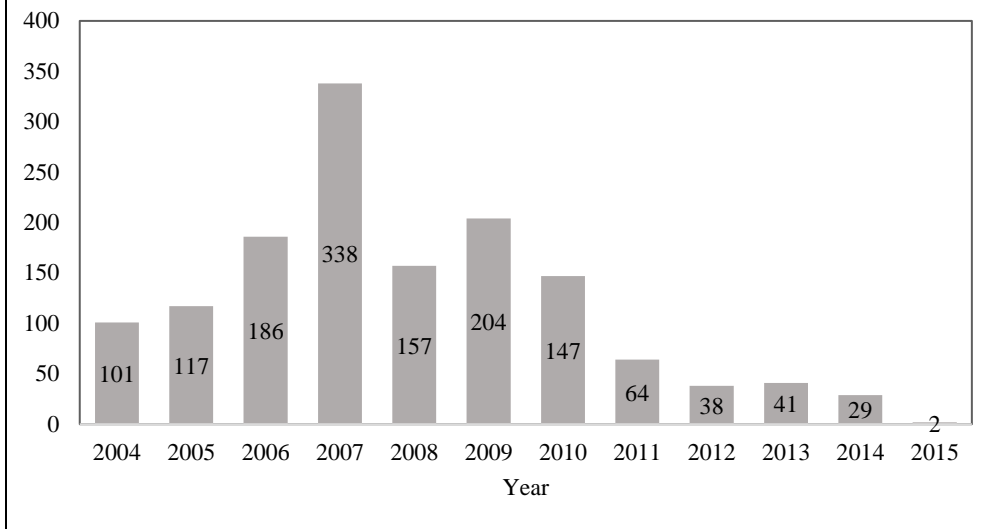

Anchorage, 2004-2015



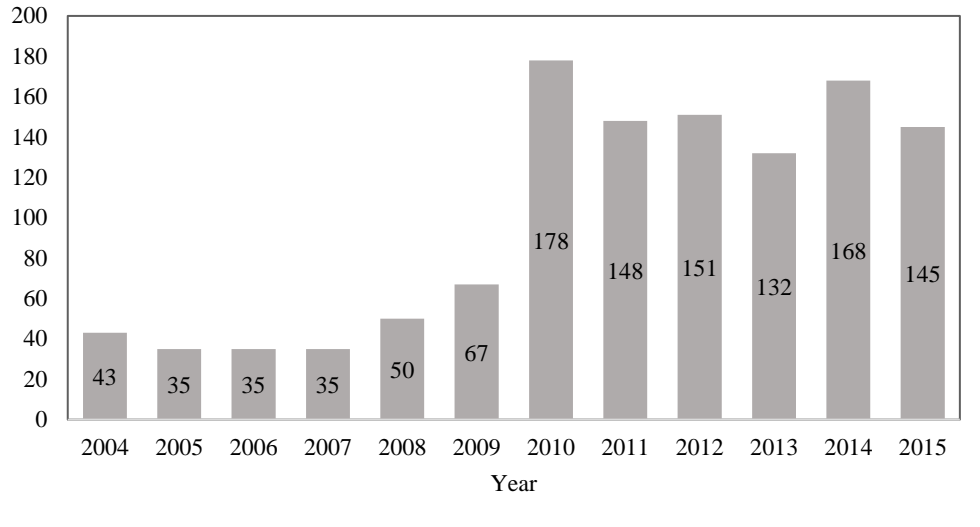

Anchorage, 2004-2015



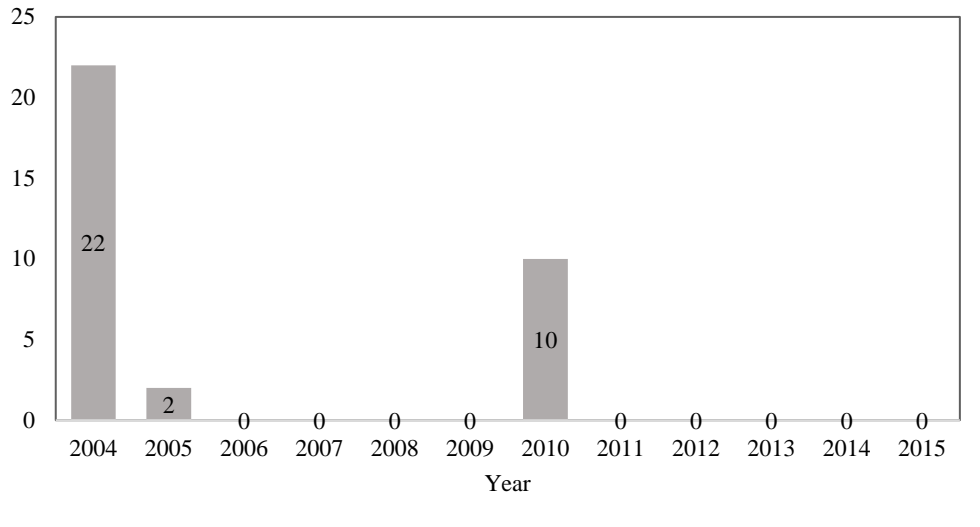

Anchorage, 2004-2015**



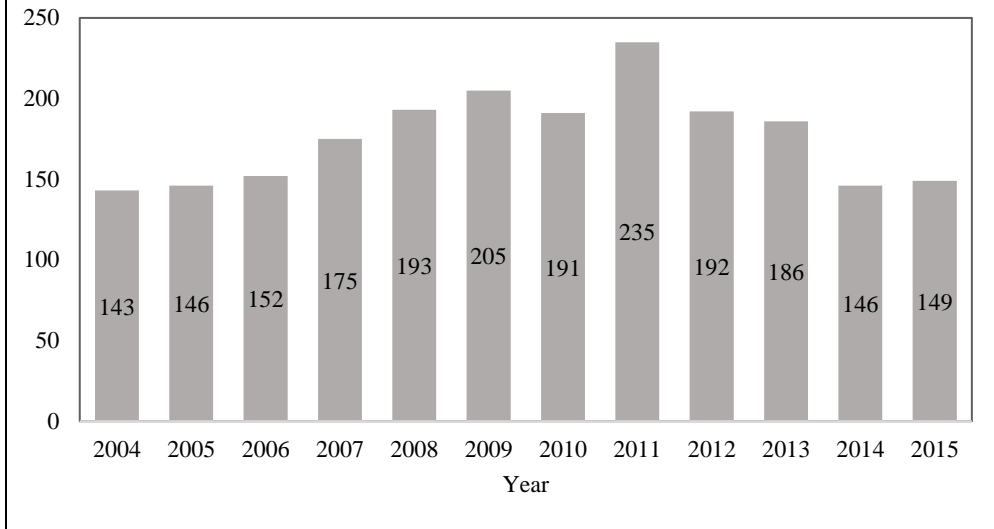

Anchorage, 2004-2015**



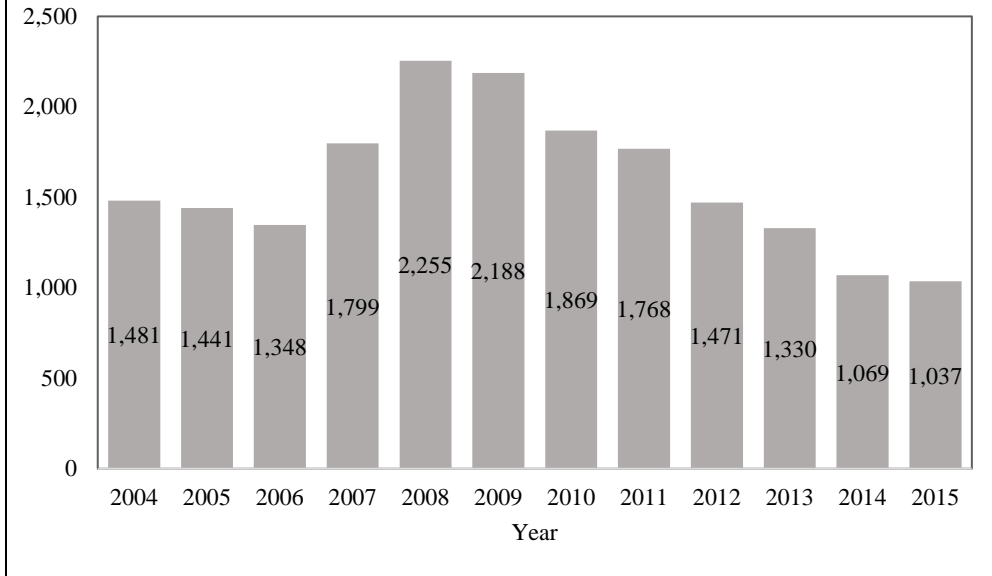

Anchorage, 2004-2015



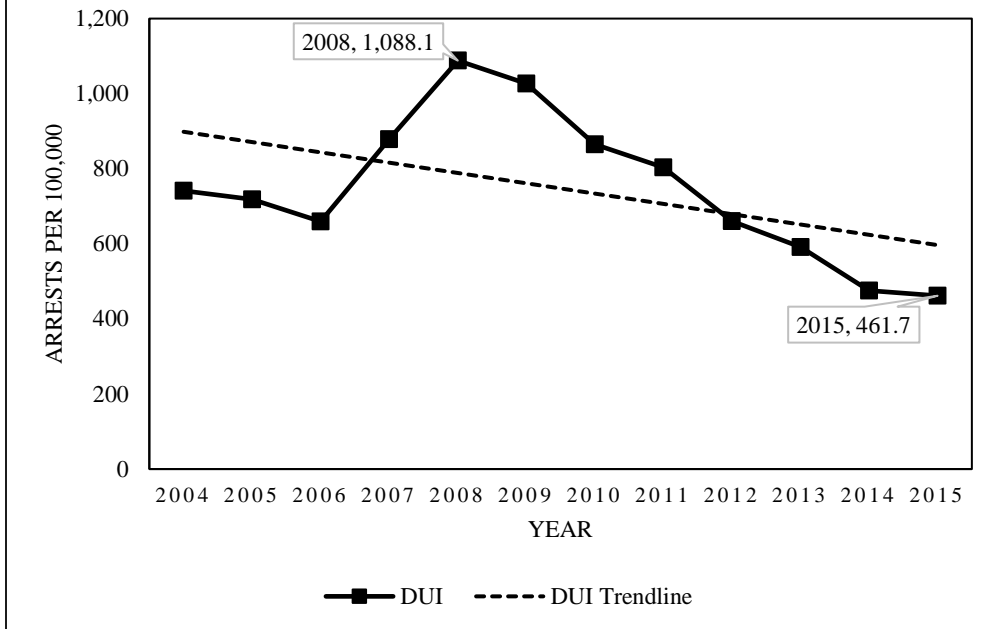

Figure 56: Number of Adult Arrests, DUI, Anchorage, 2004-2015



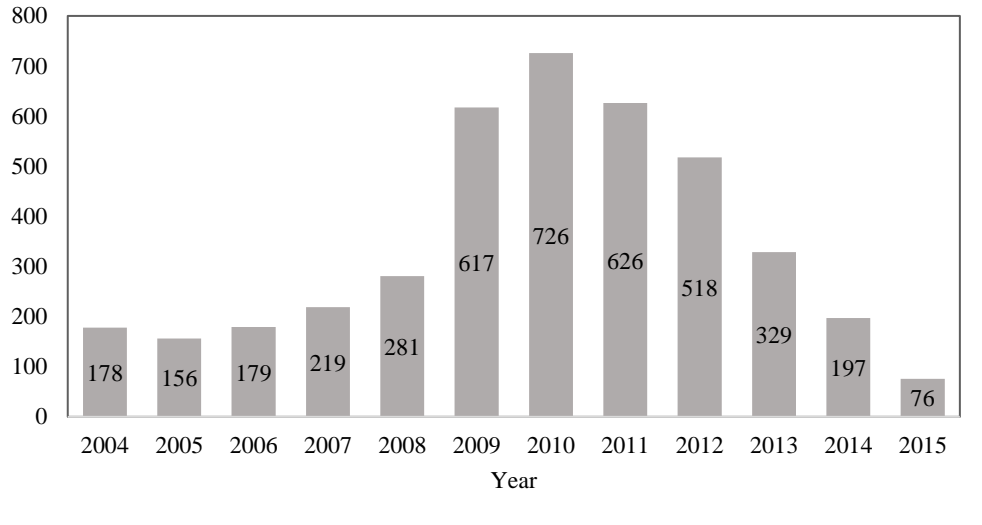

Figure 57: Adult Arrest Rate, DUI, Anchorage, 2004-2015



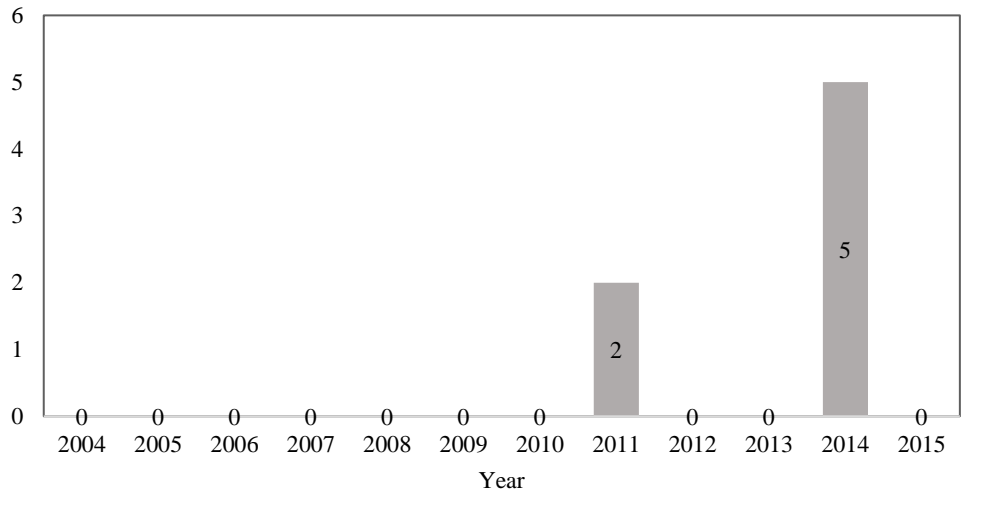

Anchorage, 2004-2015



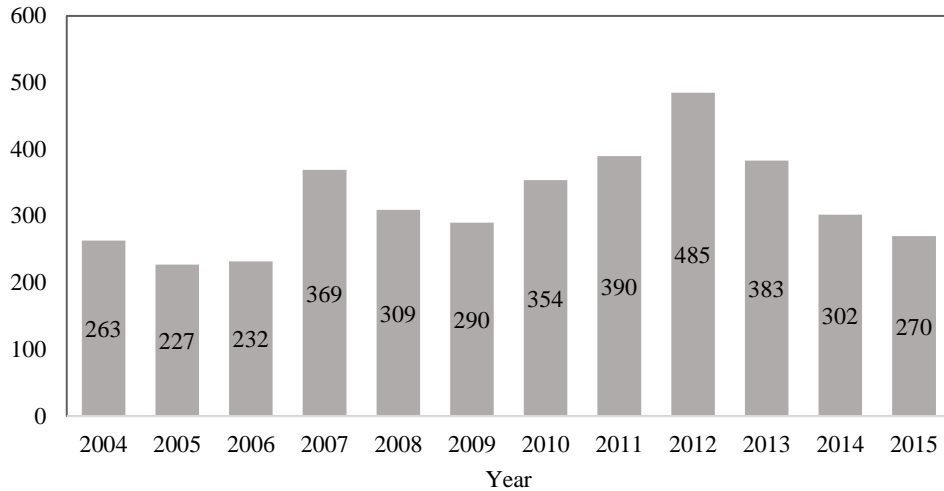

Anchorage, 2004-2015



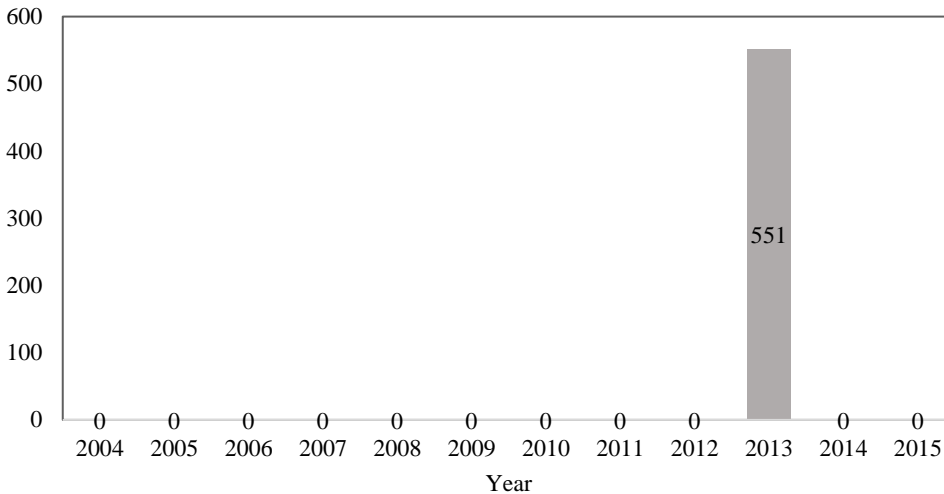

Anchorage, 2004-2015



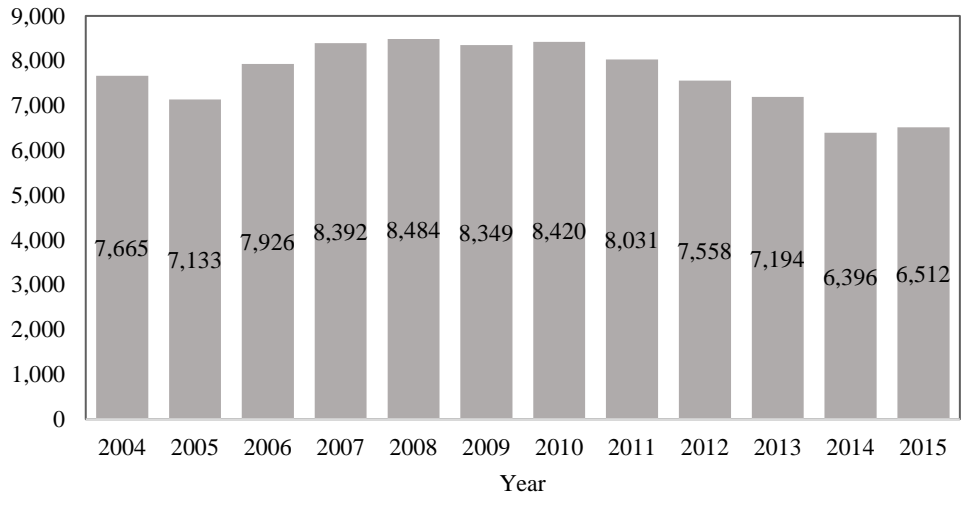

Anchorage, 2004-2015



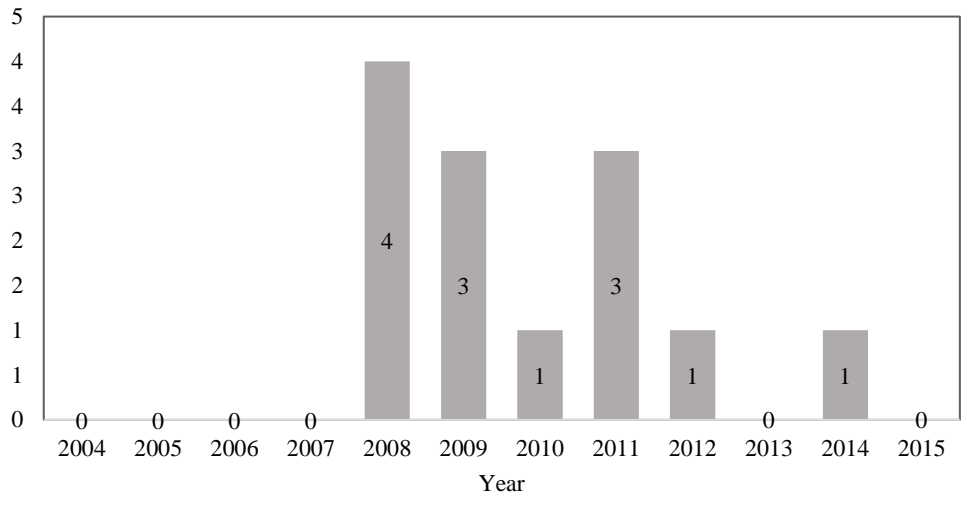

D. Drug Arrests for Anchorage

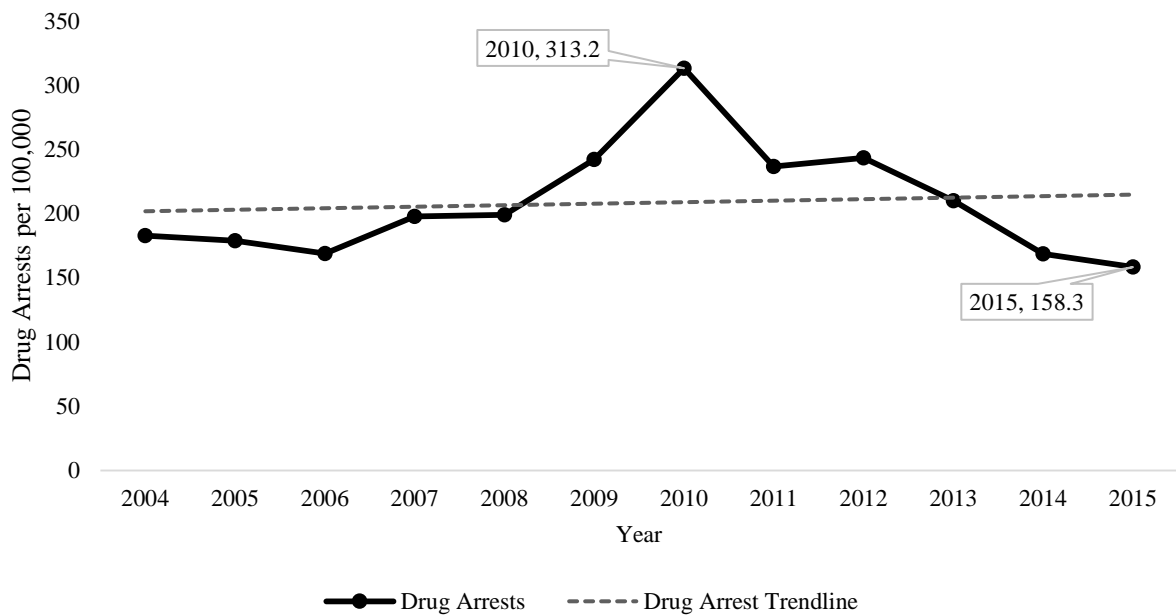
Figure 64: Number of Drug Arrests (Adult & Juvenile), Anchorage, 2004-2015

Tables 10-11 show the number of drug arrests and drug arrest rates for Anchorage between 2004 and 2015. The number of arrests are broken down by adult and juvenile. The arrest rates are broken down by adult and total arrests (adult plus juvenile). Figure 64 shows the highest number of drug arrests occurred in 2010 (914 arrests) and the lowest occurred in 2015 (473 arrests).

Figures 65 and 66 show the drug arrest rates for adults only and adults plus juveniles for Anchorage between 2004 and 2015. The highest rates for both groups occurred in 2010 and the lowest rates for both groups occurred in 2015.

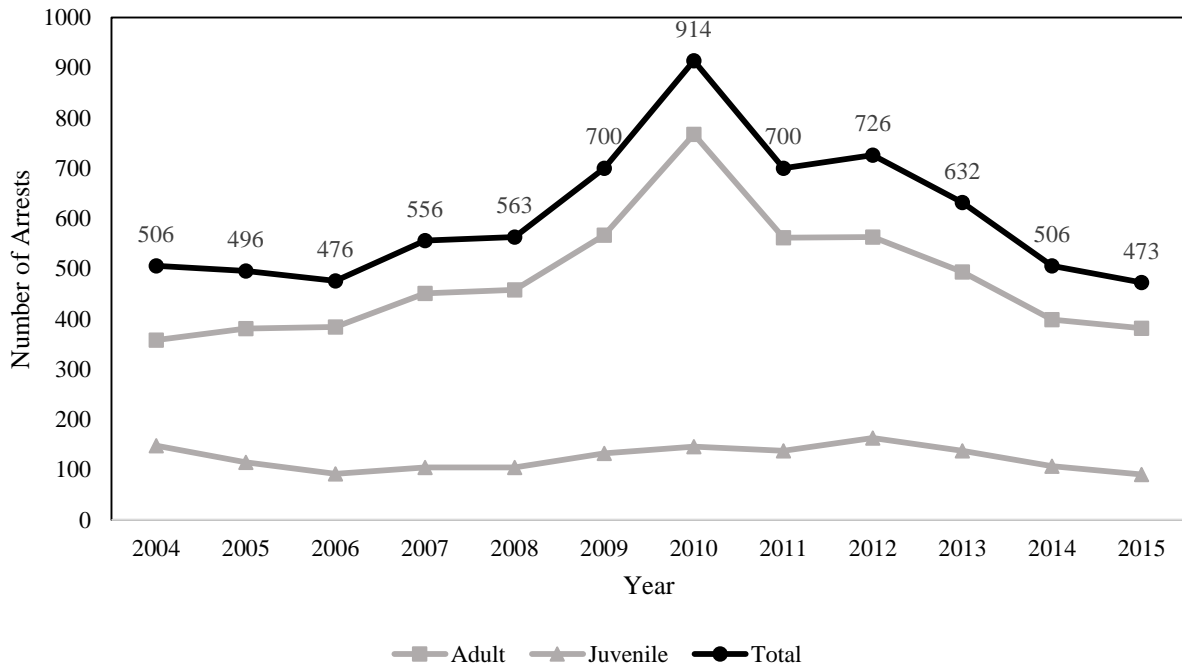

Rates per 100,000 persons



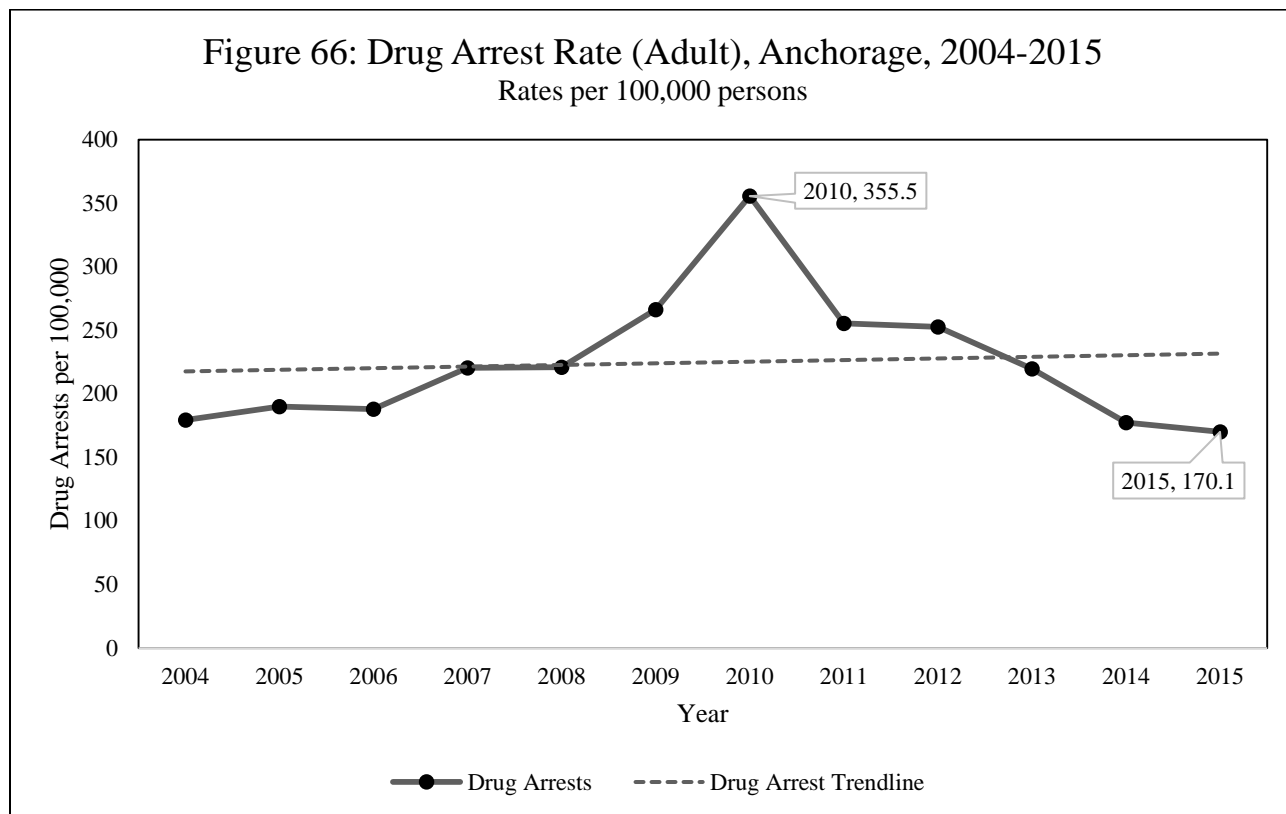

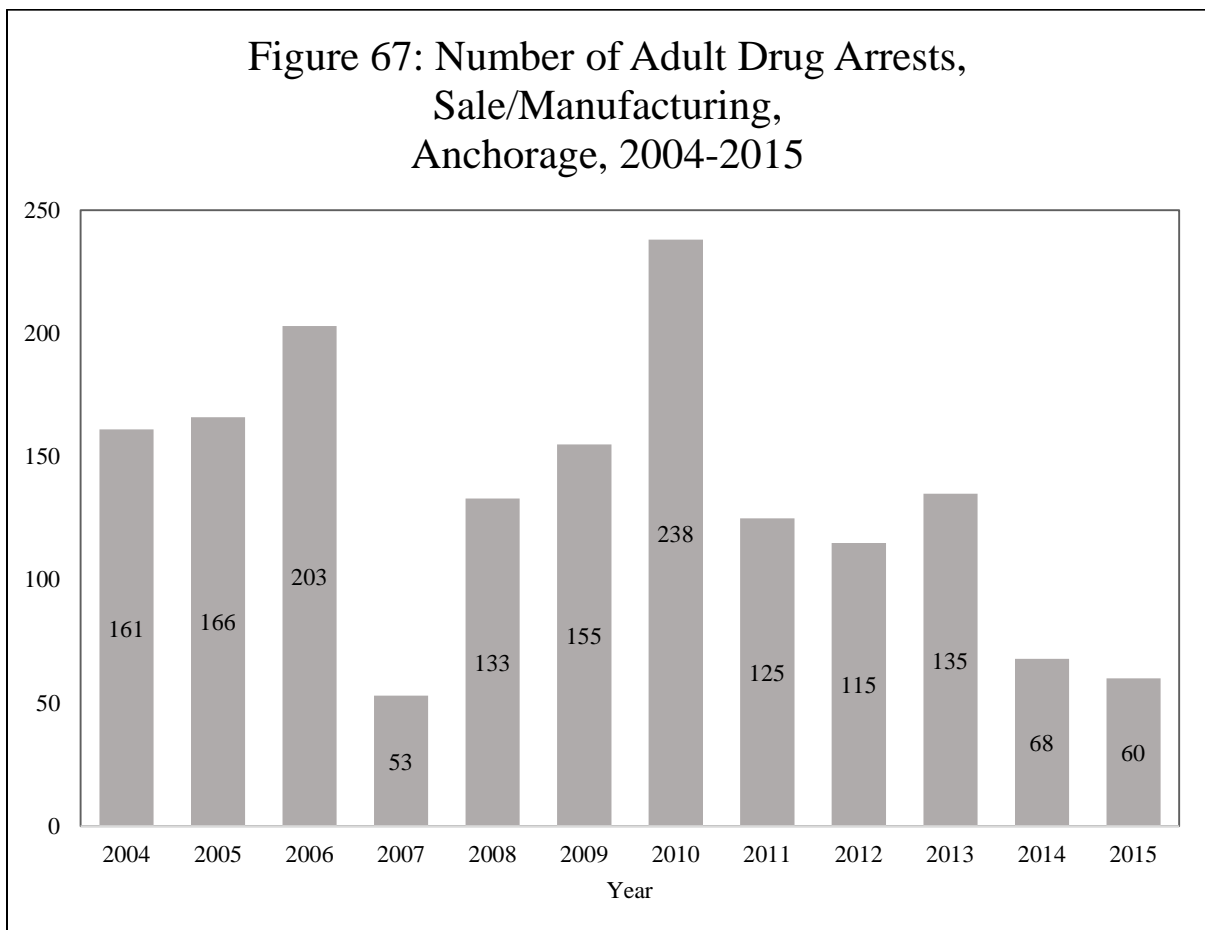

1. Adult Drug Arrests for Sale/Manufacturing for Anchorage

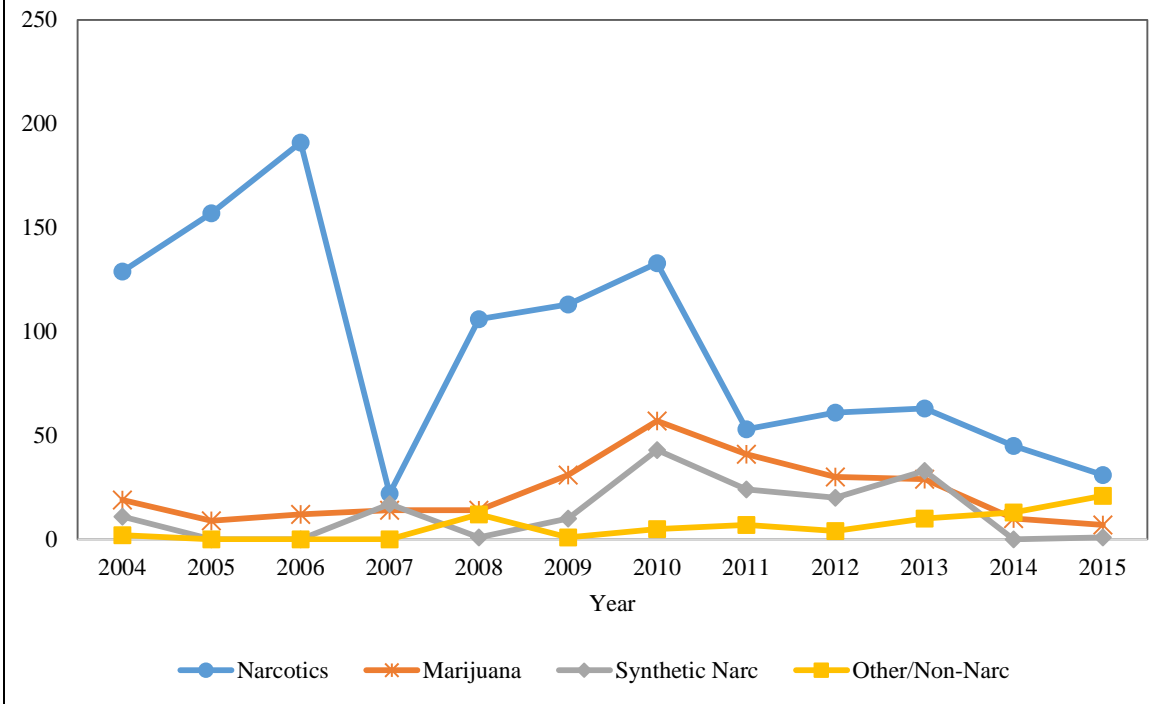
Figure 67 shows the highest number of adult arrests for the sale or manufacture of drugs in Anchorage occurred in 2010 (238 arrests) and the lowest amount of arrests occurred in 2007 (53 arrests). Figure 68 shows the number of sale/manufacturing drug arrests broken down by the type of drug (narcotics, marijuana, synthetic narcotics, and other/non-narcotics). Narcotics include opium or cocaine and their derivatives (morphine, heroin, codeine). Synthetic narcotics include manufactured narcotics which can cause drug addiction (demerol, methadone). Other/non-narcotics include dangerous nonnarcotic drugs (barbiturates, benzedrine). As shown in Figure 68, narcotics sale/manufacturing arrests spiked in 2006 (191 arrests) and 2010 (133 arrests), and since 2010 the number of arrests have fallen to 31 arrests in 2015. The number of arrests for marijuana sale/manufacturing were 57 in 2010 and fell to 7 arrests in 2015. The number of arrests for synthetic narcotics sale/manufacturing were 43 in 2010 and fell to 1 arrest in 2015. The number of arrests for the sale/manufacture of other/non-narcotics was 2 in 2004 and has risen to 21 arrests in 2015.

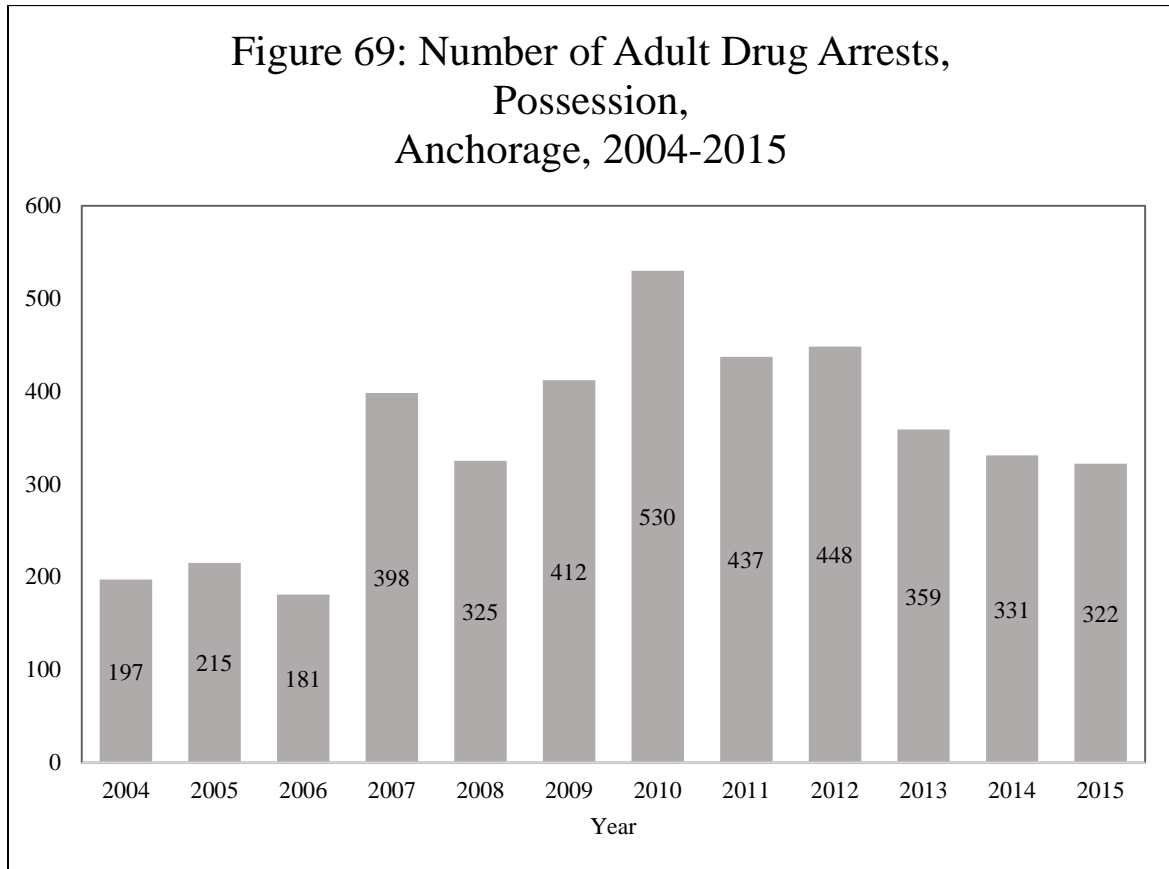
Figure 68: Number of Adult Drug Arrests,

2. Adult Drug Arrests for Possession for Anchorage

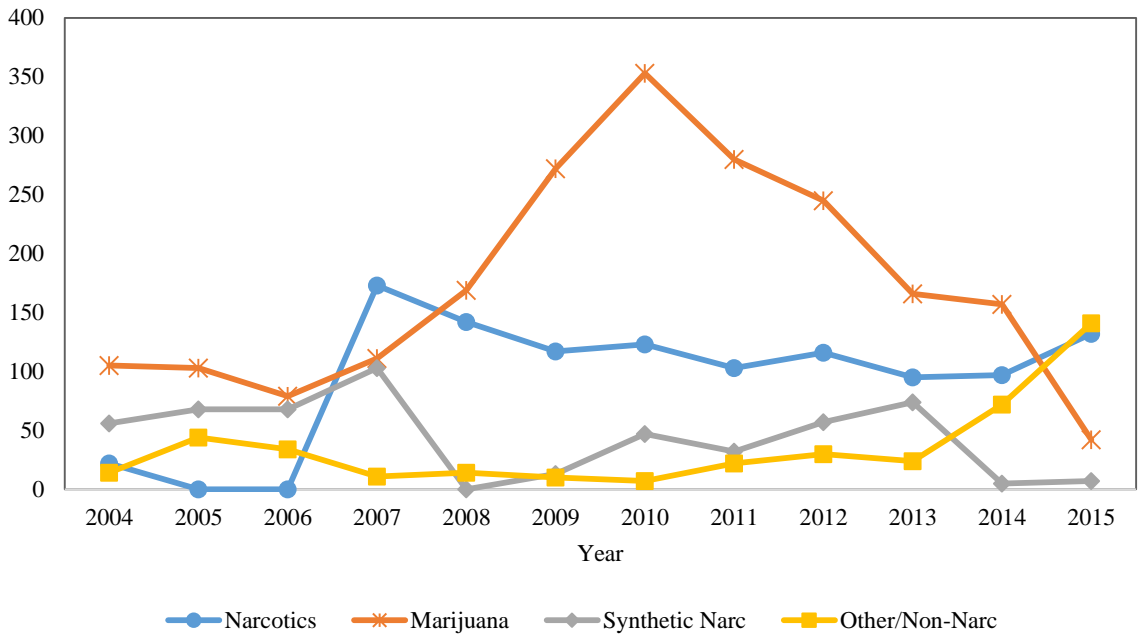
Figure 69 shows that between 2004 and 2015, the number of adult drug arrests for possession peaked in 2010 at 530 arrests and has since fallen to 322 arrests in 2015. Figure 70 shows the number of arrests for narcotics possession was 22 in 2004, peaked at 173 arrests in 2007 and fell slightly to 132 arrests in 2015. Marijuana possession arrests peaked in 2010 at 353 arrests and has fallen to 42 arrests in 2015. The number of arrests for synthetic narcotics possession peaked in 2007 at 103 arrests and has fallen to 7 arrests in 2015. The number of arrests for other/non-narcotics possession grew from 14 arrests in 2004 to 141 arrests in 2015.

Part 4: Police Officers

Tables 12-13 and Figures 71-74 show the number of police officers and rates of police officers per 1,000 persons for Anchorage and Alaska between 2004 and 2015. The UCR program advises readers should use caution when drawing comparisons between agencies based on staffing levels due to the variations between jurisdictions and agency functions.

A. Number and Rates of Police Officers for Alaska

Table 12 and Figure 71 show the number of police officers for Alaska between 2004 and 2015. The highest number of police officers during that time was in 2013 (1,331 officers) and the lowest was in 2005 (1,176 officers). Figure 72 shows the rates of police officers per 1,000 persons. The highest number of officers per capita was in 2004 (1.84 per 1,000) and the lowest was in 2015 (1.72 per 1,000). The rate of police officers decreased 8.9% between 2004 (1.84 officers per 1,000 persons) and 2015 (1.72 officers per 1,000 persons).

B. Number and Rates of Police Officers for Anchorage

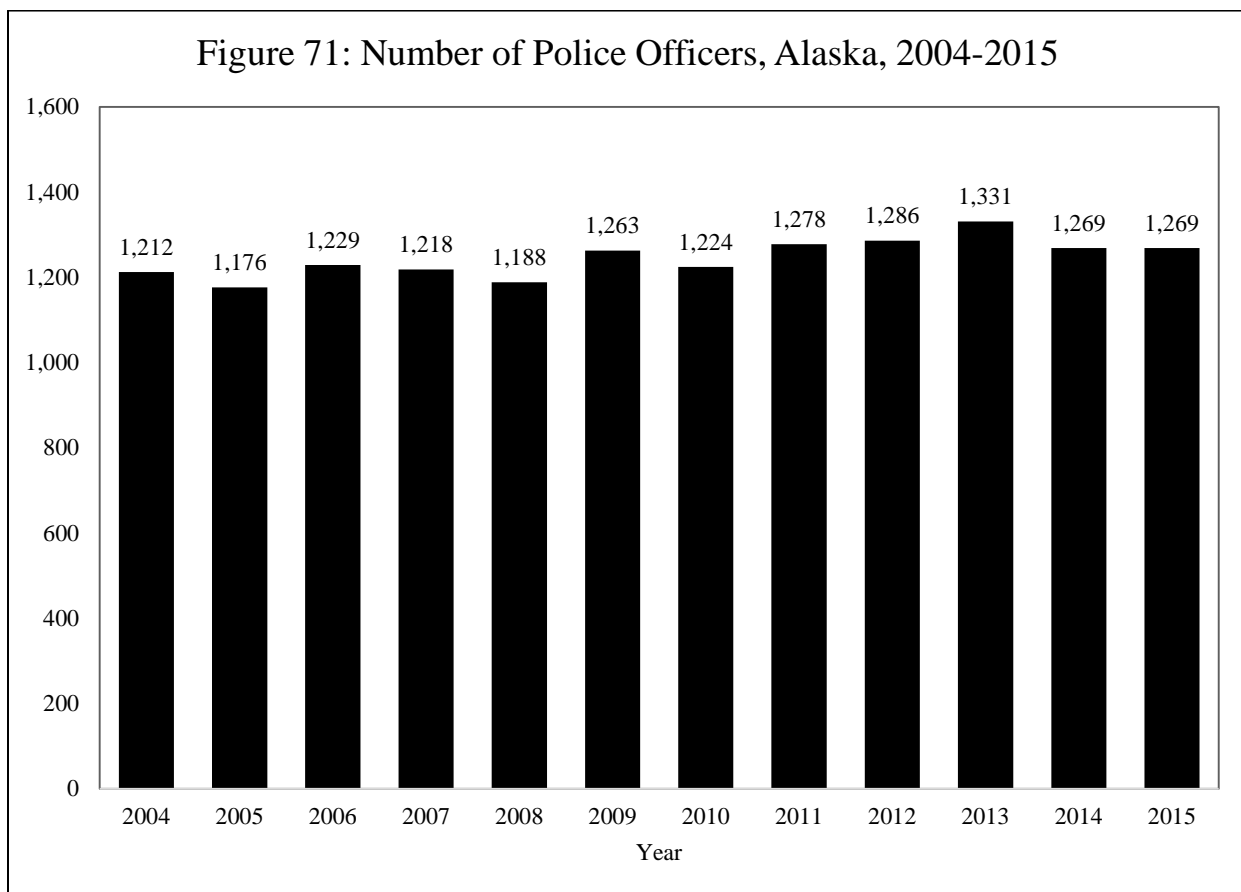
Table 13 and Figure 73 show the number of police officers for Anchorage between 2004 and 2015. The highest number of police officers during that time was in 2011 (390 officers) and the lowest was in 2013 (344 officers). Figure 74 shows the rates of police officers per 1,000 persons. In 2004, there were 1.25 officers per 1,000 persons and in 2015 there were 1.21 officers per 1,000 persons. The rate of police officers peaked at 1.35 officers per 1,000 persons in 2008 and the police officer rate declined 10.6% between 2008 and 2015.

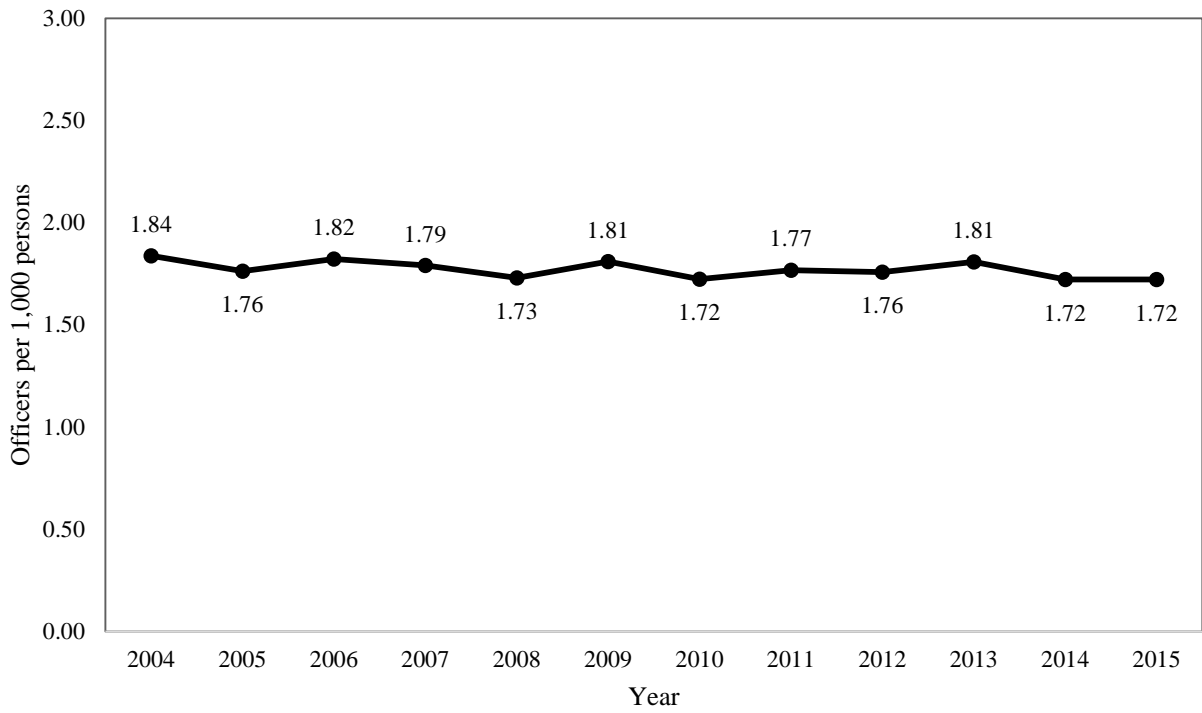

(Rates per 1,000 persons)



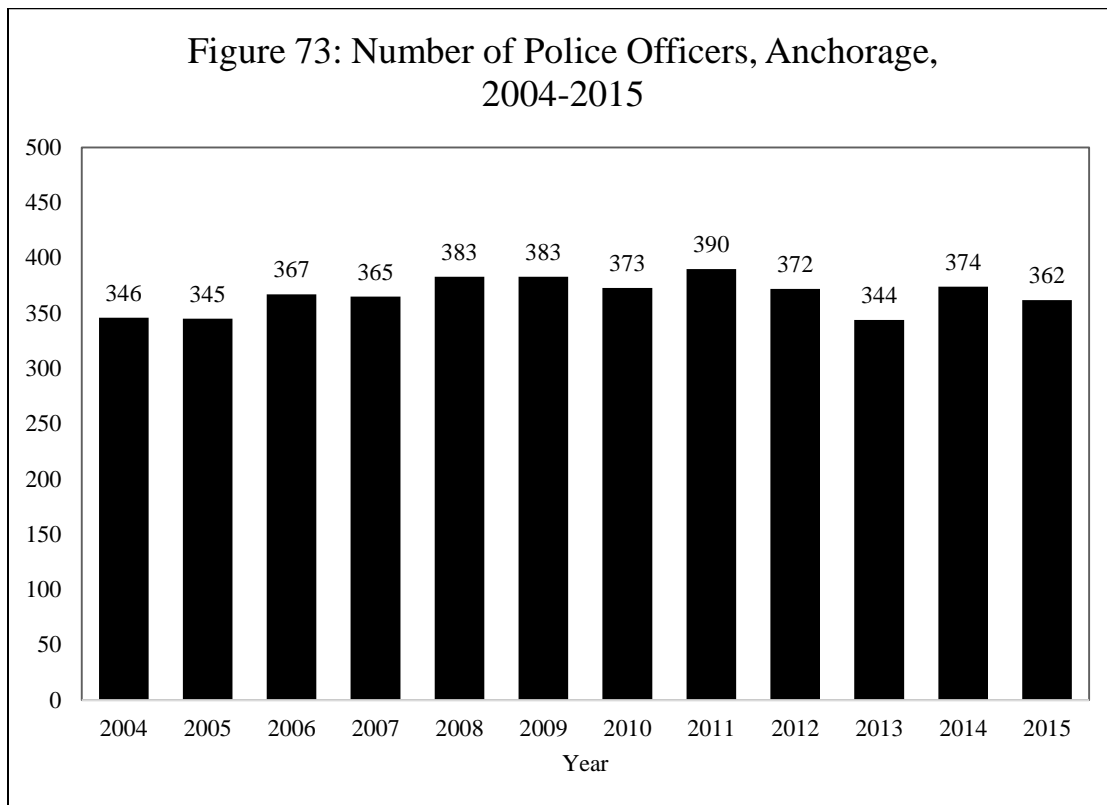

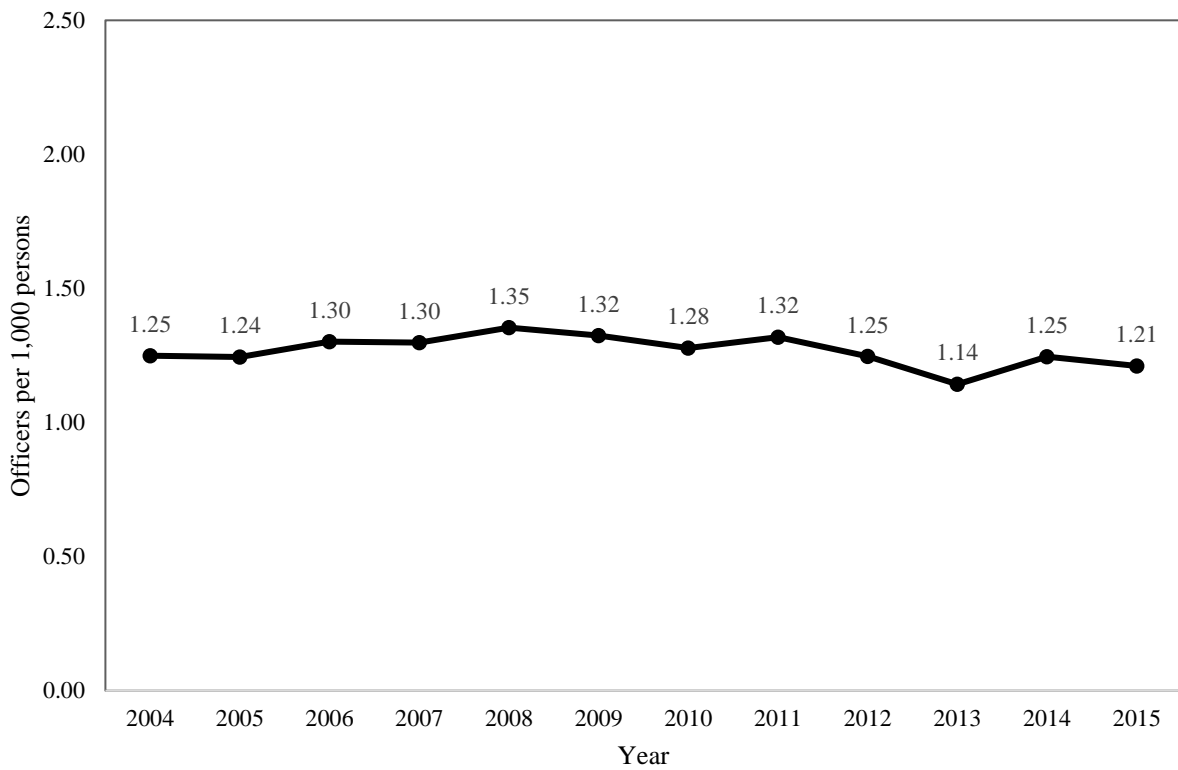

Tables 14-23 and Figures 75-98 show the number and rates of felony and misdemeanor case filings for Alaska and Anchorage between FY04 and FY15.

A. Felony Case filings

Tables 14-17 and Figures 75-84 show the number of felony filings for Alaska and Anchorage between FY04 and FY15. Felony filings are broken down by person, property, drugs, and motor vehicle case types. Person case types include homicide, assault, reckless endangerment, kidnapping, custodial interference, human trafficking, sex offenses, robbery, extortion, and coercion. Property case types include theft, burglary, criminal trespass, vehicle theft, arson criminal mischief, and business and commercial offenses. Drug case types include misconduct involving a controlled substance; manufacture, delivery, or possession of imitation controlled substance¹. Motor vehicle case types include motor vehicle DUI, motor vehicle reckless driving, and motor vehicle other. Case types for public order, fish and game, and other are not separated out by category, but are included in the total number of felony filings.

1. Felony Case Filings for Alaska

Table 14 and Figures 75-79 show the number of felony case filings for Alaska overall and by case type for FY04 to FY15.

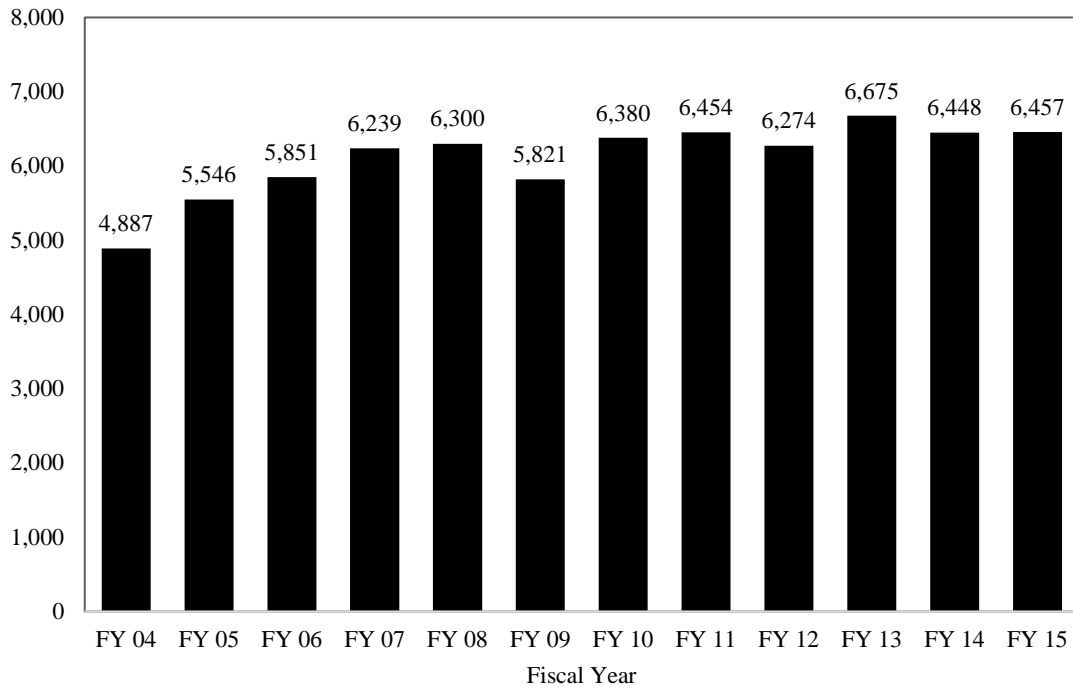

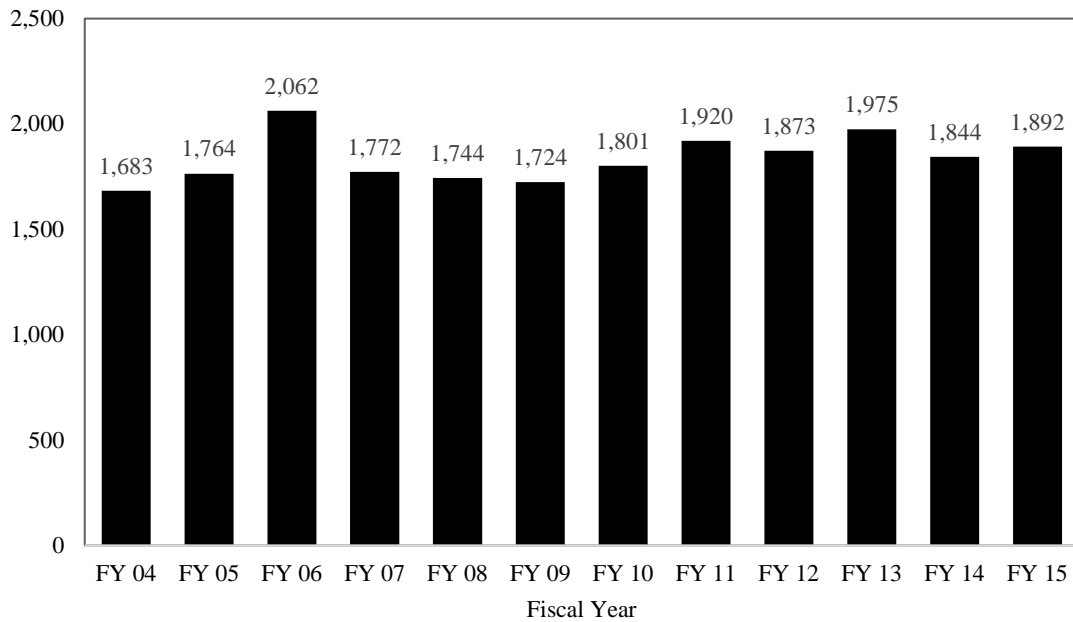

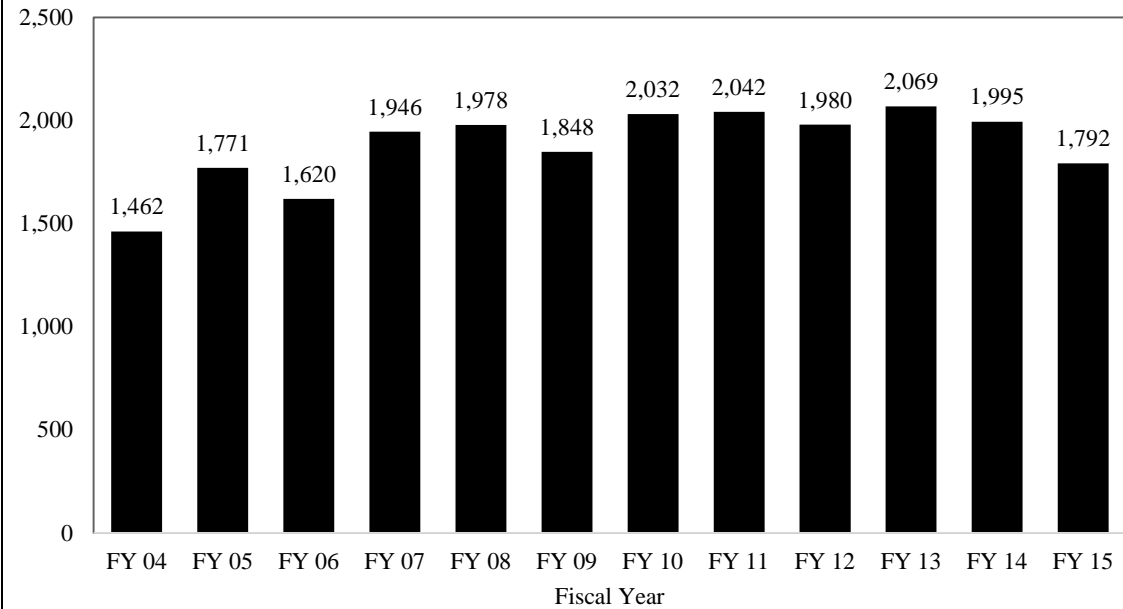
Figure 76: Number of Felony Filings, Person, Alaska, FY04-FY15

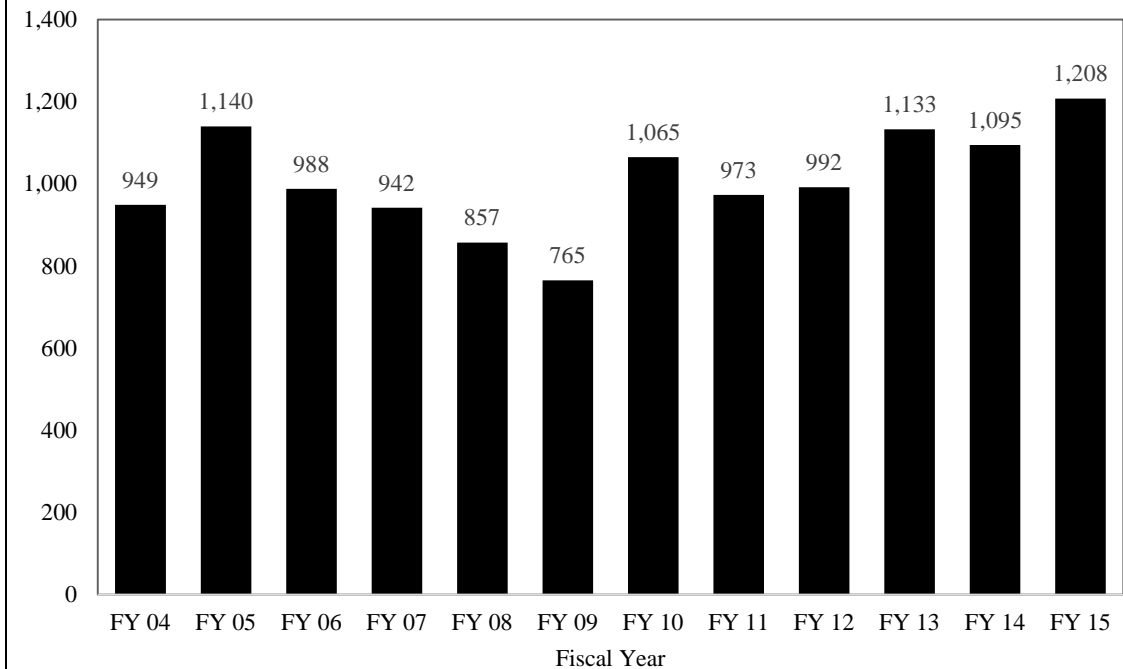
Figure 77: Number of Felony Filings, Property, Alaska, FY04-FY15

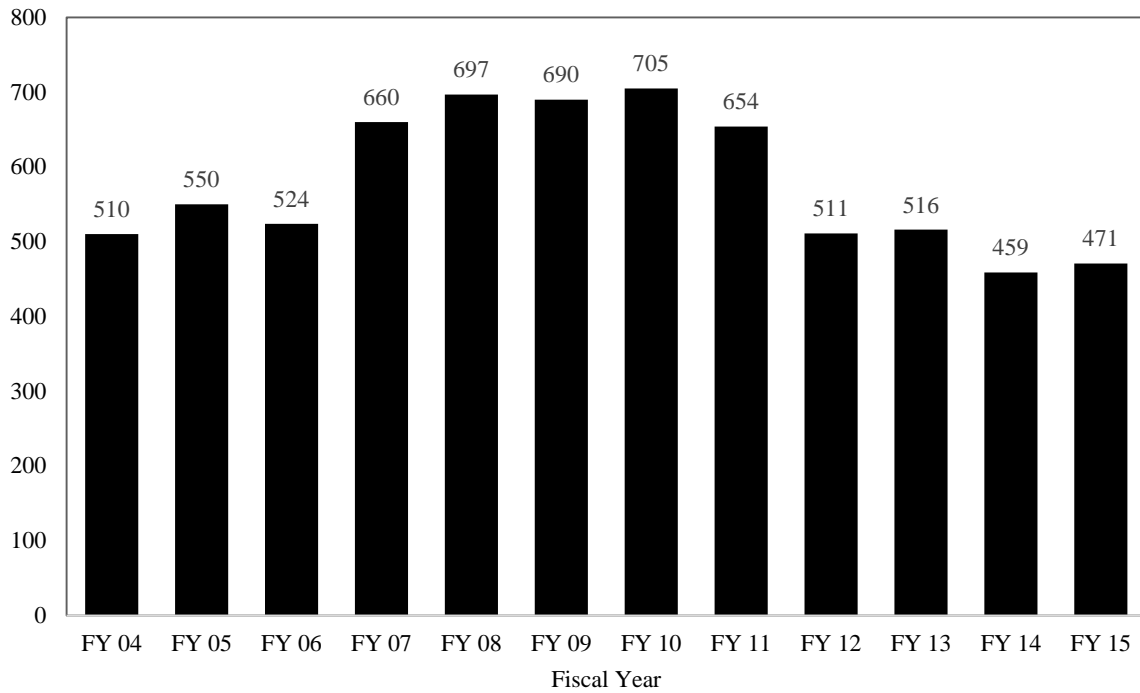
Figure 78: Number of Felony Filings, Drugs, Alaska, FY04-FY15

Table 15 and Figures 80-84 shows the rates of felony case filings for Alaska overall and by case type for FY04 to FY15. Rates are calculated per 100,000 persons using population estimates for adults aged 18 and older. Table 16 shows the percentage change in filing rates for 2, 5, 10, and 12 years.

- There was an increasing trend for overall felony filing rates in Alaska between FY04 and FY15. The percentage change in felony filing rates between FY04 and FY15 was 13.5%. The highest rate of overall felony case filings during the time period occurred in FY07 (1,263.0 per 100,000) and the lowest occurred in FY04 (1,036.3 per 100,000).
- There was a decreasing trend for person felony filings rates during the time period. The percentage change between FY04 and FY15 for person felony filings in Alaska was -3.4%. The highest rate of person felony filings occurred in FY06 (422.8 per 100,000) and lowest occurred in FY14 (336.5 per 100,000).
- There was an increasing trend for property felony filing rates in Alaska between FY04 and FY15. The percentage change between FY04 and FY15 was 5.3%. The highest rate of property felony filings occurred in FY08 (394.6 per 100,000) and the lowest occurred in FY04 (310.0 per 100,000).
- There was a decreasing trend for drug felony filing rates in Alaska between FY04 and FY15. However, there was a percentage increase of 9.3% between FY04 and FY15. The highest rate of drug felony filings occurred in FY05 (237.6 per 100,000) and the lowest occurred in FY08 (171.0 per 100,000).
- There was a decreasing trend for motor vehicle felony filing rates in Alaska between FY04 and FY15. The percentage change between FY04 and FY15 was -20.7%. The highest rate of motor vehicle felony filings occurred in FY08 (139.0 per 100,000) and the lowest occurred in FY14 (83.8 per 100,000).

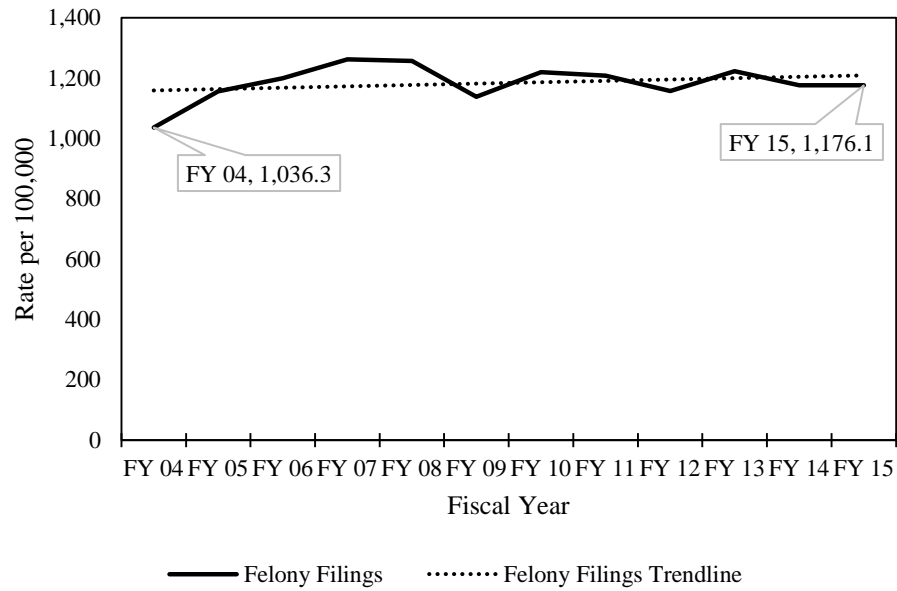

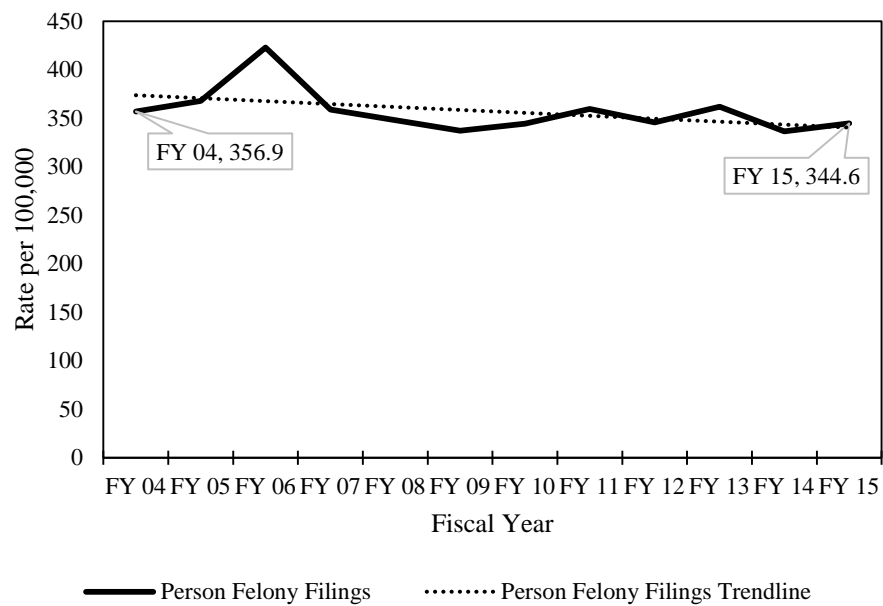

Figure 80: Felony Filing Rates, Alaska, FY04-FY15



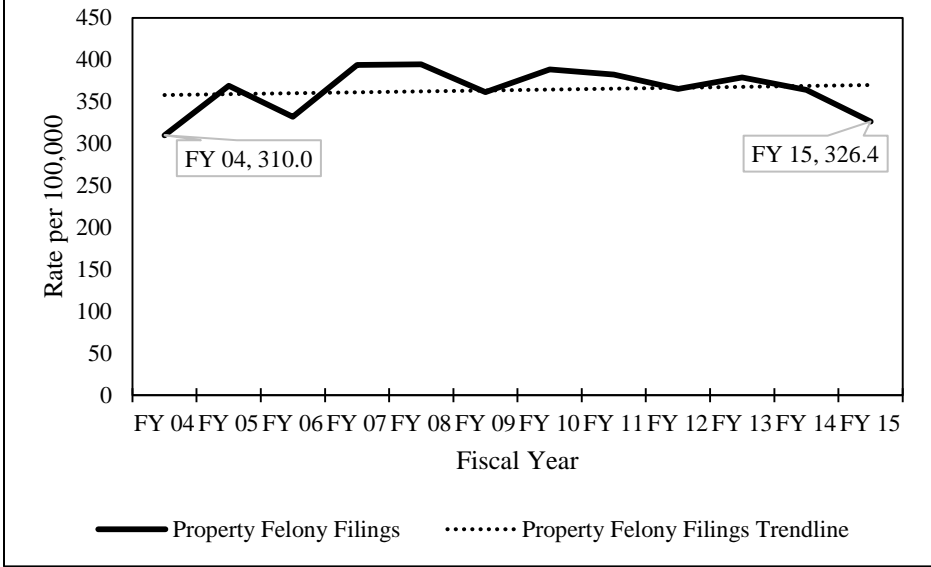

Figure 81: Person Felony Filing Rates, Alaska, FY04-FY15



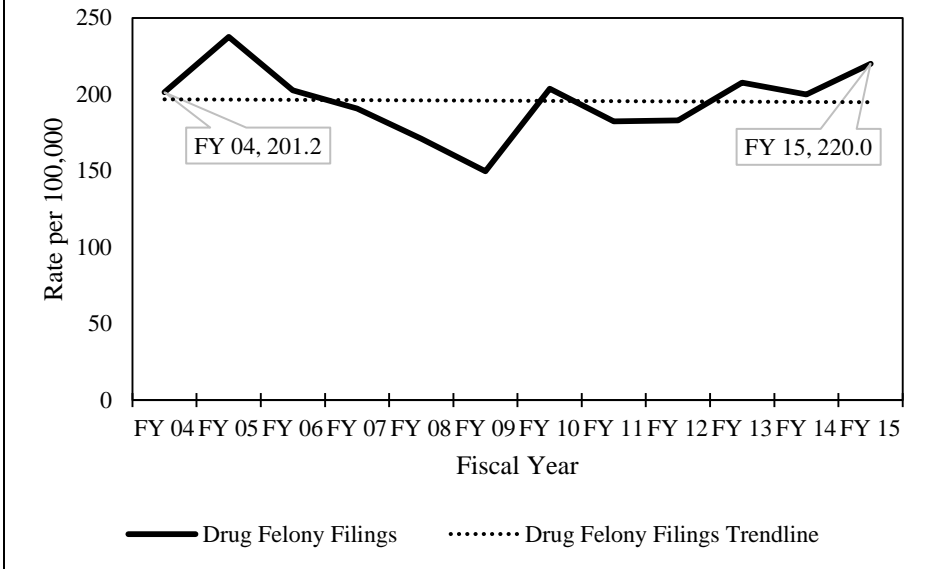

Figure 82: Property Felony Filing Rates, Alaska, FY04-FY15



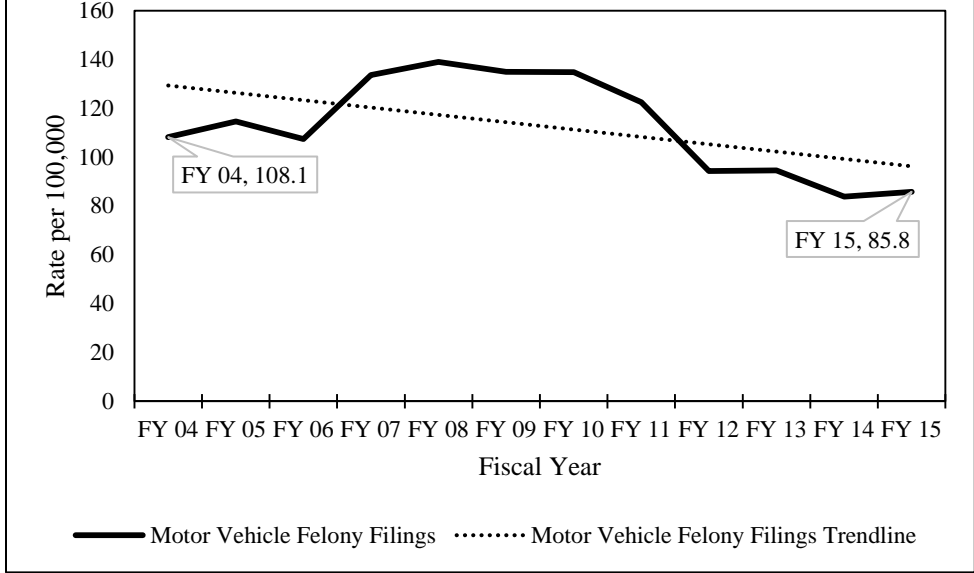

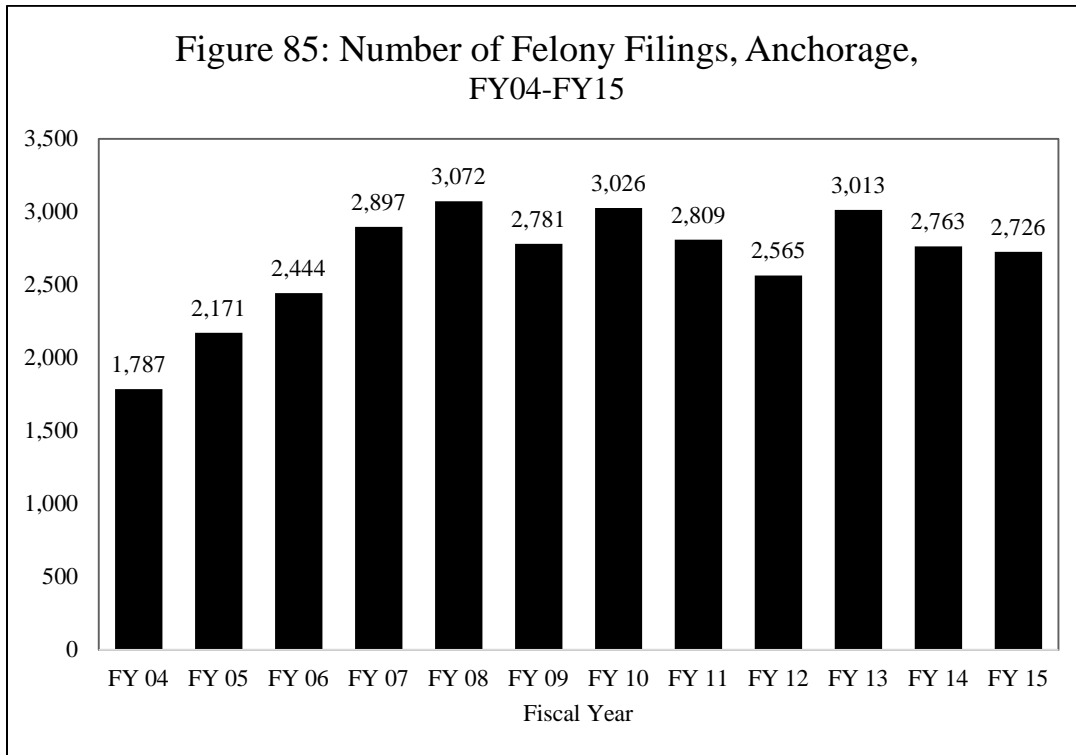

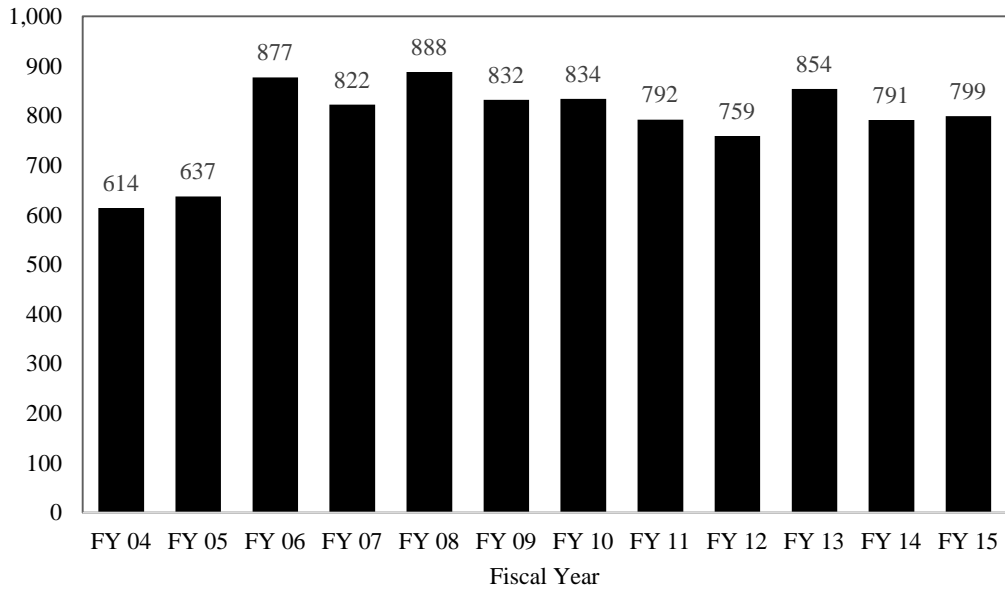

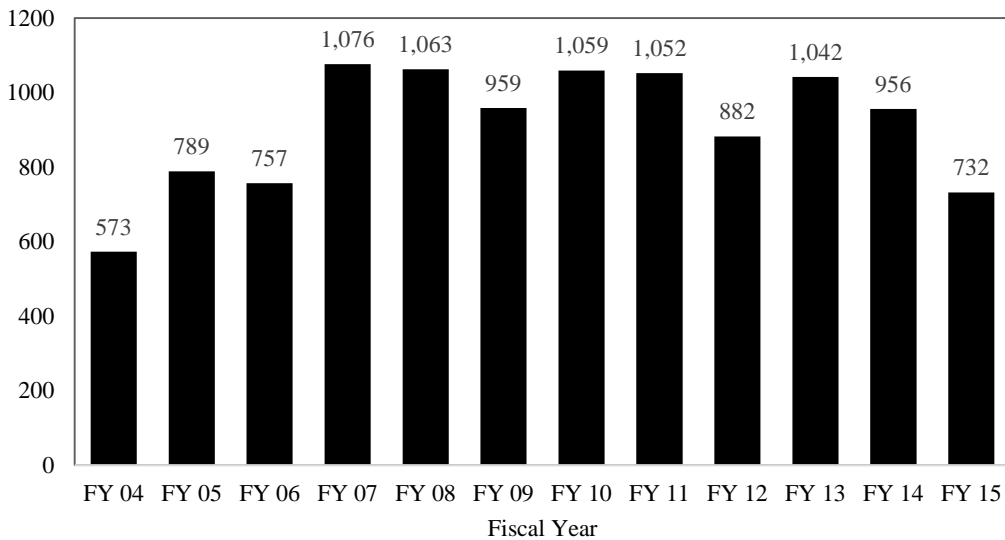
Figure 86: Number of Felony Filings, Person,

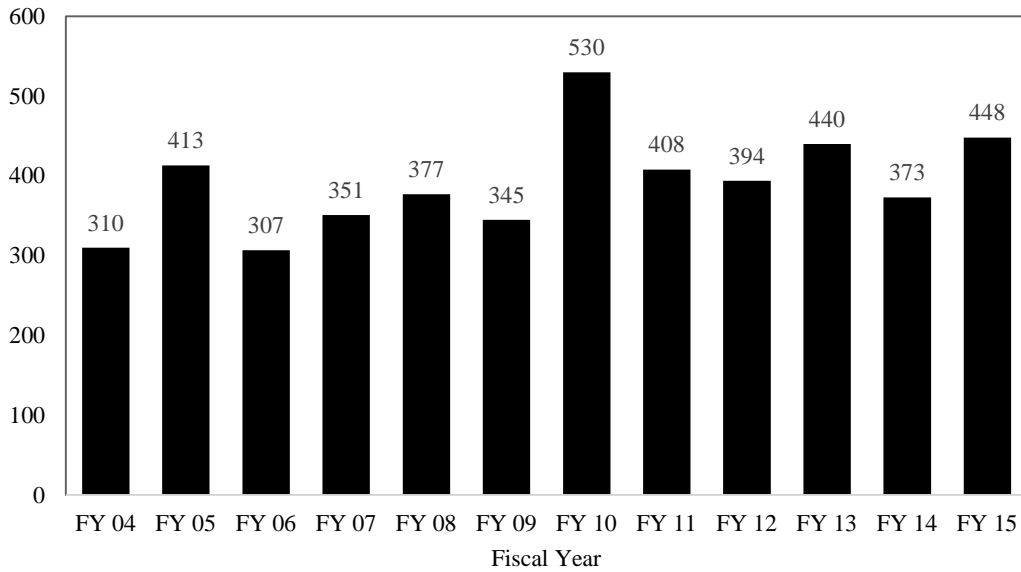
Figure 87: Number of Felony Filings, Property,

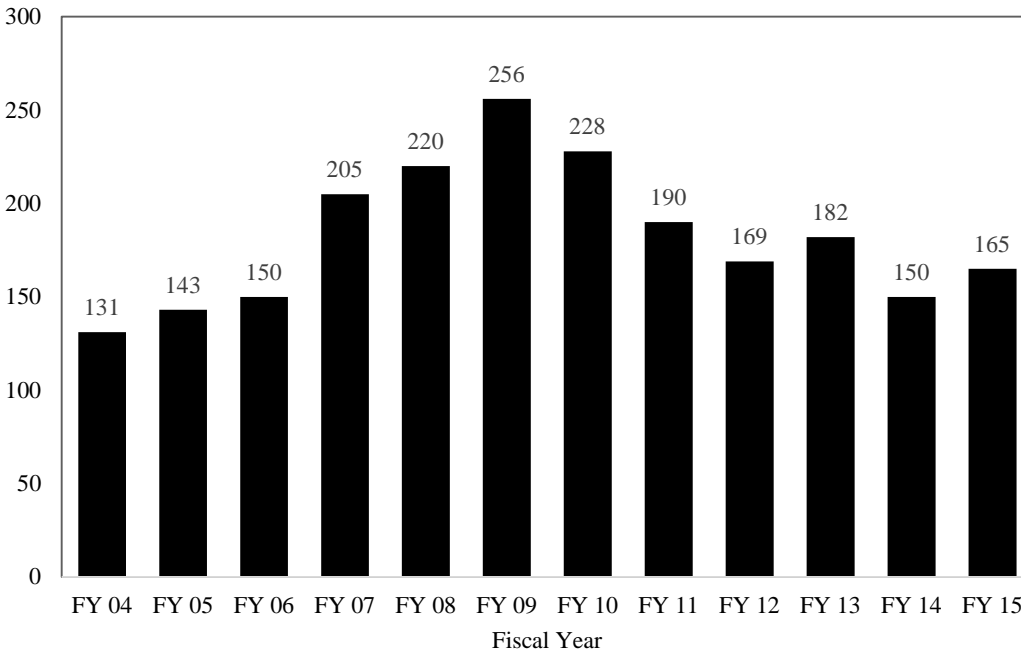
Figure 88: Number of Felony Filings, Drugs,

Table 18 and Figures 90-94 shows the rates of felony case filings for Anchorage overall and by case type for FY04 to FY15. Rates were calculated per 100,000 persons using population estimates for adults aged 18 and older. Table 19 shows the percentage change in filing rates for 2, 5, 10, and 12 years.

- There was an increasing trend for overall felony filing rates in Anchorage between FY04 and FY15. The percentage change in felony filing rates between FY04 and FY15 was 35.6%. The highest rate of overall felony case filings during the time period occurred in FY08 (1,482.3 per 100,000) and the lowest occurred in FY04 (894.8 per 100,000).
- There was a slightly decreasing trend for person felony filings rates in Anchorage during the time period. However, there was a percentage increase of 15.7% between FY04 and FY15. The highest rate of person felony filings occurred in FY06 (429.0 per 100,000) and lowest occurred in FY04 (307.5 per 100,000).
- There was an increasing trend for property felony filing rates in Anchorage between FY04 and FY15. The percentage change between FY04 and FY15 was 13.6%. The highest rate of property felony filings occurred in FY07 (525.6 per 100,000) and the lowest occurred in FY04 (286.9 per 100,000).
- There was an increasing trend for drug felony filing rates in Anchorage between FY04 and FY15. The percentage change between FY04 and FY15 was 28.5%. The highest rate of drug felony filings occurred in FY10 (245.3 per 100,000) and the lowest occurred in FY06 (150.2 per 100,000).
- There was a decreasing trend for motor vehicle felony filing rates in Anchorage between FY04 and FY15. However, there was a percentage increase of 12.0% between FY04 and FY15. The highest rate of motor vehicle felony filings occurred in FY09 (120.2 per 100,000) and the lowest occurred in FY04 (65.6 per 100,000).

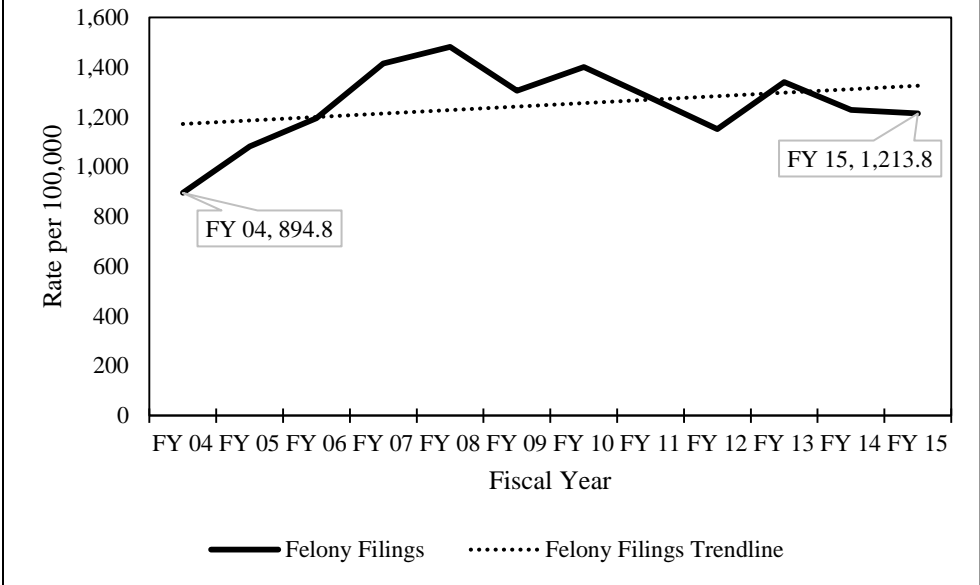

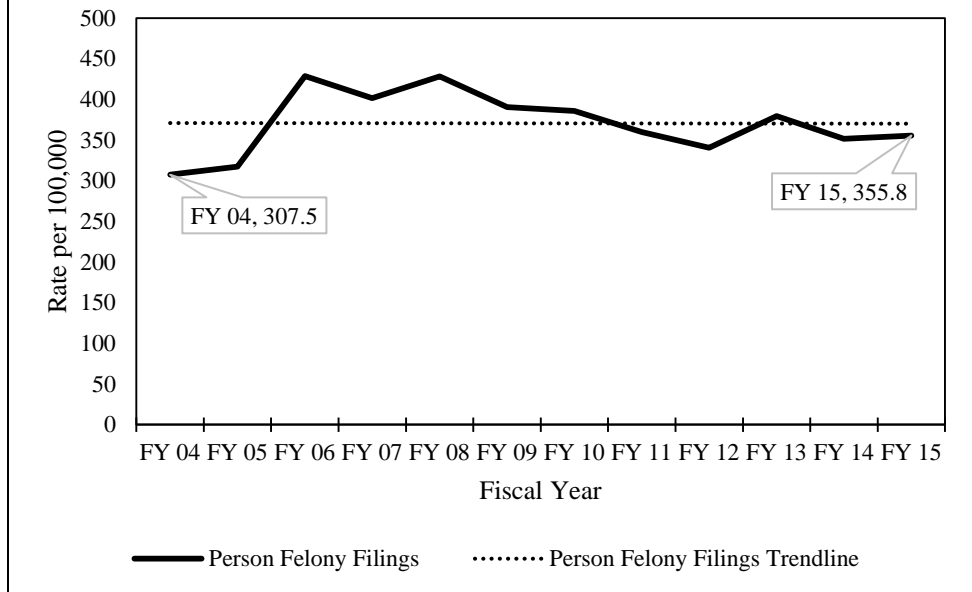

Figure 90: Felony Filing Rates, Anchorage, FY04-FY15



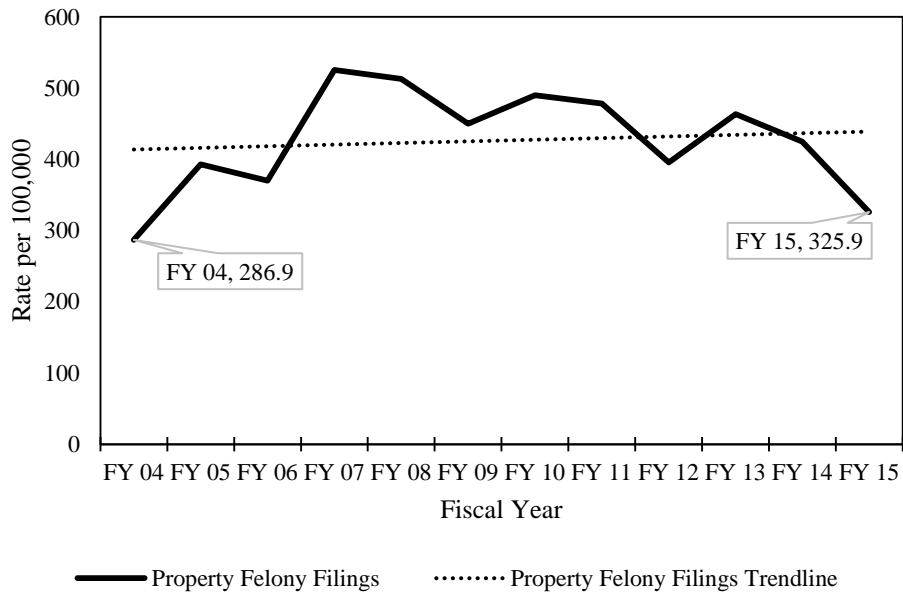

Figure 91: Person Felony Filing Rates, Anchorage, FY04-FY15



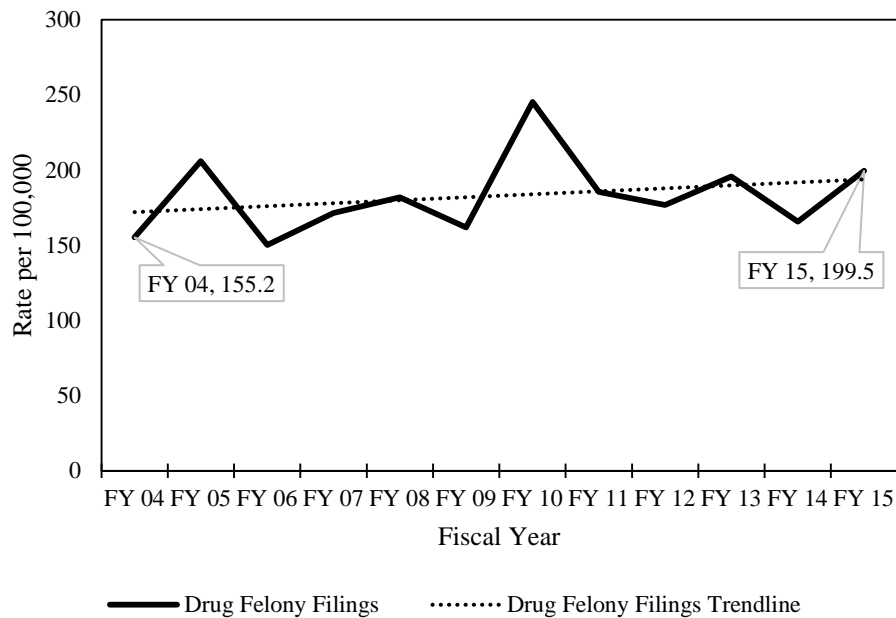

FY04-FY15



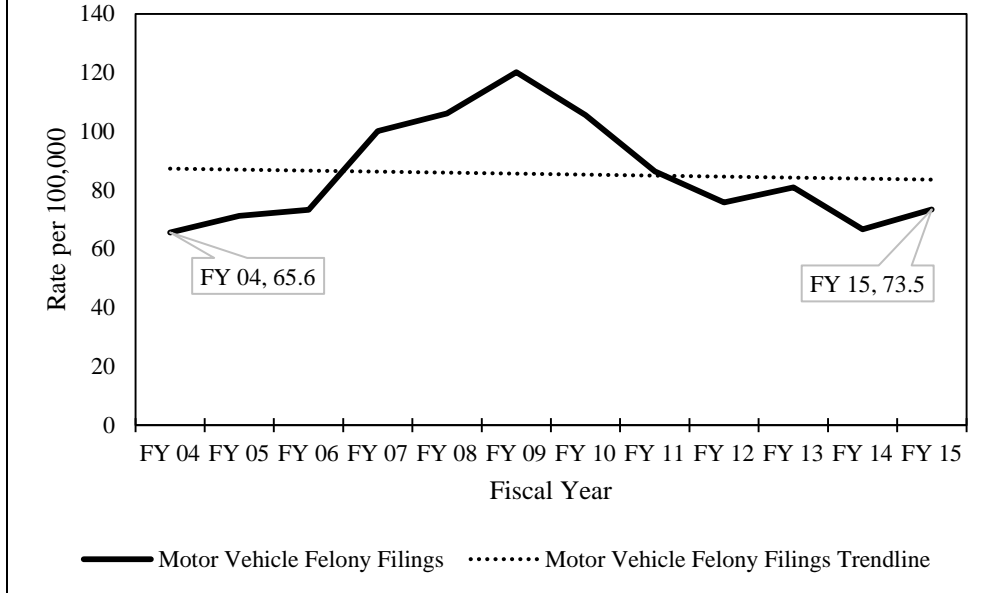

B. Misdemeanor Case Filings

Tables 20-23 and Figures 95-98 show the number and rates of misdemeanor filings for Alaska and Anchorage between FY04 and FY15. Rates were calculated per 100,000 persons using population estimates for adults aged 18 and older. In FY07, the Alaska Court System (2015) changed the way it categorized criminal cases for annual reporting. The categories conform to the National Center for State Courts' national model for caseload statistical reporting and are intended to make the statistics easier to compile, understand, and compare to other locations. Since criminal cases typically contain multiple charges, the Alaska Court System categorizes cases for reporting purposes based on the most serious charge, which is the same categories as the felony case types, therefore the misdemeanor cases filings will only be reported on an overall basis.

1. Misdemeanor Case Filings for Alaska

Table 20 and Figures 95-96 show the number and rates of misdemeanor case filings for Alaska between FY04 and FY15. Table 21 shows the percentage change in the rates of misdemeanor filings for 2 years, 5 years, 10 years, and 12 years.

- There was a decreasing trend for overall misdemeanor filing rates in Alaska between FY04 and FY15. The percentage change between FY04 and FY15 was -30.6%. The highest rate of misdemeanor filings in Alaska during the time period occurred in FY04 (6,798.5 per 100,000) and the lowest occurred in FY15 (4,715.3 per 100,000).

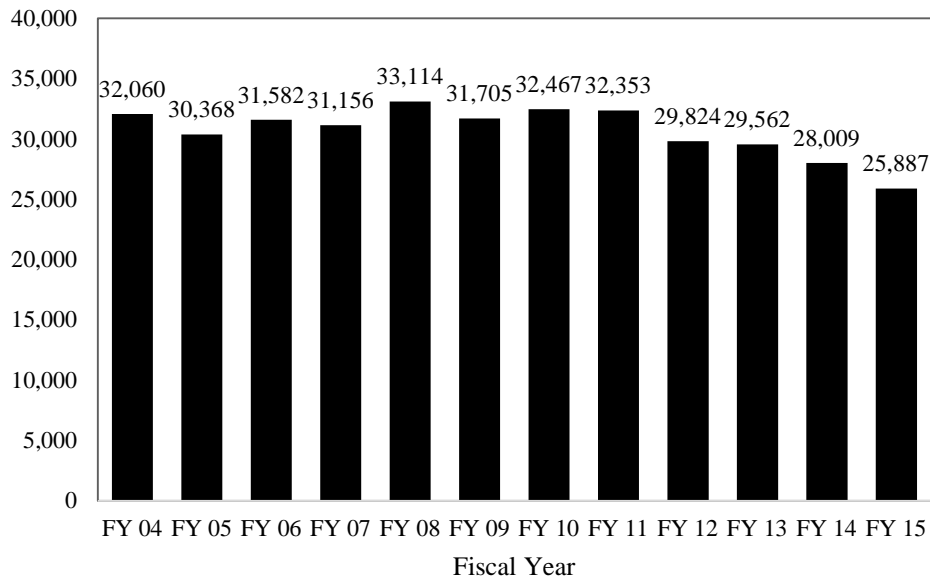

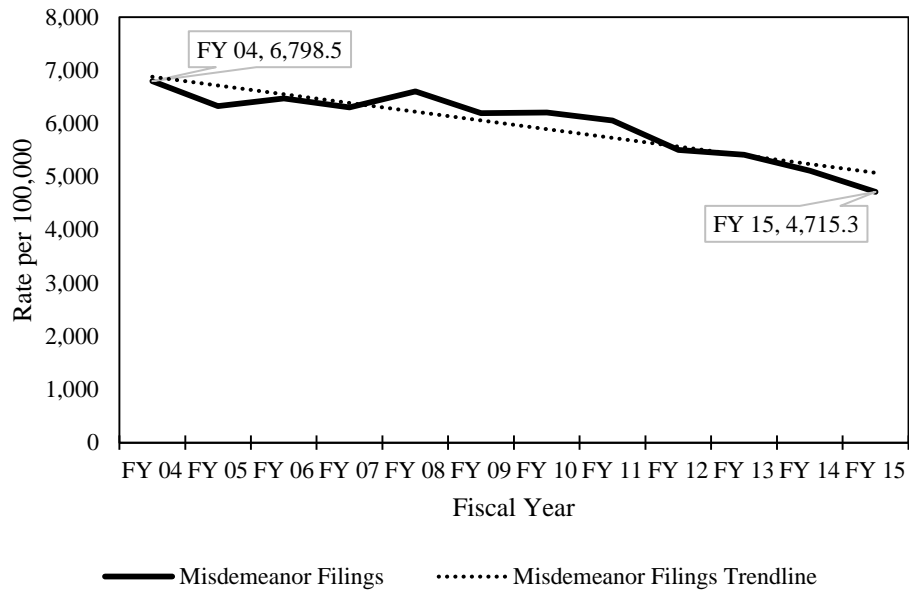

2. Misdemeanor Case Filings for Anchorage

Table 22 and Figures 97-98 show the number of misdemeanor case filings for Anchorage between FY04 and FY15. Table 23 shows the percentage change in the rates of misdemeanor filings for 2 years, 5 years, 10 years, and 12 years.

- There was a decreasing trend for overall misdemeanor filing rates in Anchorage between FY04 and FY15. The percentage change between FY04 and FY15 was -28.7%. The highest rate of misdemeanor filings in Anchorage during the time period occurred in FY09 (5,785.1 per 100,000) and the lowest occurred in FY15 (4,080.3 per 100,000).

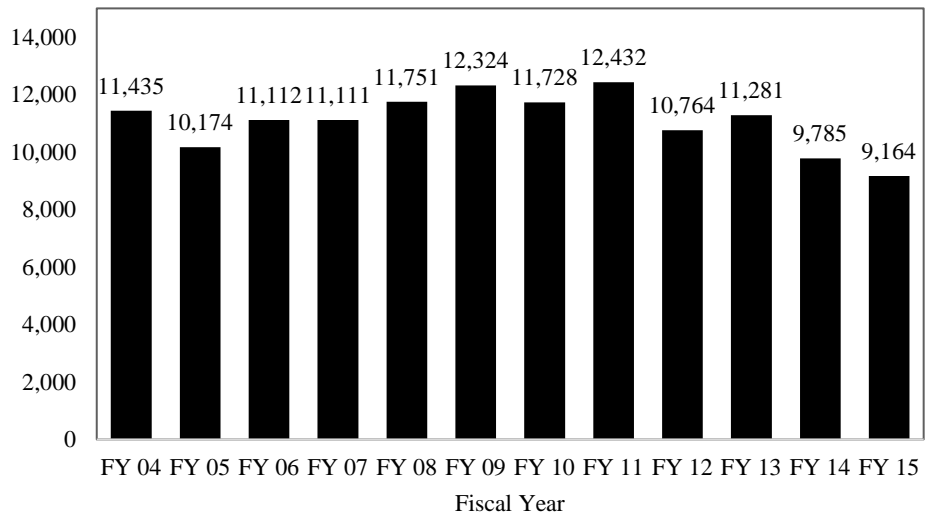

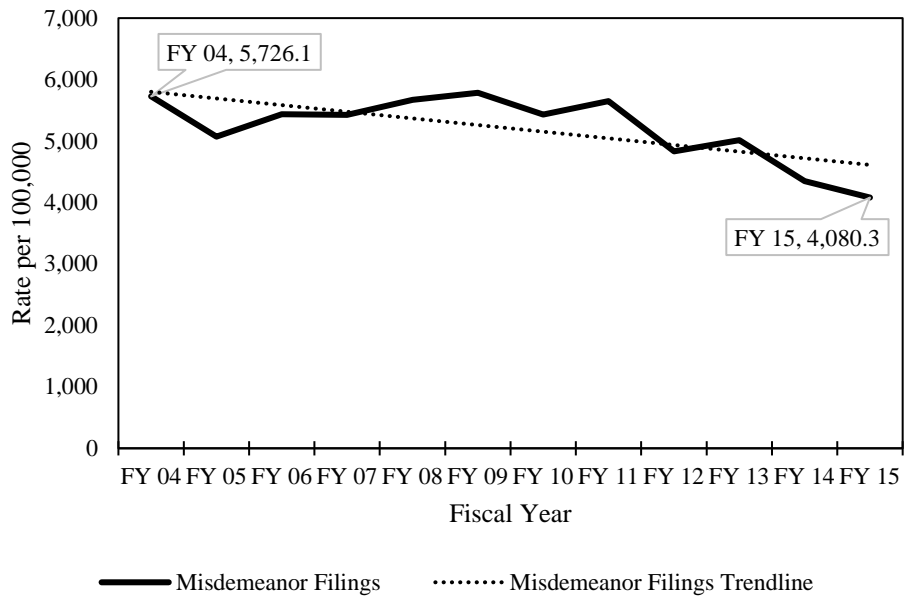
