Since the early 1990s I have been extensively involved in bringing golf to Juneau, including Juneau's youth. I joined the Juneau Golf Club around 1989. The JGC was a non-profit organization with approximately 300 members at that time who lived both in and out of Alaska. I served on the JGC Board of Directors between approximately 1990 and 1997. While the Board did not have any standing committees, I did serve on the ad hoc Rules Committee, Finance Committee, Junior Golf Committee and Roadway Committee. I was also appointed as JGC's representative to deal with issues related to pull-tab proceeds which were the main source of revenue for the organization. The Juneau Golf club donated its net profits to the City and Borough of Juneau. Those monies were retained in a special city fund with a primarily purpose to develop a golf course and secondarily to promote outdoor recreational and sporting activities in Juneau. As best I recall, the dedicated fund reached almost \$250,000 at one point. In 1996-1997 I became a board member of Totem Creek Inc. TCI was formed to actually prepare a site for golf course development. A section of city land on North Douglas Island was located, and Federal, State and local permitting undertaken to make way for a championship 18-hole golf course designed by architect Bill Robinson. Several years, over \$300,000 and thousands of hours of volunteered time were spent permitting this project. The permitting difficulties became a poster child for then Senator Murkowski's campaign for governor. The TCI board members have each conservatively invested hundreds, if not thousands of hours of their time bringing this project to permit. TCI has since entered into a lease with the City for the property, and has signed a letter of intent with a developer in anticipation of developing the project. The board has no interest in the outcome of the project other than their love of golf and their intent to make Juneau a more liveable city.

McCutcheon v. George, Case No. 3AN-85-11310 Civ. I was appointed to represent defendant McCutcheon on felony assault charges. He discharged a weapon and the bullet came to rest under a baby's crib in the trailer next to the one in which he rented a room. I convinced the DA to offer a deferred prosecution for one year on condition McCutcheon leave his weapons with the police during that one year period and violate no laws. Pat Gullufsen was then DA here when the offer was made. McCutcheon thought I was selling him out, fired me, and eventually retained, or had Joe Josephsen appointed. In the meantime months went by, and the trailer owners who were present when the shooting occurred, moved back east somewhere and declined to come back for McCutcheon's delayed trial. The new DA dismissed the charges due to unavailability of their witness. McCutcheon sued me, he also sued the State and then acting DA Svobodny. As I recall, he sued me alleging ineffective assistance. He also sued the State and the DA alleging his case was unethically dismissed and that the affidavit accompanying the dismissal notice slandered him. I turned the case over to my E&O carrier and as I recall the case was dismissed on summary judgment. The suit against the State was also dismissed, and was the subject of an appeal. See, McCutcheon v. State, 746 P.2d 461 (Alaska 1987).
