For most of my legal career I have had the privilege of serving the people of Alaska through the Department of Law. I have litigated cases in trial court, but most of my work has been appeals. I have briefed and argued cases before the Alaska Supreme Court, federal circuit courts, and the United States Supreme Court. The variety of cases I have handled closely mirrors the kinds of cases the Alaska Supreme Court regularly sees: from child-in-need-of-aid to eminent domain, separation-of-powers disputes to workers compensation, tort claims to Medicaid eligibility, and much in between.

Additional Comments (Continued)

I became the supervising attorney for the Department of Law's civil appeals section a little under two years ago. I oversee a team of eight attorneys, a paralegal, and three legal assistants. While personally handling fewer appeals, I now have a leadership role in our appellate practice. I act as a sounding board for our attorneys as they develop arguments; review briefs in our office's most significant cases; advise whether to seek interlocutory review or appeal; and act as a resource for attorneys Department-wide when considering the implications of their trial strategies on the eventual appeal. Serving in this role has not only broadened my knowledge of substantive law and appellate practice, but also sharpened my skill in working as a member of a team to promote the goals and health of a large institution.

Practicing frequently before the Alaska Supreme Court, I have seen in the Court's work its fidelity to important judicial values. Among the most important are respect for litigants, recognition of the courts' role in our system of government, independence from partisan politics, and analytical rigor. I share those values and would strive to emulate the example our justices have set. My familiarity with the Court's docket, procedures, and tradition would be a valuable source of continuity for the Court with the great turnover it will see in the coming years.

I first came to Alaska in high school and fell in love with the vast wilderness and the midnight sun. I always hoped for the chance to come back.

After graduating from the University of Michigan Law School, I moved to Fairbanks to clerk for Justice Daniel E. Winfree of the Alaska Supreme Court. Since then, I have worked at the Department of Law in Anchorage—first as a special assistant to Attorney General Daniel S. Sullivan, then as an assistant attorney general handling civil appeals, and now as the supervising attorney of the department's civil appeals section.
