Whether picking berries in the tundra, rafting rivers in Southeast or exploring glaciers in Wrangell - St. Elias, there is no better place to live, work, and practice law than Alaska.

Life before law school included managing a back country air service, leading community development programs, owning and operating a micro-business, and supporting science in Greenland, Antarctica, and Alaska.

I first practiced energy law, focusing on utility rate work on behalf of business. Next came an Alaska Superior Court clerkship, followed by civil law practice as an Assistant Attorney General. For five years, I served as an Administrative Law Judge, adjudicating and mediating a wide variety of case types. Rural Alaska called, and I moved to Bethel, then Kotzebue, as a prosecutor, holding offenders accountable and making safer communities.

It would be an honor to continue serving the people of Alaska as a judge.
