### Additional Comments (Non-Confidential)

23. Please make any additional comments that you wish to bring to the Council's attention about your experience and suitability for this judgeship.

As a Justice Department official I understand firsthand how important the public's confidence is in our judicial system. This confidence relies on professionals who put the rule of law above their personal interests and prejudices. It requires a faithful commitment to adjudicating matters based on the written law and established precedent, without imposing judicial will. As a judge I would approach the work with the same integrity, work ethic, and professionalism that I have demonstrated throughout my career.

I currently work at the United States Attorney's Office focusing on national security. In 2023 I worked for three months at a DoD facility in Jordan where I advised on the collection and use of battlefield evidence in criminal prosecutions around the world. I worked with U.S. equities and foreign nations with the mission of disrupting and dismantling ISIS through criminal prosecutions. I learned about justice systems around the world, and what makes ours special. I have also worked in Central America and Mexico and seen firsthand the respect that our foreign law enforcement partners have for our system. However, I also understand that this respect is only possible because of dedicated professionals who demonstrate the highest levels of competency and professionalism.

Neither of my parents attended college. My father was a small business owner, with intermittent success. I began helping with the business in sixth grade. When I was 15 years old my father was indicted for felony charges related to his business. He was held in custody for several weeks before we scraped together bail money. I never knew the details of the charges, and the case was later dropped. However, the damage was done as it drained the little money the family had and ruined his reputation. Financial struggles were constant; power being shut off, house foreclosed on, evicted from rentals, and eventually requiring food stamps. Most of the money I earned while working high school jobs went towards the family bills. My father later took a sales job and my mom worked nights as a proof reader.

## Additional Comments (Continued)

After high school I worked numerous jobs to make ends meet including selling women's shoes at Macy's, delivering furniture, working as a bouncer, and a high school security guard. At 23 I was admitted to Arizona State University determined to attend law school. I turned my work ethic towards my undergraduate degree and preparing for law school. *William Taylor v. Michael Pompeo, Secretary of State, et al.*, 19-CV-2987 (D.D.C.)

In 2018 I applied for, and was selected, for an internal DOJ detail to work at the United States Embassy in Kabul, Afghanistan for a one-year term. The position was both a capacity building program as well as operational assisting in counterterrorism and counter-narcotics operations. During the predeployment process I received a Class 1 Worldwide Medical Clearance from the Department of State. However, shortly before I was to deploy the Department of Defense stepped in to block my travel because I have Type 1 (juvenile) diabetes. The decision was based on a misreading of their own policy, violation of federal law, and an antiquated understanding of Type 1 diabetics. I exhausted administrative remedies with the Departments of Justice, State, Defense, and Air Force. I filed discrimination lawsuit (Rehabilitation Act violation) in federal court in Washington D.C. against the three department heads and the secretary of the Air Force.

I worked closely with the American Diabetes Association's Legal Office leading up to the litigation. The government moved to dismiss the case or alternatively for summary judgment. I prevailed against those motions in a very favorable order. The agencies then entered into settlement negotiations and after several months an agreement was reached. In addition to compensatory damages, I would be put to the top of the list for the next Rule of Law detail position in Afghanistan or Iraq. The settlement was finalized just a few weeks before Afghanistan fell, and funding for the Iraq program was cut, so I was never able to fulfill the opportunity.

This litigation was important not just to me personally, but to others with my condition as well. I knew I could fulfill the detail without any burden on DoD, much less an undue burden. I later worked at a classified DoD facility in a war zone for 3 months with no medical issues.

My 39-year-old cousin is developmentally disabled. He was adopted by my grandmother when he was 2-years old and he lived with her in Sacramento, California until my grandmother passed away from COVID complications in August 2022. My sister and I took over care for him, moving him to Arizona where my sister lives and there are more services for his conditions. This court case we were legally appointed co-guardians of him. I visit him in Arizona 4-5 times a year and my sister and I manage his medical needs, state benefits, and overall enjoyment in life.

*William A. Taylor et al., v. Admirals Cove Apartments LLC.*, 3AN-12-1856-SC (Alaska Dist. Ct.)

On Christmas Day 2011, my wife and I were woken by a carbon monoxide alarm and were both feeling ill. We immediately left the apartment, and the fire department arrived and provided treatment. I was later treated at the hospital for carbon monoxide poisoning. AFD advised the levels of carbon monoxide were too high to return to the apartment. The city later went out and tested the apartment and advised the levels were unsafe. There was a design flaw where during certain winds the exhaust from the underground garage would be pushed into our air intake for the apartment. The apartment would not agree to pay any of the hotel, moving, or medical expenses. We brought a claim in small claims court, and they eventually agreed to pay the expenses of about \$5,500.00.
