32. Please make any additional comments that you wish to bring to the Council's attention regarding your experience and suitability for this judgeship.

After nine years on the bench, I continue to enjoy the challenge and responsibility of being a decision-maker, and of managing a busy courtroom and court calendar.

In addition to my service as a district court judge, I have had extensive service as a superior court judge on felony matters, domestic relations cases, childrens' proceedings, and administrative appeals. I have been responsible for numerous travel calendars in Unalaska, Dillingham, Naknek, McGrath, Whittier, Kenai, and Homer, and for each calendar I have served as a pro tem superior court judge for all cases appearing on the docket. From 1990 to 1994 I also served as Deputy Presiding Judge of the Anchorage District Court, which has far-and-away the highest case load of any court in Alaska.

In 1994 I was given the opportunity to serve on a full-time basis as a pro tem judge on the Alaska Court of Appeals for over six months. This in-depth involvement with the appellate process has provided me with a breadth of experience that I find to be of great value as a trial court judge.
