Alaska Judicial Council Public Votes for Judicial Vacancies, and for Judicial Retention Evaluations

Anchorage Superior Court Bethel District Court Evaluation of Judges Eligible to Stand for Retention in 2018

The Alaska Judicial Council will hold a teleconference for public voting to nominate the most qualified applicants for three Anchorage Superior Court vacancies, and for a Bethel District Court vacancy. The Council will also vote on its retention recommendations for 17 judges who will be on the ballot this November.
