Currently, I am a District Court Judge in Anchorage. I handle both criminal and civil cases. For much of my tenure on the bench, I have had a standing order to preside over Superior Court cases such as "C" felony cases, felony petitions to revoke probation and "B" felony cases on a case-by-case basis. As part of my civil caseload, I have presided over four civil jury trials. I have also conducted numerous settlement proceedings with a high rate of success. Such experience is a valuable asset for a Superior Court judge as there is a trend to mediate family law cases.

I have also presided over two therapeutic courts: CRP (mental health court) and the municipal wellness court. Both courts attempt to divert misdemeanor offenders with either mental disabilities or substance abuse issues away from jail and into appropriate community treatment in an attempt to reduce recidivism in the criminal justice system.

In January, 2011, I was appointed Deputy Presiding District Court Judge for the Third Judicial District. In that capacity, I handle administrative issues which arise for

the District Court and any other matters in other court divisions which affect District Court. I have been a member of the Boney court remodel committee in order to insure that the remodel addresses District Court needs and is functional for District Court proceedings.
