I have practiced law almost entirely since being admitted in 1975 to the Missouri Bar Association and before that, as an intern with Legal Services in Kansas City, Missouri, for two years during law school. I have represented the people of the State of Alaska as a prosecutor most of my career in Alaska.

Though some attorneys may view me exclusively as a prosecutor, for approximately a quarter of my career I have worked as an attorney in the civil sector representing indigent clients as a Legal Services attorney in Missouri and representing injured plaintiffs, school districts, insurance companies and other civil clients when I worked for a litigation firm in South Texas. I have experienced the stresses of billable hours, finding expert witnesses, keeping case costs down, preparing for depositions, formulating and executing a cost efficient and effective discovery plans and dealing with the nuances of private practice. I believe that I have the

experience both from a civil and criminal perspective to be a successful and skilled Superior Court Judge.

People may wonder why I am applying for a judgeship at the age of 62. I have changed jobs several times, but never have considered retiring from the practice of law. Ironically, the one time that I retired, I joined a very active litigation firm in South Texas and worked as hard as I did when I was a prosecutor in Alaska.
