MEMORANDUM

TO: Judicial Council Members

DATE: February 24, 2010
RE: Court Employee Survey Report

The Judicial Council began surveying court system employees in 1996. This is the eighth time the Council has asked court system staff to evaluate the performance of judges standing for retention election.

The court employee survey was mailed to all non-attorney court system employees. Of 653 surveys mailed, 284 were returned for a return rate of 43.5%. Of the 284 returned surveys, 19 had no ratings or comment on any judge and were not included in the analysis. Council staff entered data, ran descriptive statistics, and transcribed comments from the surveys. A sample survey page is included at the end of this memorandum.

Table 1 shows the basis for evaluation of each judge. In approximately 3.5% of the responses court employees did not identify the basis for their evaluation.
