## Salary Warrant Withholdings

Alaska law states: "A salary disbursement may not be issued to a [justice or judge] until the [justice or judge] has filed with the state officer designated to issue salary disbursements an affidavit that no matter referred to the [justice or judge] for opinion or decision has been uncompleted or undecided by the judge for a period of more than six months." AS 22.05.140(b) (Supreme Court); AS 22.07.090(b) (Court of Appeals); AS 22.10.190(b) (Superior Court); AS 22.15.220(b) (District Court).
