For about 30 years I have practiced state and federal law throughout much of Alaska. I have lived and worked in communities from Kotzebue to Ketchikan. My practice has been primarily criminal law both as a state prosecutor and as a defense attorney. I have defended and prosecuted persons charged with unclassified felonies (e.g., murder) to traffic violations. Every June and July for the past 15 years, I have traveled to Naknek where over the years I have represented hundreds of fishing men and women charged with commercial fishing law violations during the Bristol Bay commercial sockeye season. Before my work as a defense attorney, as a state prosecutor I prosecuted commercial fishing cases in the Bristol Bay and in S.E. Alaska.

My civil law experience is considerably less in comparison to my criminal law experience. Still, over the years I have represented clients (as counsel for plaintiffs and defendants) in serious civil/personal injury cases in Barrow, Dillingham, and Juneau. Some cases resulted in long trials; others resolved via mediation. In those civil cases, I served as counsel for individual persons and for governmental entities. All of these cases required a full knowledge and application of the civil rules.

I spent a lot of time thinking about the submission of my application, what the position would require of me, and how the people of Juneau and S.E. Alaska would be best served. While I love what I do, I am fortunate to have the opportunity at this point in my life to think about this possible change in the course of my career, and, more importantly, to consider how I could best serve if appointed to the bench.

I believe a judge must work to see that justice is served in the end, but must also work to accomplish the critical process of ensuring that all persons appearing before the court are treated with respect and dignity. This is the critical human part of the judicial process.

To insure those results, I believe I have the breath of experience as a lawyer and as an individual that would well serve the bench and the people of Juneau and S.E. Alaska.
