Approve Agenda

Approve July 30, 2025 meeting summary

Ms. Wilkerson moved to approve the May 28, 2025 meeting summary. Ms. Stanfill seconded the motion, and members approved it without objection.

Public Comment Period

Press releases

Ms. DiPietro said the question of issuing press releases to announce the publication of DAC reports arose at the July 30 meeting. Ms. Stanfill moved that the staff develop a list of press and other contacts such as UAA and executive branch agencies, and draft press releases for

review by the DAC chair and vice-chair. Members approved the motion without objection.

Review of 2025 DAC Annual Report, first draft

Chair Claman proposed that members postpone review of the executive summary until after going through the report itself.

Members reviewed the report, and suggested a variety of changes. Ms. DiPietro said that staff could make those changes, and any others that members wanted to suggest by the afternoon of Wednesday, October 1. Staff will incorporate changes received by Oct 1 into a second draft which will be distributed on October 3. The second draft will be discussed at the meeting on October 10.
